Notes to Financial Statements

Note 1: Plan Description

The following description of Dean Distributing, Inc. Profit Sharing 401(k) Plan & Trust (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Dean Distributing, Inc. (the "Company") who have completed at least 250 hours of service during the first three months of employment or 1,000 hours of service, one year of service, during a 12-month consecutive period of time, as defined by the plan document. Effective January 1, 2024, part time, seasonal, and temporary employees must complete one year of service or complete three consecutive years of service where the employee completes at least 500 hours of service to become eligible to participate in the Plan. The Plan's entry dates are January 1, April 1, July 1, and October 1 of each year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. Officers of the Company are responsible for the oversight of the Plan. The officers determine the appropriateness of the Plan's investments and monitor investment performance.

Contributions

Participants may elect to contribute to the Plan up to 90% of their eligible compensation on a pretax or Roth basis, subject to certain Internal Revenue Service ("IRS") limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan or elect an alternate rate. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions invested in a designated fund until changed by the participant. Participants who are automatically enrolled will be subject to a 1% annual increase in deferral rate each year, up to a maximum of 10%, unless a different election is made by the participant.

The Company may make discretionary matching and profit sharing contributions. Participants must be employed on the last day of the plan year and have completed at least 250 hours of service during the plan year to receive Company matching contributions. Participants must be employed on the last day of the plan year and have completed at least 1,000 hours of service during the plan year to receive Company profit sharing contributions. Catch-up contributions are eligible for the Company discretionary matching contribution. Rollover contributions are not matched. For 2024, the Company made a discretionary matching contribution equal to 20% of participants' contributions into the Plan. The Company did not make a discretionary profit sharing contribution for 2024.

Note 1: Plan Description (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's discretionary matching contributions, and allocations of (a) the Company's discretionary profit sharing contributions, and (b) plan earnings or losses. Participant accounts are reduced by withdrawals and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their voluntary contributions and rollovers, plus actual earnings or losses thereon. Vesting in the Company's discretionary matching and profit sharing contributions and related earnings or losses is based on years of continuous service. Participants vest at a rate of 20% per year beginning with the second year of service. Participant accounts become fully vested after six years of service. In the event of death or termination due to total disability while employed at the Company, participants' accounts become 100% vested. Participants are considered to have completed one year of service for purposes of vesting upon the completion of 1,000 hours of service during a plan year.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may only have one note outstanding at any given point in time. Note terms shall not exceed five years, except for notes used for the purchase of a primary residence, which may not exceed 15 years. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50% at December 31, 2024. Interest rates are set at the prime rate plus 1%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Plan benefits are available at normal retirement (age 55), disability retirement, death, or termination of employment with vested interests. Benefits are paid in a lump sum for those participants whose vested account balance does not exceed \$5,000. Participants whose vested account balance exceeds \$5,000 may elect to receive benefit payments in the form of installment payments or a lump-sum distribution. In addition, hardship withdrawals are permitted if certain criteria are met. The Plan also allows for in-service distributions of participant contributions upon attaining age 59 1/2. Participants may withdraw their rollover contributions at any time.

Note 1: Plan Description (Continued)

Forfeitures

Plan forfeitures arise as a result of participants terminating service with the Company before becoming 100% vested in the Company's discretionary matching and profit sharing contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$6,991 and \$441, respectively. Forfeitures may be used to offset Company contributions or to pay administrative expenses of the Plan. During the year ended December 31, 2024, \$1,184 was used from forfeited nonvested accounts to reduce Company contributions, and no amounts were used to pay administrative expenses.

SECURE 2.0 Act

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing laws for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028, and include required and optional elements. Principle areas of the act addressed participant saving assistance, required minimum distributions (RMD), catch-up contributions, and lost participants. There are provisions which are currently part of the plan design, including the provisions designed to assist with participant savings, automatic enrollment and automatic increases, and the RMD provisions required for 2023 which have already been adopted by the Plan. All provisions of SECURE 2.0 will be evaluated and implemented in accordance with future regulations and guidance, and the Plan will be amended as needed.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of the accompanying financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Note 2: Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses and Investment Management Fees

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment management fees paid directly by the Plan are allocated proportionately to plan participants based on their respective account balances and are included in net investment income on the accompanying statement of changes in net assets available for benefits. Fees related to distributions and the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. All other expenses paid directly by the Plan are allocated proportionately to plan participants based on their respective balances and are included in administrative expenses.

Subsequent Events

Subsequent events have been evaluated through August 27, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would be used only if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust fund: Valued at the NAV provided by the administrator of the fund using NAV as a practical expedient to estimate fair value. This practical expedient would not be used if it were determined to be probable that the fund would sell the underlying investments for an amount different than the reported NAV. This fund is a stable fund, and its NAV is based on the underlying investments held by the fund less its liabilities. Participant transactions (purchases and sales) may occur daily, and there are no restrictions as to the redemption of this fund or unfunded commitments at December 31, 2024 and 2023.

Note 4: Information Prepared and Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company ("Reliance"), the trustee of the Plan.

Note 5: Party-in-Interest Transactions

ADP, LLC ("ADP") is the recordkeeper as defined by the plan document and, therefore, transactions with ADP qualify as party-in-interest transactions. Fees paid by the Plan to ADP for recordkeeping services were \$13,271 during 2024. Commonwealth Equity Services, Inc. ("CommonWealth") is the investment advisor of the the Plan and, therefore, fees paid to Commonwealth qualify as party-in-interest transactions. Fees paid by the Plan to Commonwealth for investment management fees were \$33,009 during 2024.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the plan document to discontinue its contributions and terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their Company discretionary matching and profit sharing contributions.

Note 7: Tax Status

The Company has adopted a non-standardized pre-approved plan document with an IRS notification letter dated October 6, 2020, which states the non-standardized pre-approved plan document as then designed, was in compliance with the applicable sections of the Internal Revenue Code ("IRC"). Although the plan document has been amended since receipt of the notification letter, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
