We have performed audits of the financial statements of International Shoppes, Inc. 401(k) Profit Sharing Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024 and the related notes to the financial statements

**Note 1. Description of Plan**

The following description of the International Shoppes, Inc. 401(k) Profit-Sharing Plan (Plan) provides only general information. Participants should refer to the Plan Documents for a more complete description of the Plan's provisions.

**General**

The Plan, established on January 1, 1987, amended and restated in April 2022, is a defined-contribution 401(k) plan covering all eligible employees who are over the age of 21 and have completed 1,000 hours or 12 months of service, as defined, of International Shoppes, Inc., International Shoppes, LLC, International Shoppes Shekinah Group IAH, LLC, and Diplomatic Duty Free Shoppes of New York, Inc., which are all affiliated companies (Company). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). The board of trustees is responsible for oversight of the Plan. Plan management determines the appropriateness of the Plan's investment offerings and monitors investment performance.

**Contributions**

Each year, participants may contribute up to 90% of their annual compensation not to exceed \$23,000 for 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions as permitted under the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified plans (rollover). The Company matches participant contributions up to a maximum of 3% of their compensation, as defined, provided that the participant is employed by the Company at the end of the plan year, as defined. The Company may also make discretionary contributions. The Company makes matching contributions once a year. Forfeited balances of unvested participant accounts are used to reduce future contributions from the Company. Participants direct the investments in their account into various investment options offered by the Plan.

**Participant Accounts**

Each participant's account is credited with (i) the participant's contributions, (ii) the Company's matching contribution, (iii) their share of the Company's additional discretionary contributions, if any, (iv) net earnings (loss) on their account, and (v) charged with an allocation of administrative/investment expenses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company's matching and discretionary contributions, plus actual earnings thereon, shall be 20% after two years of service with an additional 20% vesting for each additional year of service thereafter, up to a maximum vesting in accrued benefit of 100%. Upon reaching normal retirement, disability or death, a participant's account also becomes fully vested.

**Investment Options**

All investments are participant directed to various mutual funds or into self-managed brokerage accounts.

***Notes Receivable from Participants***

Participants may borrow a minimum of \$1,000 and up to a maximum equal to the lesser of 50% of their vested account balance, as adjusted, or \$50,000. Loans are payable over no more than five years (except for loans to acquire a principal residence, which are repayable over no more than 30 years), are secured by the participant's account, and bear interest at rates ranging from 4.25% to 9.5% per annum. Principal and interest are paid ratably through biweekly payroll deductions.

***Payment of Benefits***

Upon normal retirement, disability, death, or separation from service, a participant may elect to receive their vested benefit in a lump-sum or installment payments, as defined. For termination of service for other reasons, a participant may receive their vested interest in his or her account as a lump sum distribution, as defined.

***Forfeited Accounts***

The Plan provides that forfeitures, the unvested portion of employer contributions for terminated participants, may serve to reduce future Company contributions. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$32,000 and \$29,250, respectively.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan were prepared on the modified cash basis of accounting, a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Under the modified cash basis of accounting used by the Plan, contributions, interest, and dividends are recognized when received rather than when they are earned and benefits and expenses are recognized when paid rather than when the obligation is incurred; however, investments are presented at fair value. Accordingly, the financial statements are not intended to be presented in conformity with accounting principles generally accepted in the United States of America.

***Use of Estimates***

The preparation of financial statements in conformity with the modified cash basis of accounting requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines plan valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest and dividend income is recorded when received. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are paid. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. No allowance for losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan Document.

***Payment of Benefits***

Benefits are recorded when paid.

***Administrative Expenses***

Substantially all expenses of the Plan are paid directly by the Plan and allocated to the participant's account. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative fees. Investment related expenses are included in net appreciation in fair value of investments.

***Subsequent Events***

Subsequent events have been evaluated through September 22, 2025, which is the date the financial statements were available to be issued.

**Note 3. Certification of Plan Trustee**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company (Reliance), a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

***Investments***

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. The Plan had no Level 3 investments at December 31, 2024 and 2023.

**Note 5. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

**Note 6. Tax Status**

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by ADP, LLC. This prototype plan document has been filed with an appropriate agency and has obtained a favorable opinion letter dated October 06, 2020, from the IRS stating that the plan constitutes a qualified plan under Section 401 of the Internal Revenue Code and that the related trust was tax exempt as of the financial statement date. The Plan has been amended since the issuance of the opinion letter.

However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related Trust was tax exempt as of the financial statement date.

Accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of both December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 7. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, or a person who owns more 50% or more of such an employer or employee association or relatives of such persons.

Certain Plan investments are shares of mutual funds managed by Reliance. Reliance is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Additionally, the Plan incurred direct fees for investment advisory fees. Fees paid by the Plan for administrative, auditing, and investment management services amounted to \$24,143 for the year ended December 31, 2024.

Additionally, indirect fees charged by the following funds at rates ranging from 0.10% to 0.25% of the average daily assets for accounts invested in Calamos Advisors LLC, and indirect fees charged by the following funds at rates ranging from 0-100 basis points for accounts invested in Allianz Global Investors Distributors, Blackrock Funds V, Columbia, Fidelity Distributors Corp., and T. Rowe Price. Also, indirect fees charged by TD Ameritrade, Inc. included approximately 2.5% per qualified trade, and mutual fund fees of 0 to 25 basis points on balances in certain mutual funds. Direct and indirect fees and commissions are included in net appreciation in fair value of investments through revenue sharing rather than direct payments.

Notes receivable from participants also qualify as party-in-interest transactions.

The Company provides certain accounting and administrative services to the Plan for which no fees are charged.

### **Note 8. Risks and Uncertainties**

The Plan invests in various investments which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
