Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Operation HOPE 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Operation HOPE 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements referred to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Operation HOPE 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Operation HOPE 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

NOTE 1: Description of the Plan

The following description of the Operation HOPE 401(k) Plan (“Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution 401(k) plan covering substantially all employees including leased employees of Operation HOPE, Inc. (the “Employer”) who are at least 21 years of age and have completed three months of service. After completing one year of service, employees become eligible for the profit sharing contributions.

The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (IRC). Additionally, the Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute up to 90% of their pretax annual compensation, as defined in the Plan. Total participant contributions are subject to annual limits under the IRC. The maximum participant deferral limit was \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. Catch-up contributions of \$7,500 and \$7,500 were available to participants who had attained age 50 or older by December 31, 2024 and 2023, respectively, and had not exceeded the contribution limit for the Plan year. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 1% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Plan includes a match provision, whereby the Employer matches 50% on the elective deferrals up to 6% of such deferrals, excluding catch up contributions.

The Employer may make annual discretionary profit sharing contributions to the Plan, which are to be allocated to participants employed on the last day of the Plan year, on the basis of their relative compensation to the total compensation of all eligible participants. The Employer did not make any discretionary profit sharing contribution to the Plan for the years ended December 31, 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant's contributions, employer contributions, and earnings or losses resulting from the participant’s investments, and is charged for specific participant transactions. Participants direct the investment of their accounts into the investment options offered by the Plan.

NOTE 1: Description of the Plan – continued

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Employer's matching contributions and discretionary profit sharing contributions is based on years of continuous service. A participant is 20% vested after one year of service and continues to vest 20% per year thereafter. Participants are fully vested after five years of service. Notwithstanding the above, if a participant (1) attains the age of 65, (2) dies or (3) terminates employment by reason of permanent disability, the Employer discretionary profit sharing contributions, and match, amounts becomes 100% vested without regard to years of service.

Benefit Payments

Distributions of a participant's account can be made upon termination of service, death, disability or retirement. Distributions are made in either a lump-sum payment or in annual installments paid over a period not to exceed the participant's estimated life expectancy at the time of distribution. If a participant's vested account is greater than \$1,000 but less than \$5,000, and the participant does not elect to have the amount rolled over into another retirement account or to receive a distribution directly, such account will be rolled over to an Individual Retirement Account. An in-service distribution can also be made to participants who have attained the age of 59 ½, upon disability or when experiencing financial hardship.

Administrative Expenses

Expenses of maintaining the Plan are paid by the Employer. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net investment gains of investments.

Notes Receivable from Participants

Participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of the participant's vested balance. One loan may be outstanding at any time for each participant. The notes are secured by the vested balance in the participant's account and bear interest at prime plus one percent. Principal and interest are paid ratably through payroll deductions or participant's own personal funds over a term not to exceed 4.5 years or extend beyond the participant's normal retirement, except notes receivable used to purchase the participant's primary residence, which generally have a repayment term of up to 10 years.

Forfeitures

Forfeitures of terminated participants' unvested Employer contributions may be used to reduce future Employer contributions or administrative expenses. Forfeitures applied to reduce Company contributions during the year ended December 31, 2024 and 2023 were \$48,987 and \$54,172, respectively. Forfeitures available at December 31, 2024 and 2023 for future use were approximately \$294 and \$635, respectively.

NOTE 2: Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting.

Use of Estimates

Management of the Plan has made certain estimates and assumptions relating to the reporting of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities to prepare the financial statements in conformity with generally accepted accounting principles. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments in mutual funds are reported at fair market value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See NOTE 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the cash basis. Dividends are recorded on the ex-dividend date. Net investment gains includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recognized when paid, generally monthly. Delinquent participant loans are recorded as distributions based upon the terms of the plans.

Benefit Payments

Benefits are recorded when paid.

Subsequent Events

Subsequent events have been evaluated through September 25, 2025, which is the date the financial statements were available to be issued.

NOTE 3: Plan Termination

Although it has not expressed any intent to do so, the Employer has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 4: Information Certified by Custodian

The trustee has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the following information certified by Reliance Trust Company as of December 31, 2024 and 2023, except for comparing such information certified by Reliance Trust Company to information included in the Plan’s financial statements and supplemental schedule of assets held for investment purposes.

NOTE 5: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefit.

NOTE 6: Fair Value Measurement

The Plan has adopted the provisions of Accounting Standards Codifications 820 (“ASC 820”), Fair Value Measurements, for financial assets and liabilities. Under ASC 820, fair value is based on the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In order to increase consistency and comparability in fair value measurements, ASC 820 establishes a fair value hierarchy that prioritizes observable and unobservable inputs used to measure fair value into three broad levels. These levels, in order of highest priority to lowest priority, are described as follows:

NOTE 6: Fair Value Measurement – continued

Level 1: Quoted prices in active markets for identical assets or liabilities.

Level 2: Unobservable prices that are based on inputs not quoted on active markets, but corroborated by market data.

Level 3: Inputs are unobservable inputs for the asset that are supported by little or no market activity and that are significant to the fair value of the underlying asset.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: Mutual funds are registered investments with various investment managers. The fair value of these investments is determined by reference to the fund's underlying assets, which are principally marketable equities and fixed income securities. Shares held in mutual funds are valued at their net asset value.

The Plan's mutual funds measured at fair value on a recurring basis in accordance with ASC 820 as of December 31, 2024 and 2023, are deemed as Level 1.

Stable value fund: The stable value fund invests in fully benefit-responsive guaranteed investment contracts (GICs), which are general obligations of the insurance companies that issue the contracts, as well as synthetic GICs and other financial instruments. The stable value fund trades daily at the net asset value (NAV) which is based on the contract value of the underlying GICs and the fair values of other investments (Level 1).

The Plan's stable value fund measured at fair value on a recurring basis in accordance with ASC 820 as of December 31, 2024 and 2023, is deemed as Level 1.

Investments are exposed to various risks, such as interest rate, currency, market, and credit risks.

NOTE 7: Income Tax Status

The Internal Revenue Service has determined, and communicated in the letter dated October 6, 2020, that the prototype non-standardized profit sharing plan, as adopted by the Employer, is acceptable under Section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. The plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The plan administrator has analyzed tax positions taken by the Plan and concluded that, as of December 31, 2024, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or that would require disclosure in the financial statements.

NOTE 7: Income Tax Status – continued

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2021.

NOTE 8: Reconciliation to Form 5500
