INDEPENDENT AUDITORS' REPORT

To the Participants and Administrator of the
Entertainment One Employee Benefits Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Entertainment One Employee Benefit Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 17, 2024 and December 31, 2023, and the related statements of changes in net assets available for benefits for the period from January 1, 2024 to December 17, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Entertainment One Employee Benefit Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan by Principal Financial Group that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements of information regarding assets so held are prepared and certified to by Principal Financial Group in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 17, 2024 and December 31, 2023, and for the period from January 1, 2024 to December 17, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section-

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a Principal Financial Group agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirement of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Entertainment One Employee Benefit Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination and Liquidation Basis of Accounting

As described in Note 1 to the financial statements, the Plan administrator elected to terminate the Plan effective January 1, 2024, and determined liquidation is imminent. As a result, the Plan changed its basis of accounting for periods subsequent to December 31, 2023 to the liquidation basis. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Entertainment One Employee Benefit Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the

plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Entertainment One Employee Benefit Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Entertainment One 401(k) Plan's ability to continue as a going concern for a reasonable period of time.



Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. DESCRIPTION OF THE PLAN

The following description of the Entertainment One (the “Company”) 401(k) Plan (the “Plan”) provides general information of the Plan. Participants should refer to the Plan agreement for a complete description of the Plan’s provisions.

Plan Termination

On December 26, 2023, the Plan administrator resolved to terminate the Plan effective January 1, 2024 (the “Termination Date”), which indicates that the Plan is not a going concern. In connection with the resolution to terminate the Plan, contributions to the plan ceased and all active and terminated participants with account balances in the Plan became 100% vested in their accounts. Participants were provided notice from the Plan administrator regarding the Plan termination that contained instructions on how to request a distribution of their account balance from the Plan. Plan participants were requested to submit a request for distribution of their benefits prior to October 20, 2024. As of December 17, 2024, all plan assets were distributed to the Plan participants in accordance with the terms of the Plan, subject to the provisions of ERISA. All of the account balances remaining in the Plan were automatically transferred to an IRA account at Prudential Bank.

General

The Plan has ten participating employers, Entertainment One Television USA Inc., Entertainment One Licensing US Inc., Entertainment One Television Copyrights Ltd., Momentum Pictures, LLC, Paperny Entertainment US Inc., Deluxe Pictures, Inc. dba Mark Gordon Company, Sierra Affinity, Sierra Pictures, LLC, and Secret Location USA Inc. The Plan is a defined contribution safe harbor, 401(k) plan covering substantially all employees of the Company and its participating employers. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The trustee of the Plan is the Principal Financial Group.

Employees may begin participating under the Plan once they have satisfied the eligibility requirements, when they (a) are age 21 or older and (b) have worked at least 1,000 hours in a specified 12-month period, and reached the “Entry Date.” The entry date will be as soon as administratively feasible after participants meet the eligibility requirements.

1. DESCRIPTION OF THE PLAN (CONTINUED)

Contributions

The Plan is funded through contributions under compensation reduction agreements. Prior to the Termination Date, Participants may contribute a pre-tax amount up to 100% of their compensation by means of payroll deductions, subject to certain limitations imposed by the Internal Revenue Code (“IRC”). For the period from January 1, 2024 to December 17, 2024, the Company did not make any employer contributions to the Plan. Contributions were subject to certain statutory limitations.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and allocations of the Company’s contribution and Plan earnings and charged with an allocation of applicable administrative expenses. Allocations are based on participant earnings or account balances, as defined. Each participant self-directs their individual account in various mutual funds and trust investments. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in amounts attributable to their elective deferrals and the earnings thereon. For safe harbor employer matching contributions, participants are 100% vested after two years of service. For employer contributions other than safe harbor, the “Vested Percentage” in participants’ accounts is determined under the following schedule and is based on vesting years (or periods) of service.

The participants’ account related employer contributions, become 20% vested upon completing two years of credited service as defined, and continue to vest at the rate of 20% for each successive year of service until 100% vested after six years of service.

Notes Receivable from Participants

Participants may borrow from their fund account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The maximum number of notes that participants may have outstanding in any 12-month period is two. The notes are secured by the balance in the participant's account and bear interest at rates determined by the Administrator of the Plan upon reviewing the interest rates charged for similar types of loans by other lenders. Principal and interest are paid ratably through biweekly payroll deductions. Notes receivable from participants are reported at the unpaid principal balance plus accrued interest. Delinquent notes receivable from participants, when determined by Plan management, are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

A participant may withdraw all or part of their vested account balance upon reaching age 59^{1/2} and are entitled to the total amount in their account upon completing six years of service, or upon normal retirement.

On termination of service, a participant is entitled to the vested interest in his or her account. Participants or beneficiaries may make an election to receive the vested amount in either a lump sum or periodic installments.

Forfeited Accounts

As of December 17, 2024, forfeited non-vested accounts were \$0. These forfeited non-vested accounts are used to reduce employer contributions. Employer contributions for the period from January 1, 2024 to December 17, 2024 were not reduced from forfeited non-vested accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America. As disclosed in Note 1, the Plan was terminated effective January 1, 2024. As a result, the Plan changed its basis of accounting for year end subsequent to December 31, 2023 from the ongoing basis to the liquidation basis. Under the liquidation basis of accounting, assets were measured to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process and liabilities were measured using the accrual basis of accounting and would include any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process. At December 17, 2024 there were no additional expected costs to incur in conjunction with the liquidation process. The change in basis of accounting had no material effect on the financial statements for the period from January 1, 2024 to December 17, 2024 .

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and the accompanying notes. Although these estimates are based on management's knowledge of current events and actions it may undertake in the future, they may ultimately differ from actual results.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account.

As of December 17, 2024 and December 31, 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant's loan to be in default, the loan balance is eliminated, and the delinquent balance of the participant's note receivable is recorded as a benefit payment based on the terms of the Plan document.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value (except for the fully benefit responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses, such as the Trustee's custodial and administrative fees, are paid by the Plan. Accounting and auditing fees are paid by the Company. Administrative expenses for loans, distributions and withdrawals are paid by the participants.

3. INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

Certain information related to investments disclosed in the accompanying financial statements, including investments, at fair value and unallocated cash as reported at December 17, 2024 and December 31, 2023, and net change in fair value of investments and interest and dividends for the period from January 1, 2024 to December 17, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Financial Group (the trustee of the Plan).

5. INCOME TAX STATUS

The Internal Revenue Service ("IRS") has determined and informed the Company that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan's management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate uncertain tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken a position that more likely than not would not be sustained upon examination by the IRS: The Plan does not have any uncertain tax positions.

The Plan is subject to routine audits by various taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2020.

6. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, defines fair value as the price that would be received upon sale of an asset or paid upon transfer of a liability in an orderly transaction between market participants at the measurement date and in the principal or most advantageous market for that asset or liability. The fair value should be calculated based on assumptions that market participants would use in pricing the asset or liability, not on assumptions specific to the entity.

FASB ASC 820 specifies a hierarchy of valuation techniques based upon whether the inputs to those valuation techniques reflect assumptions other market participants would use based upon market data obtained from independent sources (observable inputs). In accordance with FASB ASC 820, the following summarizes the fair value hierarchy:

- Level 1 Inputs - Unadjusted quoted market prices for identical assets and liabilities in an active market that the Company has the ability to access.
- Level 2 Inputs - Inputs other than the quoted prices in level 1 that are observable either directly or indirectly.
- Level 3 Inputs - Inputs based on prices or valuation techniques that are both unobservable and significant to the overall fair value measurements.

FASB ASC 820 requires the use of observable market data, when available, in making fair value measurements. When inputs used to measure fair value fall within different levels of the hierarchy, the level within which the fair value measurement is categorized is based on the lowest level input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

6. FAIR VALUE MEASUREMENTS (CONTINUED)

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 17, 2024 and December 31, 2023.

Common collective trusts: Valued at net asset value per unit as reported by the respective funds. Net asset value is based on the fair value of the underlying assets of the fund derived from inputs principally from or corroborated by observable market data by correlation or other means.

Registered Investment Companies (Mutual Funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separated Accounts: A separate account in which several plans participate generally is referred to as a pooled separate account (“PSA”). A PSA is maintained by an insurance carrier, which is regulated, supervised, and subject to periodic examination by a state agency for the collective investment and reinvestment of assets contributed thereto from employee benefit plans maintained by more than one employer of a controlled group of corporations. PSAs are similar to mutual funds except that they are issued by insurance companies and are not publicly traded like mutual funds. Each plan's share of a PSA is determined on a participation-unit or variable-unit basis. The plan's equity account provides a cumulative record of the number of participation units credited to the account and the number of units allocated or withdrawn from the account. The balance of participation units credited to the account, multiplied by the current participation-unit value, equals the amount of equity account assets held on behalf of the policyholder at any given time. The participation-unit value is adjusted, usually each business day, to reflect investment results under the separate account. PSAs often have audited financial statements; however, for certain insurance companies, audited PSA financial statements are not available.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table presents the Plan's assets and liabilities and related valuation inputs within the fair value hierarchy utilized to measure fair value as of December 31, 2023. The Plan held no assets at December 17, 2024 :

7. GROUP ANNUITY CONTRACT WITH PRINCIPAL LIFE INSURANCE COMPANY

In 2013, the Plan entered into a traditional fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company (Principal) totaling for \$0 for the period from January 1, 2024 to December 17, 2024 and \$154,900 for 2023. Principal maintains the contributions under Principal Trust Company's custody. The account is credited with earning on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specific interest rate that is guaranteed to the Plan.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

8. RELATED PARTY TRANSACTIONS

The Principal Financial Group, as the trustee of the Plan, is a party-in-interest. Certain Plan investments in common/collective trusts and pooled separate accounts are managed by the Principal Financial Group. Fees paid by the Plan for the investment management services totaled \$133,006 for the period from January 1, 2024 to December 17, 2024. These party-in-interest transactions are exempt from the prohibited transaction rules under ERISA.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Such investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with such investments and the level of uncertainty related to changes in the values of such investments, it is at least reasonably possible that changes in the values of the Plan's investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
