INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the financial statements of the CAM Integrated Solutions, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the CAM Integrated Solutions, LLC 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

- The information in the accompanying 2024 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of the CAM Integrated Solutions, LLC 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion on the 2024 financial statements.

Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

1. DESCRIPTION OF THE PLAN

The following description of the CAM Integrated Solutions, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

General

The Plan was established on January 1, 2016, with its most recent amendment and restatement, effective March 21, 2024, introduced provisions permitting loan refinancing. The Plan is a defined contribution and profit-sharing plan that generally covers all employees except those specifically excluded in the Plan Document of CAM Integrated Solutions, LLC and its participating employers (collectively, the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

John Hancock Life Insurance Company (U.S.A) (“Custodian”) is the custodian of the Plan.

Participant and Employer Contributions

The Plan provides for voluntary pre-tax and after-tax participant contributions expressed as a percentage of the participant’s eligible compensation, as defined, up to the maximum amounts set by the Internal Revenue Code (“IRC”), which limits the annual amount of salary deferrals that may be made by any participant. Participants also may contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Eligible participants may also make catch-up contributions upon attaining 50 years of age, as defined by the IRC. The employer matching contribution was reinstated effective August 12, 2022, at which time the Company began making matching employer contributions of 2% of eligible compensation. The employer matching contribution was increased from 2% to 3% of eligible compensation effective April 7, 2023, and then to 4% of eligible compensation effective July 28, 2023.

Effective January 1, 2024, the Company adopted the safe harbor provisions of the IRC. The Company will make a safe harbor matching contribution equal to 100% of the participant’s salary deferrals that do not exceed 3% of the participant’s compensation plus 50% of the participant’s salary deferrals between 3% and 5% of the participant’s compensation. The Company may also make discretionary contributions determined annually. There were no discretionary profit-sharing contributions made for 2024.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, rollover contributions, the Company’s matching and discretionary contributions, if any, and an allocation of Plan earnings. The account is charged for participant withdrawals, an allocation of Plan losses, and administrative expenses. Allocations are based on participant compensation and account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

Investment Options

Plan participants can direct the investment of their contributions into any or all the investment options available under the Plan. Participants can change their investment allocation among the various investment options either through direct transfer from one option to another or by changing the participant allocation of future contributions.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 and a maximum equal to the lesser of \$50,000 reduced by the highest outstanding note receivable balance in the participant’s account during the prior 12-month period or 50% of the participant’s vested account balances.

Additionally, a participant may not have more than one note receivable outstanding at any time. Each note receivable under the Plan must mature within five years from the date on which it was made unless the note receivable is used to acquire a principal residence, in which case the note receivable may permit a longer repayment term. The notes receivable are secured by the vested balance in the participant's account and bear a reasonable rate of interest.

Participant Withdrawals

Participants are eligible for distributions of their vested account balances upon the event of death, disability, hardship, retirement, reaching age 59½, or termination of employment.

Upon severance of employment, distributions may be made in a lump-sum payment. If the vested account balance exceeds \$5,000, participants must consent how to receive their distribution. If the vested account balance is less than \$1,000, the payment will be made in cash in a single lump-sum without the participant's consent. If the participant's vested account balance is between \$1,000 and \$5,000 and the participant does not affirmatively consent to receive a distribution, the balance will be rolled into an individual retirement account established on behalf of the participant. Any taxable distribution paid by the Custodian directly to the participant will be subject to mandatory federal income tax withholding of 20% of the requested distribution.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. A participant is vested in the Company's matching and discretionary contributions and related earnings as follows:

Forfeitures

If a participant terminated employment before having a fully vested interest in his or her account, the non-vested balance of the account will be forfeited. Forfeitures are used to pay administrative expenses of the Plan and may also be used to reduce future employer contributions. The unused forfeitures balance as of December 31, 2024 and 2023, was \$7,190 and \$18,299, respectively. During 2024, employer contributions were reduced by \$25,044 from forfeited non-vested accounts.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Investment Valuation and Income Recognition

The Plan's investments in pooled separate accounts are stated at fair value based on quoted market prices as of year-end, which represents the net asset value ("NAV") of shares held by the Plan. See Note 3 regarding fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Unrealized appreciation in the fair value of investments held at year-end is determined using the fair value at the beginning of the year or the purchase price if the investment is acquired during the year.

The realized gain or loss on the sale of investments is determined using historical cost. Upon the sale of an investment, the current year unrealized appreciation or depreciation is adjusted for unrealized gains and losses recognized in prior years. Unrealized appreciation or depreciation and realized gains and losses are reported as net appreciation or depreciation in fair value of investments in the statement of changes in net assets available for benefits.

Plan Expenses

All administrative expenses, unless paid by the Company, are paid by the Plan.

Participant Withdrawals

Participant withdrawals are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from these estimates.

Subsequent Events

The Plan has evaluated subsequent events through September 19, 2025, the date the financial statements were available to be issued.

3. FAIR VALUE MEASUREMENTS

The Plan uses a hierarchy for grouping assets and liabilities, based on the significance of inputs. The hierarchy of fair value measurements is described below:

Level 1 – quoted prices in active markets for identical assets or liabilities;

Level 2 – inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of these assets or liabilities; or

Level 3 – unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Pooled separate accounts – Valued daily at the NAV per share, as a practical expedient, held by the Plan based on the quoted market value of the underlying assets. This investment is not leveled within the fair value hierarchy.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the valuation methods are considered appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. INCOME TAX STATUS

The volume submitter plan adopted by the Company received its latest opinion letter dated March 31, 2014, in which the Internal Revenue Service (the "IRS") stated that the Plan, as then designed, was in compliance with applicable requirements of the IRC. The Plan has been amended since receiving the opinion letter; however, the Company believes that the Plan is currently designed and being operated within the applicable requirements of the IRC. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires the Company to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Company has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

5. CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of December 31, 2024 and 2023, and interest on notes receivable from participants and net appreciation in fair value of investments for the year ended December 31, 2024, was obtained by the Company and agreed to or derived from information certified as complete and accurate by the Custodian.

6. PARTY-IN-INTEREST TRANSACTIONS

The Plan's investments were managed by the Custodian; therefore, these transactions qualify as party-in-interest transactions. Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party-in-interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

7. PLAN TERMINATION

Although the Company intends to maintain the Plan indefinitely, the Company reserves the right to terminate the Plan at any time. Upon termination, no further contributions will be made to the Plan and all amounts credited to participants' accounts will become 100% vested. The Company will direct the distribution of participants' accounts in a manner permitted by the Plan as soon as practicable.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.
