**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the M. Argueso & Co., Inc. 401(k) Plan & Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General: The Plan is a defined contribution plan, which covers substantially all of the employees of M. Argueso & Co., Inc. (the “Company”). The Plan is subject to the provisions of the Internal Revenue Code and the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Effective May 1, 2023, the Plan changed its trustee and recordkeeper from Reliance Trust Company (former Trustee) and ADP, LLC (former recordkeeper) to Empower Trust Company, LLC. The change had no impact on plan provisions in place as of December 31, 2024 and 2023.

Eligibility: Employees attaining the age of 18 and have three months of service may become participants in the Plan and are eligible for employer matching contributions after six months of service. Employees are automatically enrolled at a 3% deferral rate upon becoming eligible to participate in the Plan and they may elect to change or discontinue deferrals at any time.

Contributions: Employees participating in the Plan can make 401(k) contributions pursuant to a salary reduction agreement up to maximum limits allowed by the Internal Revenue Code. Also, participants over the age of 50 by the end of the Plan year are eligible to make catch-up contributions in accordance with Code Section 414(v). The Company has elected to contribute an amount equal to 100% of participants’ elective deferrals not to exceed 5% of employees’ total compensation. The Company may also make additional discretionary contributions. There were no additional Company discretionary contributions to the Plan in 2024.

Unless a participant who is enrolled in the Plan affirmatively elects otherwise, the participant’s elective deferral percentage will increase by 1% each year on March 1st until the percentage reached 15% of compensation.

Participant Accounts: Each participant’s account is credited with the participant’s contribution and an allocation of (a) the Company’s contributions, and (b) Plan earnings and (c) is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, participant earnings, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Retirement, Death, and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death, or disability.

Vesting: Participants are immediately vested in employee contributions to the Plan, plus actual earnings and losses thereon. In addition, participants are immediately vested in employer contributions to satisfy the safe harbor plan rules.

Payment of Benefits: A participant is eligible to receive a distribution from the Plan of his/her total vested account balance when one of the following events occurs: (1) termination of employment, (2) retirement, (3) attainment of age 59½, (4) disability, (5) death, or (6) hardship withdrawals. Additionally, on termination of service with the Company (including termination of service due to death, disability or retirement), a participant may generally elect to receive either a lump-sum amount equal to the value of the participants’ vested interest in his or her account, or annual installments over a multiple-year period.

Notes Receivable from Participants: The Plan permits loans to participants up to the lesser of \$50,000 or 50% of their vested account balance. Such loans must be repaid weekly over a period not to exceed five years, unless such loan is used to acquire a dwelling, which will be used as the principal residence of the participant within a reasonable time (determined at the time the loan is made). Interest rates on participant loans will be the prime rate plus one percent.

Forfeitures: The portion of a participant's account balance which is not fully vested will be forfeited if the participant separates from service. These forfeited amounts will be used to pay plan administrative expenses or reduce future employer contributions to the Plan.

Plan Termination: Although it has not expressed any intent to do so, the Company has the right under the Plan agreement to discontinue contributions at any time and to terminate the Plan subject to provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions and earnings thereon.

Investment Options: Participants may change the allocation of their existing account balances and future contributions on a daily basis. Participants can choose from a series of investments selected by the Company.

Administrative and Investment Management Expenses: Loan origination fees associated with notes receivable from participants and the Plan's recordkeeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income (loss) reported by the Plan. Professional fees for the annual audit of the Plan were paid by the Company.

**NOTE 2 - SUMMARY OF ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments other than fully benefit responsive investment contracts are reported at fair value as further described in Note 4. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Contract value is the relevant measure for the Plan's fully benefit-responsive investment contract, because contract value is the amount Plan participants generally receive when executing transactions under the terms of the contract and plan provisions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**NOTE 2 - SUMMARY OF ACCOUNTING POLICIES (Continued)**

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions, and the notes are collateralized by the participants' account balances.

Payment of Benefits: Benefits are recorded when paid.

Administrative Expenses: Most administrative expenses of the Plan are paid by the Company. Loan fees and other expenses of \$33,104 were charged to participant accounts for the year ended December 31, 2024.

Risks and Uncertainties: The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 3 - CERTIFIED INFORMATION - INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company of America the trustees of the Plan.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (level 1 measurements) and gives the lowest priority to unobservable inputs (level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

**NOTE 4 - FAIR VALUE MEASUREMENTS** (Continued)

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

*Mutual Funds:* The fair values of mutual fund investments, including money market mutual funds, are determined by obtaining quoted prices on nationally recognized securities exchanges (level 1 inputs).

*Collective Trust:* The fair values of participation units in the collective trust are based upon the net asset values per unit as reported by the fund manager. The collective trust provides for daily redemptions by the Plan at reported net asset value per share, with no advance notification requirements. The fund invests in investment contracts issued by life insurance companies, banks and other financial institutions with the objective of preserving principal investment while earning a level of interest income that is consistent with the principal preservation.

*Collective Trust Stable Value Fund:* The fair values of interest in stable value funds are based upon the net asset values of such funds, as reported in the most recent audited financial statements of the fund. The primary investment objective of the fund is to seek the preservation of principal and to provide interest income reasonably obtained under prevailing market conditions and rates, consistent with seeking to maintain required liquidity. The Fund's returns are based on returns generated by an actively managed, highly diversified portfolio of investment grade, fixed and floating rate securities. The fund provides for daily redemptions by the Plan at reported net asset value per share, with no advance notification requirements.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT**

The Plan holds a fully benefit-responsive investment contract that is reported at contract value, which is generally the amount a participant would receive if he or she would initiate a withdrawal or transfer from the contract under the provisions of the Plan. Contract value represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses. The contract value of the Plan's fully benefit-responsive investment contract, by general type, are presented below:

Traditional Guaranteed Investment Contract: The Plan holds a fully benefit-responsive investment contract with Empower Annuity Insurance Company of America ("Empower"; Issuer). Empower maintains the contributions in its general account. The Issuer guarantees the Plan a return of principal and interest under the terms of the contract. The interest crediting rate is updated quarterly based upon contract provisions. Empower's general account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

The Plan's investment contract specifies certain conditions under which distributions from the contract would be payable at amounts below contract value. Such circumstances include Plan termination, Plan merger, premature contract termination initiated by the Company, and certain other Company initiated events that result in distributions exceeding a set amount. The contract limits the circumstances under which the Issuer may terminate the contract. Examples of circumstances which would allow the Issuer to terminate the contract include the Plan's loss of its qualified status, uncured material breaches of responsibilities, or material and adverse changes to the provisions of the Plan. If one of these events were to occur, the Issuer could terminate the contract at an amount less than contract value. Currently, management believes that the occurrence of an event that would cause the Plan to transact contract distributions at less than contract value is not probable.

**NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor (“DOL”) regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Investment management fees are paid for by the Plan to investment managers who qualify as parties-in-interest, including Rockefeller Financial, LLC and Empower Trust Company, LLC. These investment management fees are reflected in the financial statements as a reduction of the return on the Plan’s investments. Transactions during the year with parties-in-interest include administrative services. The investment contract as of December 31, 2024, is issued by Empower, which qualifies as a party-in-interest investment. Notes receivable from participants also reflect party-in-interest transactions.

**NOTE 7 - TAX STATUS**

The Internal Revenue Service issued an opinion letter dated November 14, 2022 indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the Internal Revenue Service; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 8 - SUBSEQUENT EVENTS**

Plan management has performed an analysis of activities and transactions subsequent to December 31, 2024 to determine the need for any adjustment to and/or disclosures within these financial statements for the year ended December 31, 2024. Plan management has performed their analysis through September 18, 2025, which was the date that the financial statements were available to be issued and there are no subsequent events to disclose.
