Notes to Financial Statements

Note 1: Description of Plan

The following description of the Carew Concrete Supply Company, Inc. Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Carew Concrete & Supply Company, Inc. and Carew Trucking, Inc. (collectively referred to as the "Company") who have one year of service and are age 21 or older. Effective January 1, 2024, under the SECURE 2.0 Act, long-term part-time employees who have worked at least 500 hours in each of the previous three consecutive years are also eligible to participate in the Plan. Employees enter the Plan on the earlier of January 1 or July 1 after meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Management of the Company is responsible for oversight of the Plan, including the appropriateness of the Plan's investment offerings and monitoring of investment performance.

Contributions

Each year, participants may contribute to the Plan up to the maximum allowable limits of the Internal Revenue Service ("IRS") on a pre-tax or Roth basis. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled into the Plan unless they affirmatively elect not to participate in the Plan or make an alternate deferral rate election. Automatically enrolled participants have their pre-tax deferral rate set at 3% of eligible compensation and their contributions invested in a designated fund until changed by the participant. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company may make discretionary matching and discretionary nonelective contributions to the Plan. Rollover contributions are not matched. Participants must be employed on the last day of the plan year and have worked at least 1,000 hours in the plan year in order to receive the Company discretionary matching and discretionary nonelective contributions. For 2024, the Company made discretionary matching contributions of 50% of the first 6% of eligible compensation remitted to the Plan. The Company did not make any discretionary nonelective contributions during 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's discretionary matching contributions, and allocations of (a) the Company's discretionary nonelective contribution, and (b) plan earnings or losses. Participant accounts are reduced by withdrawals and charged with an allocation of expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1: Description of Plan (Continued)

Vesting

Participants are immediately vested in their voluntary deferral and rollover contributions, and Company discretionary matching contributions plus actual earnings thereon. Vesting in the Company's discretionary nonelective contribution portion of a participant's account is based on the number of years of service. Participants vest at a rate of 20% per year starting with their second year of service. Participants become fully vested after six years of service. In addition, there is full vesting upon death or disability of an employee.

Payment of Benefits

On termination of service due to death, disability, or retirement (age 65), a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or payment installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In addition, hardship distributions out of the participant's vested account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 62. Participants may withdraw their rollover contributions at any time.

Forfeitures

Forfeitures arise as a result of participants who terminate service with the Company before becoming 100% vested in the Company's discretionary nonelective contributions. Forfeited nonvested accounts totaled \$0 at December 31, 2024, and \$744 at December 31, 2023. These accounts can be used to pay administrative expenses of the Plan or to reduce Company discretionary nonelective contributions in accordance with the plan document. Forfeitures of \$747 were used during 2024 to pay administrative expenses.

SECURE ACT 2.0

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. The plan has adopted some of these provisions, and is in the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for further discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative and Investment Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment management fees paid directly by the Plan are allocated proportionately to plan participants based on their respective account balances and are reflected as investment expenses and included in net investment income. Fees related to distributions are charged directly to the participant's account and are included in administrative expenses. Certain investment-related expenses are included in net appreciation in fair value of investments, since they are paid through revenue sharing rather than direct payment. All other expenses paid directly by the Plan are allocated proportionately to plan participants based on their respective account balances and are included in administrative expenses.

Subsequent Events

Subsequent events have been evaluated through September 12, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Fixed annuity contract: The value of this general account product is derived from contract provisions and, therefore, contract value approximates fair value when using a discounted cash flow valuation methodology where the interest rate is reset quarterly. The value of the fund is determined based on contributions plus interest less withdrawals and charges. Due to provisions within the contract, immediate and full payment of the contract value is prevented. As a result, this fixed annuity contract is not considered fully-benefit responsive.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4: Information Prepared and Certified by the Trustee and Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Empower Trust Company, LLC, the Trustee of the Plan, and Empower Annuity Insurance Company of America ("Empower Annuity"), the Custodian of the Plan.

Note 5: Party-in-Interest Transactions

Empower Annuity is the Custodian of the Plan, Empower Advisory Group LLC ("Empower Advisory") and Clifton Larsen Allen ("CLA") are both investment advisors for the Plan, and MAP Retirement USA LLC ("MAP") is the Plan's recordkeeper. As a result, transactions with all these entities qualify as party-in-interest transactions. A Plan investment is managed by the Custodian. In 2024, the Plan paid \$25,816 to the Custodian and \$8,363 to MAP for administrative fees. In 2024, the Plan paid \$33,706 to CLA and \$6,271 to Empower Advisory for investment management fees.

Note 6: Tax Status

The Company adopted a non-standardized pre-approved plan document with an IRS notification letter dated June 30, 2020, which states the non-standardized pre-approved plan document, as then designed, was in compliance with the applicable sections of the Internal Revenue Code ("IRC"). Although the plan document has been amended since receipt of the notification letter, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provisions for income taxes has been included in the Plan's financial statements.

Note 7: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the plan document to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company discretionary nonelective contributions.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
