### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of Patterson & Dewar Engineers, Inc. Profit Sharing Plan & Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Their report dated August 1, 2024 indicated that in their opinion (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agrees to or is derived from certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## NOTES TO FINANCIAL STATEMENTS

### Note 1. Description of Plan

The following description of Patterson & Dewar Engineers, Inc. Profit Sharing Plan & Trust (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General:

The Plan is a defined contribution plan established on September 18, 1961 to provide retirement and other benefits for eligible employees of Patterson & Dewar Engineers, Inc. (the "Company"). The Plan covers all employees, except employees covered by collective bargaining agreements, leased employees, nonresident aliens, and Itinerant Field Representatives, who have attained age 18 and completed three months of service. Employees are permitted to enter the Plan on the first day of each month. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions:

Each year, eligible participants may elect to contribute a percentage of their annual compensation, as defined by the Plan. The Plan has an automatic enrollment feature for newly eligible participants, whereby these participants will be automatically enrolled in the Plan at a salary rate of 3% unless elected otherwise. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes safe harbor qualified nonelective contributions equal to 3% of Plan compensation for each participant who is eligible for the Plan. The Company may also match a portion of participants' contributions, as defined by the Plan. There were no discretionary matching contributions for the year ended December 31, 2024. Additionally, the Company may also make discretionary profit sharing contributions, as defined by the Plan. Profit sharing contributions for the year ended December 31, 2024 were \$5,910,294. Profit sharing contributions are allocated proportionally based on each participant's eligible salary as a percentage of total participants' eligible salaries. Employees are eligible to receive profit sharing contributions on the first day of the calendar quarter after attaining age 18 and completing one year with 1,000 hours of eligible service, as defined in the Plan document. Contributions are subject to certain limitations.

#### Participant accounts:

Each participant has an individual account that includes their contributions and allocations of the Company's contributions and Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## Note 1. Description of Plan (continued)

## Vesting:

Participants are immediately vested in their contributions and safe harbor contributions, plus actual earnings thereon. Vesting in profit sharing contributions and matching contributions, plus actual earnings thereon, is based on years of continuous service. Participants are 100% vested in profit sharing and matching contributions after six consecutive years of service.

## Forfeited accounts:

Forfeitures may be used to reduce employer contributions and to pay the Plan's administrative expenses. The amount of unallocated forfeitures as of December 31, 2024 and 2023 was \$51,792 and \$42,333, respectively. \$42,575 of forfeitures were used during the year ended December 31, 2024 to offset employer contributions.

## Notes receivable from participants:

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of (a) 50% of the participant's vested account, reduced by any outstanding note balance or (b) \$50,000, reduced by the highest outstanding note balance during the one-year period ending on the day before the note is made. The notes receivable from participants are secured by the balance in the participant's account and bear interest at rates ranging from 3.25% - 8.50%. Note terms may extend up to five years except for notes used to acquire a primary residence. Principal and interest is paid ratably through payroll deductions.

## Payment of benefits:

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum cash payment, installment payments, a direct rollover to an IRA or other qualified plan, or any combination thereof. If the participant's vested account balance does not exceed \$7,000, no consent is required to distribute the vested account balance.

Hardship withdrawals are permitted as defined in the Plan.

## ERISA spending account:

The Company and Fidelity Management Trust Company ("FMTC"), the Plan trustee, have established an ERISA Spending Account, or Revenue Credit Account ("RCA"), funded by deposits from the trustee. Funds in the RCA are treated as plan assets and must be used to reimburse the Company for permissible plan expenses incurred or allocated to participants, as described in the amendment to the trust agreement. Such funds are provided when certain credits exceed the amount required to offset recordkeeping and administrative service fee charges by the trustee, as detailed in the amendment. Such amounts are deposited quarterly in arrears. Funds are invested in the Fidelity Government Money Market Fund. Funds deposited into the RCA are recorded as contributions-other. Contributions of \$20,711 were made to the RCA for the year ended December 31, 2024. The balance of the RCA was \$160,189 and \$132,539 as of December 31, 2024 and 2023.

## Note 2. Significant Accounting Policies

## Basis of accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

## Investment valuation and income recognition:

Investments made through self-directed brokerage funds include certificates of deposit, common stock, exchange traded funds/notes, money market funds, mutual funds, and equity options.

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

## Administrative expenses:

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

## Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

## Payment of benefits:

Benefit distributions, determined in accordance with provisions of the Plan, are recorded when paid.

## Use of estimates:

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

## Note 3. Related Party Activity

Certain Plan investments are mutual funds held and managed by Fidelity Management Trust Company. As Fidelity Management Trust Company is the trustee of the Plan, these transactions qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA. During 2024, fees paid by the Plan totaled \$27,285.

## Note 4. Information Prepared and Certified by Trustee

The following information was compiled from data certified by Fidelity Management Trust Company, the trustee of the Plan, as being complete and accurate:

- A. Investments included in the Statements of Net Assets Available for Benefits - December 31, 2024 and 2023.
- B. Investment income included in the Statement of Changes in Net Assets Available for Benefits - Year Ended December 31, 2024.
- C. Investment information included in Schedule of Assets Held at End of Year.

## Note 5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

## Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### Note 7. Income Tax Status

The Plan is a prototype non-standardized profit sharing plan with cash or deferred arrangement (CODA). The Internal Revenue Service had determined and informed Fidelity Management & Research Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Any employer adopting this form of the Plan will be considered to have a plan qualified under the applicable section of the IRC. Therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes is included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 8. Fair Value Measurements

The Plan's investments are valued at fair value based on a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds and money market fund:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-directed brokerage funds (including certificates of deposit, common stock, exchange traded funds/notes, money markets, mutual funds, and equity options):* Valued based on quoted market prices of certificates of deposit, common stock, exchange traded funds/notes, money markets, mutual funds, and equity options traded in active markets and held by the Plan at year-end.

*Interest in common collective trust funds:* The fair value of the participation units held in the collective trust funds are based on their NAV, as reported by the managers of the collective trust funds and as supported by the unit prices of actual purchase and sale transactions occurring as of or close to the financial statement date. The Putnam Stable Value Fund invests primarily in guaranteed and security-backed investment contracts with life insurance companies, banks, and other financial institutions. The collective trust funds provide for daily redemption by the Plan at reported NAV per share, with no advance notice requirement. The NAV is used as a practical expedient to estimate fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
