Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of ATL Retirement & Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of ATL Retirement & Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from John Hancock, the trustee, a qualified institution as of December 31, 2024 and 2023 and for the year December 31, 2024, stating that the certified investment, information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of ATL Retirement & Savings Plan 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about ATL Retirement & Savings Plan 401(k) Plan 's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for ne resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The supplemental schedules, Schedule H, Line 4a - Schedule of Delinquent Participant Contributions, and Schedule H, Line 4i - Schedule of Assets (HELD AT END OF YEAR) are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. The following description of the ATL Retirement & Savings Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

1. General - The Plan is a defined contribution plan covering substantially all employees of Advanced Technology Leaders, Inc. (the “Sponsor” or “Company”) initially adopted January 1, 2017 and most recently amended and restated on June 1, 2023 to incorporate prior amendments and current laws. Employees are eligible for participation once they have completed 3 months of service and have attained 21 years of age. Employees become participants on the first day of the month following the completion of eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).
2. Administration - The Sponsor has designated certain employees, who serve without additional compensation, to administer the Plan. The Plan administrator has the overall responsibility and authority as the named fiduciary to manage and control the operations and administration of the Plan and may designate one or more individuals to perform those responsibilities.
3. Contributions - For the year ended December 31, 2024, participants may contribute from 1% to 90% of compensation, up to the IRS maximum percentage of pretax annual compensation, as defined in the Plan. Roth contributions are also allowed. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan.
4. The Sponsor will make safe harbor matching contributions to the Plan authorized by the board of directors of the Sponsor. The Sponsor made required safe harbor matching contributions of 100% of the first 4% of participant contributions totaling \$351,114 for the Plan year ended December 31, 2024.

The Company may decide to make a nonelective contribution to the Plan. The nonelective contribution will be allocated to all employees eligible to participate in the Plan. There are no nonelective contributions made by the Company for the year ended December 31, 2024.

Catch-up Contributions - For the year ended December 31, 2024, if a participant is eligible to make deferrals and turns 50 before the end of the calendar year, the participant may defer an additional catch-up contribution into the Plan as a pre-tax contribution subject to certain IRC limitations and limits as defined by the Plan.

5. Participant Accounts - Each participant’s account is credited with the participant’s contribution and allocations of the Sponsor’s contribution and Plan earnings and charged with benefits paid to participants and an allocation of Plan losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

NOTE 1 - DESCRIPTION OF PLAN (continued)

6. Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Participants may have one loan outstanding at a time. The loans are secured by the balance in the participant's account and bear interest at a rate of prime plus 2%, 9.5% as of December 31, 2024. Principal and interest are paid ratably through bi-weekly payroll deductions. Participant loans must be repaid within a period of five years, unless such loan is for the purchase of the participant's primary residence, in which case loan repayment can be in excess of five years.
7. Vesting - Participants are vested immediately in their contributions and actual earnings thereon, as well as the Sponsor's safe harbor matching contributions. The Sponsor's nonelective contributions will be vested according to the following schedule:

Less than 2	0%
At least 2 years, but less than 3	20%
At least 3 years, but less than 4	40%
At least 4 years, but less than 5	60%
At least 5 years, but less than 6	80%
6 or more years	100%

8. Benefits Paid to Participants - Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or installments as defined by the Plan. Withdrawals prior to attaining age 59½ are not permitted, except in the event of total disability, or as a hardship distribution. Upon proof, to the satisfaction of the Plan administrator, of an immediate and heavy financial need, amounts contributed may be withdrawn for a hardship purpose. Certain income tax penalties may apply to withdrawals or distributions prior to age 59½.
9. Investment Options - Upon enrollment in the Plan, each participant may make contributions into various investment options offered by the Plan. Participants may change their investment options at any time.
10. Forfeitures - Forfeited amounts are used to reduce the Sponsor's safe harbor matching contributions, as defined by the Plan. As of December 31, 2024 and 2023, forfeited accounts totaled zero for both years and no amounts were used to reduce the safe harbor matching contributions for the year ended December 31, 2024.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

The policies and principles that significantly affect the determination of net assets and changes in the net assets are summarized below:

Basis of Accounting - The financial statements of the Plan are prepared using the accrual method of accounting.

Contributions Receivable - Amounts deferred by participants or the sponsor before yearend and remitted afterward are presented on the statement of net assets available for benefits as contributions receivable. The Plan evaluates the collectability of contributions receivable based on management's review of historical loss experience, current economic conditions, reasonable and supportable forecasts, and other relevant factors. As of December 31, 2024 and 2023, Management believes that the receivables are fully collectible and that no allowance for credit losses is necessary.

Notes Receivable from Participants - The Plan allows participants to borrow from their individual accounts. Participant loans are secured by the balance in the participant's account. As of December 31, 2024 and 2023, Management has assessed the collectability of these loans based on review of historical loss experience, current economic conditions, reasonable and supportable forecasts, and other relevant factors and believes that no allowance for credit losses is necessary.

Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

The Plan presents in its statement of changes in net assets available for benefits the net appreciation/depreciation in the fair value of investments, which consists of realized gains or losses and unrealized appreciation/depreciation on those investments.

Payment of Benefits - Benefit payments to participants are recorded upon distribution.

Administrative Expenses - Certain administrative functions are performed by employees of the Plan Sponsor. No such employee receives compensation from the Plan. In addition, substantially all administrative expenses are paid directly by the Plan Sponsor.

Subsequent Events - The Plan has evaluated subsequent events through September 12, 2025, the date the financial statements were available to be issued.

NOTE 4 - FAIR VALUE MEASUREMENTS

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. Fair value measurements must be classified and disclosed in one of the three levels of the fair value hierarchy are described as follows:

- Level 1 - Financial instruments with unadjusted, quoted prices listed on active market exchanges.
- Level 2 - Financial instruments values using inputs that include quoted prices for similar assets or liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.
- Level 3 - Financial instruments that are not actively traded on a market exchange and require using significant unobservable inputs in determining fair value

NOTE 4 - FAIR VALUE MEASUREMENTS (continued)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds - These investments are public investment vehicles valued using the net asset value ("NAV") provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. These are classified within Level 1 of the valuation hierarchy.

The following tables summarize the valuation of the Plan's financial assets and liabilities measured at fair value on a recurring basis as of December 31, 2024 and 2023, based on the level of input utilized to measure fair value:

NOTE 5 - RIGHTS UPON PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions and earnings thereon.

NOTE 6 - TAX STATUS

The IRS has determined and informed the Plan sponsor by a letter dated October 6, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires the Plan Sponsor to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by regulatory agencies. The Plan Sponsor does not believe there are any material uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by the qualified institution of the Plan. Fees paid by the Plan for investment management services, as well as distribution fees, amounted to \$27,472 for the year ended December 31, 2024.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan provides for various investment options including any combination of mutual funds and traditional annuity contracts. The underlying investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits and participants' individual account balances.

NOTE 9 - DELINQUENT CONTRIBUTIONS

As required by ERISA Section 2510.3-102, the Plan Sponsor is required to segregate employee contributions to the Plan from its general assets as soon as practicable. During the 2024 Plan year, the Company failed to remit to the Plan's trustee certain employee and employer contributions totaling \$153,680 within the period prescribed by DOL regulations. The delayed contributions are considered prohibited, or nonexempt transactions. All delinquent contributions have been funded to the plan by the audit report date.
