Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Century Mining, LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTES TO FINANCIAL STATEMENTS

AS OF DECEMBER 31, 2024 AND 2023, AND FOR THE YEAR ENDED DECEMBER 31, 2024

1. DESCRIPTION OF THE PLAN

The following description of the Century Mining, LLC 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan’s information.

General—The Plan is a defined contribution plan covering substantially all employees of Century Mining LLC (the “Company”) who are not covered by a union agreement, nonresident aliens, leased employees, or part-time or seasonal employees. The Company has appointed the 401(k) Committee of Century Mining, LLC to control and manage the operation and administration of the Plan. Certain employees of the Company serve as the trustee of the Plan and John Hancock Life Insurance Company (U.S.A.) is the Insurance Carrier of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On November 22, 2024, Century Mining, LLC (Plan Sponsor) filed for bankruptcy under Chapter 11. On June 13, 2025, the Plan Sponsor emerged from bankruptcy. As a result of the emergence, the Plan Sponsor changed the name of the Plan from Century Mining, LLC 401(k) Plan to Allegheny Metallurgical LLC 401(k) Plan. Other than the name change there was no impact on the Plan from bankruptcy.

Contributions—Contributions to the Plan include (i) salary reduction contributions authorized by participants, (ii) safe-harbor contributions made by the Company, (iii) discretionary matching or profit-sharing contributions made by the Company; and (iv) participant rollovers from other qualified plan. Participants have the option to make Roth elective salary reduction contributions to the plan.

Participants may elect to contribute a percentage of their compensation to the Plan each year, subject to the limitations, as defined in the plan document. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions; these additional contributions are also eligible for a Company matching contribution.

The Company makes a safe-harbor contribution to each participant’s account equal to 100% of the amount of the participant’s salary reduction contribution, up to 5%, as defined by the Plan. Additional profit-sharing amounts may be contributed at the discretion of the Company. During the year-ended December 31, 2024, the Company did not make any additional profit-sharing contribution to the Plan.

Participants may also contribute amounts representing distributions from other qualified plans, which represent rollovers into the Plan (rollovers). Contributions are subject to certain Internal Revenue Code (IRC) limitations.

Participant Accounts—Individual accounts are maintained for each participant of the Plan. Each participant’s account is credited with the participant’s contribution and related matching Company contributions and Plan earnings. Participant accounts are also charged with withdrawals and an allocation of plan losses and administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investments—Participants may direct the investment of their contributions and any discretionary profit-sharing contributions and/or account balances into various investment options offered by the Plan and may change investments and transfer amounts between funds daily.

Vesting—Participants are vested immediately in their contributions and the safe-harbor contributions, plus actual earnings thereon. Vesting in the Company’s matching and profit-sharing contribution portion of their accounts is based on years of continuous service in accordance with the following schedule:

Notes Receivable from Participants—Participants may borrow from their accounts a minimum of \$1,000 up to the lesser of a maximum of one-half of the vested account balance or \$50,000 and may only have 1 loan outstanding at a time. The loans are secured by an assignment of a participant’s vested interest in the Plan, and bear interest at a rate of prime plus 1% at the time funds are borrowed. Principal and interest are paid ratably through payroll deductions or as a lump sum for the outstanding loan balance. Loan terms range from 1 to 5 years; however, terms may exceed 5 years for the purchase of a primary residence. As of December 31, 2024, participant loans have maturities through 2039 at interest rates ranging from 7.25 percent to 9.50 percent.

Payment of Benefits—A participant may request an in-service withdrawal at the age of 59 ½. On termination of service with the Company (including termination of service due to death, disability, or retirement), a participant may generally elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account or annual installments.

Participants are also eligible to make hardship withdrawals from their deferred contributions in the event of certain financial hardships.

Forfeited Accounts—When certain terminations of participation in the Plan occur, the nonvested portion of the participant’s account, as defined by the Plan, represents a forfeiture. The plan document permits the use of forfeitures to either reduce future employer contributions or pay plan administrative expenses for the plan year. At December 31, 2024 and 2023, there were no forfeited nonvested accounts.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting—The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates—The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties—The Plan provides various investment options to its participants. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the value of the participants' account balances and the amounts reported in the financial statements.

The Plan sponsor operates in the mining industry which has many inherent risks including safety events that could cause business interruption. The Plan sponsor has comprehensive insurance coverages in place for such events. In response to a safety event, the Plan sponsor may discontinue the company match or terminate the plan (see Note 6).

Concentration of Investments—The Plan has a concentration (i.e., 10% or more of total investments) in the following investments at December 31, 2024 and 2023. A significant decline in the market value of these investments would significantly affect the net assets available for benefits.

Investment Valuation and Income Recognition—The Plan's investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held at year end.

Notes Receivable from Participants—Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the plan document.

Contributions—Employee contributions and employer matching contributions are recorded when withheld and earned, respectively.

Administrative Expenses—Administrative expenses of the Plan are paid by the Plan or the Plan sponsor, as provided in the Plan document. Participants pay administrative costs for loans, distributions and qualified domestic relation orders.

All investment management and transaction fees directly related to the Plan investments are paid by the Plan. Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, investment management fees and operating expenses are reflected as a reduction of investment return for such investments.

Payment of Benefits—Benefit payments to participants are recorded upon distribution. There were no participants who elected to withdraw from the Plan but had not yet been paid at December 31, 2024.

Subsequent Events—Subsequent events were evaluated through September 24, 2025, the date the financial statements were available to be issued. No events occurred that require additional disclosure or adjustments to the Plan’s financial statements.

3. CERTIFIED INVESTMENT INFORMATION

The following is a summary of the information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan’s financial statements and supplemental schedules that were prepared by or derived from information prepared by the Insurance carrier of the Plan and furnished to the Plan administrator. The Plan administrator has obtained certifications from the Insurance carrier that such information is complete and accurate.

4. FAIR VALUE MEASUREMENTS

Accounting Standards Codification (ASC) 820, Fair Value Measurement, provides a framework for measuring fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value, as follows: Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets [and liabilities] are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Asset Valuation Techniques—Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value.

Pooled Separate Accounts—Valued by using the net asset value (NAV) of the funds at year-end as a practical expedient. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. The pooled separate accounts do not have any redemption restrictions or unfunded commitments.

Stable Value Fund—The net asset value (NAV) is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to confirm that securities liquidations will be carried out in an orderly business manner.

5. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

John Hancock Life Insurance Company (U.S.A.) is the Insurance carrier and recordkeeper, as defined by the Plan. The Plan invests in John Hancock pooled separate accounts which are exempt from prohibited transaction rules and are exempt party-in-interest transactions. Fees paid for investment management services were included as a reduction of the return earned on each fund. The Plan also issues loans to participants, which are secured by the vested balances in the participants' accounts.

6. PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

7. FEDERAL INCOME TAX STATUS

The Plan uses a prototype plan document sponsored by Blue Sky 401(k) Specialists Inc. Blue Sky 401(k) Specialists Inc. received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, which states that the prototype document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.
