Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For



information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Description of the Plan

The following description of the Vericel Corporation 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Vericel Corporation (the Company) and its subsidiaries. The Plan was established effective January 1, 1994. The Plan was amended and restated effective October 1, 2021. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The trustee and recordkeeper of the Plan is Fidelity Management Trust Company (the Trustee or Fidelity). The administrator of the Plan is the Company. The Trustee holds all assets of the Plan in accordance with the service provider contract with the Company. The Vericel 401k Committee (the VCC) determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

All employees of the Company who have attained age 21 are eligible to become participants in the Plan and to receive Company matching contributions, except for leased employees (as defined in the Plan document). In addition, residents of Puerto Rico and nonresident aliens with no income from U.S. sources (as defined in the Plan document) are not eligible to participate in the Plan. Effective October 1, 2021, employees are eligible to participate in the Plan on the first of the month after 30 days of employment.

Contributions

Each year, participants may contribute up to 60% of their eligible compensation, as defined in the Plan document, subject to certain Internal Revenue Service (IRS) limitations. Participants' contributions are withheld from the participants' pay on a pre-tax basis. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Company contributes 100% of the first 3.5% of eligible compensation that a participant contributes to the Plan. Additional amounts may be contributed and allocated by the Company at the discretion of the VCC. During the years ended December 31, 2024 and 2023, the Plan did not receive any additional contributions from the Company that were made at the discretion of the VCC. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollovers).

Participants direct the investment of their contributions and the Company's contributions into various investment options offered by the Plan.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is increased for any participant contribution, the Company's matching contributions, the Company's discretionary contributions, and an allocation of the Plan's investment earnings. Additionally, each participant's account is charged with withdrawals, an allocation of the Plan's investment losses,

and administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants in the Plan are 100% vested in their own contributions. Participants will vest 100% in their Company matching contributions and discretionary contributions after three years.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance reduced by the highest outstanding loan balance in their account during the prior 12-month period. The loans are secured by the balance in the participant's account and bear interest at rates determined by the Company in its capacity as Plan administrator based on the prevailing interest rates charged by financial institutions for loans that would be made under similar circumstances. The interest rate remains fixed throughout the duration of the loan. Principal and interest are paid ratably through payroll deduction over a period of five years or less, unless loans were used to purchase a primary residence, in which case the loan terms may exceed five years. Also, each participant may not have more than one loan outstanding at any time.

Payment of Benefits

Upon disability, retirement, or termination of service, a participant may generally elect to receive a lump-sum amount equal to the value of the participant's account balance. For terminated participants with vested balances greater than \$1,000, but less than \$5,000, their vested balance will be rolled into an individual retirement account with Fidelity unless otherwise elected. Immediate lump-sum distributions are to be made to terminated participants if the participant's vested account balance is \$1,000 or less. Withdrawals from the Plan may also be made upon circumstances of financial hardship, in accordance with provisions specified in the Plan. Participants may also withdraw an amount at age 59½ if certain criteria are met.

Forfeitures

Forfeited non-vested accounts may be used to pay administrative expenses and reduce future Company contributions. For the years ended December 31, 2024 and 2023, the Company did not direct any forfeitures to be allocated to administrative expenses and \$96,739 and \$135,645 was applied to reduce the Company contributions, respectively. At December 31, 2024, there was a balance of \$21,522 of forfeitures remaining in the Plan and no forfeitures were remaining in the Plan in 2023.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires the Plan administrator to use estimates and assumptions that impact the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the Trustee. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued unpaid interest. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Administrative Expenses

Administrative expenses of the Plan are paid by the Company, except for certain expenses that are charged to participant accounts, including loan fees, withdrawal fees, Plan administrative fees, and investment management fees. Certain investment expenses that are charged within investments are presented net of the appreciation in fair value of investments. All other expenses of the Plan were paid by the Company and are excluded from these financial statements.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Subsequent Events

Subsequent events were evaluated through September 24, 2025, which is the date the financial statements were available to be issued. Effective January 1, 2025, the Plan was amended to allow for designated Roth 401(k) contributions. This amendment permits participants to elect to have a portion or all of their elective deferrals designated as Roth contributions, which are made on an after-tax basis. There were no other subsequent events impacting the Plan that require recognition or disclosure in the financial statements.

3. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money Market Fund - The money market fund invests in high-quality short-term securities. In accordance with Rule 2a-7 under the 1940 Act, the money market fund is valued at amortized cost method, which approximates fair value. This method of valuation is designed to enable the money market fund to price its shares at \$1.00 per share, although each money market fund's share price may deviate from \$1.00 per share. The objective of this money market fund is to preserve capital and liquidity and achieve the highest possible current income.

Common/Collective Trust - The common/collective trust is a stable value fund that is composed primarily of fully benefit-responsive investment contracts. Investments in the stable value funds are considered indirect investments in fully benefit-responsive investment contracts, and, therefore,

are valued at NAV, which is used as a practical expedient to estimate fair value. There are no unfunded commitments. There are no participant redemption restrictions for this investment and the redemption notice period is applicable only to the Plan. The redemption frequency is daily for participant level transactions. This is a direct filing entity.

Collective Investment Trusts (CITs) - CITs are valued at the NAV of units held. The NAV, as provided by the trustee of the CITs, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the CIT less its liabilities. This practical expedient is not used when it is determined to be probable that the CITs will sell for an amount different than the reported NAV. There are no participant redemption restrictions for this investment and the redemption notice period is applicable only to the Plan. There are no unfunded commitments related to these investments. These are direct filing entities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of termination of the Plan by the Company, all participants would become 100% vested in their accounts.

5. Income Tax Status

The Plan uses a pre-approved plan document sponsored by Fidelity. Fidelity received an opinion letter from the IRS, dated June 30, 2020, which states that the pre-approved document, as then designed, satisfies the applicable provisions of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS. Although the Plan has been amended and restated since the date of the opinion letter, Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examination audits for any tax periods in progress.

6. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends and interest income, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution.

7. Risks and Uncertainties

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the financial statements and participant account balances.

8. Related Party and Party-in-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by Fidelity. Participant loan and distribution processing fees are paid to Fidelity by participants. The Plan also issues loans to participants that are secured by the vested balance of the participants' accounts. The Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.
