1. Description of Plan

The following brief description of the Lifeline Medical Associates, LLC Cash or Deferred Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement or summary Plan description for a more complete description of the Plan’s provisions.

General

The Plan was established on January 1, 2003 by Lifeline Medical Associates, LLC (the “Company”) to provide supplemental retirement benefits to its employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Plan management oversees the governance of the Plan.

Administration

The general administration of the Plan and the responsibility for carrying out its provisions is placed on the Company. The Company has engaged the services of an independent profit sharing and pension plan administration firm to assist it with the performance of its duties.

The Company has entered into a trust agreement with Fidelity Management Trust Company (the “Trustee”) to provide for the establishment of a trust to which all employee contributions shall be contributed and from which all benefits under the Plan shall be paid. The Trustee values all accounts on each accounting date.

Eligibility

All employees with at least 21 years of age are eligible to participate in the Plan after completing one year of service and a minimum of 1,000 hours of service.

Contributions

Each year, participants may contribute a percentage of their pre-tax annual compensation, as defined in the Plan, up to maximum of \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions not to exceed \$7,500 for both the years ended December 31, 2024 and 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers mutual funds and money market funds as investment options for participants.

The Company may make a safe-harbor contribution of 3% of the non-highly compensated employees’ compensation for any Plan year. For the years ended December 31, 2024 and 2023, the contribution was \$782,927 and \$795,981 respectively.

The Company may also make profit sharing contributions of 3% to 9% of owners’ and highly compensated employees’ annual wages. That contribution was \$1,989,397 and \$1,906,494 for the years ended December 31, 2024 and 2023, respectively.

The Plan also has a matching contribution feature that is discretionary at the determination of the Company. For the years ended December 31, 2024 and 2023, there was no discretionary match.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of: (a) Company contributions, (b) Plan earnings, (c) forfeitures of terminated participant's non-vested accounts and charged with benefits paid and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participants' vested accounts.

Vesting

Participants are immediately vested in their voluntary and safe-harbor contributions plus actual earnings thereon. Vesting in the Company's profit sharing contribution portion of their accounts plus actual earnings thereon is based upon years of continuous service as follows:

<u>Years of Service</u>	<u>Vested Percentage</u>
After 1 year but less than 2	20%
After 2 years but less than 3	40%
After 3 years but less than 4	60%
After 4 years but less than 5	80%
After 5 or more years	100%

Vesting in the Company's matching contribution portion of their accounts plus actual earnings thereon is based upon years of continuous service as follows:

<u>Years of Service</u>	<u>Vested Percentage</u>
After 2 years but less than 3	20%
After 3 years but less than 4	40%
After 4 years but less than 5	60%
After 5 years but less than 6	80%
After 6 or more years	100%

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer between the investment fund and the loan fund. Loan terms may not exceed five years, unless the loan is made for the purchase of a principal residence, in which case the repayment period may exceed five years.

The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest are paid ratably through monthly payroll deductions. The interest rates ranged from 4.25% to 9.5% at December 31, 2024.

Payments of Benefits

Upon death, retirement, disability or termination of service, a participant may elect to receive their benefits as a lump-sum or roll over the balance to another qualified plan or individual retirement account. A participant, with account balance exceeding \$1,000, may elect to receive annual installments over a period not to exceed the participant's life expectancy or their designated beneficiary. If no election is made, the Plan administrator may automatically roll over the vested balance into an individual retirement account for balances between \$1,000 and \$5,000. For balances below \$1,000, the Plan administrator may distribute the account as a lump sum. Additionally, under certain circumstances of financial hardship, the participant is allowed to withdraw funds from the Plan.

Forfeitures

Forfeitures of terminated participants' non-vested balances are available to offset future employer contributions at the Company's discretion. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$29,948 and \$14,111, respectively. There were no employer contributions reduced from forfeited non-vested accounts in 2024 or 2023.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Plan Expenses

The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan Document. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Plan management has reviewed subsequent events and transactions that occurred after December 31, 2024 through the date of the independent auditor's report and the date the financial statements were available to be issued, July 25, 2025. The financial statements include all events or transactions, including estimates, required to be recognized in accordance with generally accepted accounting principles. Management has determined that there are no non-recognized subsequent events that require additional disclosure.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Self Directed Brokerage Accounts: For the Fidelity BrokerageLink investments, the Plan receives prices from a nationally recognized pricing service that are based on observable market transactions and includes these estimates in the amount disclosed in Level 1. The fair value of the certificates of deposit is estimated using the external pricing service, and is disclosed in Level 2. The fair value of the corporate bonds is provided by the external pricing service, and is disclosed in Level 2 since significant inputs are market observable.

Mutual funds and money market funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at the price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trusts: Units of the Retirement Savings Trust are valued at NAV at year-end. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan were to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurement at the reporting date.

Defaulted participant loans for those participants that are still actively employed are recorded as deemed distributions on the form 5500.

6. Exempt Party-In-Interest Transactions

The Plan invests in self-directed brokerage accounts managed by an affiliate of Fidelity Management Trust Company (“FMTC”). FMTC acts as trustee for only those investments as defined by the Plan. Transactions in such investments qualify as party-in-interest transactions which are exempt from the prohibited transaction rules. Fees paid by the Plan for the investment management services are included in the net appreciation(depreciation) in fair value of investments, as they are paid through revenue sharing, rather than direct payment.

7. Tax Status

The Plan has received a determination letter from the Internal Revenue Service dated June 30, 2020, stating that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.
