Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements

We have performed an audit of the accompanying financial statements of Washburn-McReavy Funeral Chapels, Inc. Profit Sharing/401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Washburn-McReavy Funeral Chapels, Inc. Profit Sharing/401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Opinion on the Financial Statements

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Washburn-McReavy Funeral Chapels, Inc. Profit Sharing/401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. Description of Plan

The following description of Washburn-McReavy Funeral Chapels, Inc. (“Company”) Profit Sharing/401(k) Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General - The Plan is a defined contribution plan covering all full time employees of the Company who have completed one year of service, defined as completing at least 1,000 hours of service during a Plan year, and are age twenty-one or older, except for employees specifically identified in the Plan agreement as employees paid primarily on a commission basis, employees classified by the Company as assistant grounds keepers and equipment maintenance employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA) and the requirements of section 401(k) of the Internal Revenue Code (IRC). Effective January 1, 2021, the Plan was amended and restated to bring the Plan into compliance with legislative and regulatory changes set forth in IRS Notice 2017-37 (i.e. the 6-year pre-approved plan restatement cycle.)

Contributions - The Plan permits participants to make contributions up to 100% percent of eligible compensation, as defined by the Plan, up to the maximum allowed by the Internal Revenue Code sections 401(k), 402(g), 404 and 415. Participants direct the investment of the contributions into various investment options offered by the Plan, currently mutual funds.

The Company, at its discretion, may annually contribute a percentage of each participant’s pre-tax annual base compensation and has currently elected to match 100% of the participant’s contribution, up to 4% of eligible compensation. Contributions are subject to compensation ceiling and annual limitations prescribed by the IRC. Additional profit sharing amounts may be contributed at the option of the Company. For the Plan years ended December 31, 2024 and 2023, the Company made a profit sharing contribution of approximately \$266,000 and \$247,000, respectively, and a matching contribution of approximately \$209,000 and \$201,000, respectively, to the Plan.

Participant accounts - Each participant’s account is credited with the participant’s contribution and the Company’s matching contribution. Each participant account is charged an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

1. Description of Plan (continued)

Vesting - Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Employer contributions are subject to a graded vesting schedule and are fully vested after six years of service. Participants become immediately vested in the Company's contributions if they become disabled or upon death.

Payment of benefits – On termination of service due to death, disability, retirement, or termination of employment, a participant may elect to receive installment payments or a lump-sum amount equal to the value of the participant's vested interest in his or her account. Certain mandatory distribution provisions may apply to balances less than \$5,000 for terminated employees. The Plan also permits in-service distributions for those that have achieved age 59 1/2.

Forfeited accounts – If a participant terminates employment before coming fully vested in their account balance, the forfeited portion of the account balance is used to reduce future employer contributions to the Plan. At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$0 both years. During the years ended December 31, 2024 and 2023, approximately \$1,700 and \$1,650 of forfeited nonvested account totals in the Plan were used to reduce employer contributions, respectively.

2. Summary of Accounting Policies

Basis of accounting - The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ from those estimates.

Payments of benefits - Benefits are recorded when paid.

Administrative expenses – Custodian and accounting fees are paid primarily by the Company.

Investment valuation and income recognition - The Plan's investments are stated at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year end using quoted market prices. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized gains and losses on investments bought and sold during the year, as well as unrealized gains and losses on investments held during the year, are presented at net appreciation (depreciation) in fair value of investments.

2. Summary of Accounting Policies (continued)

Subsequent events - Plan management has evaluated subsequent events through August 15, 2025, which is the date the financial statements were available to be issued.

3. Certified Investments

At December 31, 2024 and 2023, the Plan's investments were held by the Trustee, Alerus Financial, N.A. Participants in the Plan directed the Trustee as to the investment of their individual account balance.

The Trustee has certified the completeness and accuracy of all investments reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

4. Fair Value Measurements

The Fair Value Measurements Topic of the FASB Accounting Standards Codification establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy are as follows:

Level 1 - Inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.

Level 2 - Inputs are inputs other than quoted prices within Level 1 that are observable for the asset or liability, either directly or indirectly.

Level 3 - Inputs are unobservable inputs for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

4. Fair Value Measurements (continued)

Common Collective Fund: Valued at fair value based on the NAV units held of the collective fund. The NAV is based on the observable market prices of the underlying investments within the fund less liabilities. The NAV for the underlying assets of the fund is a readily determinable measure of their fair value and is the basis used by the fund for current transactions.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

6. Plan Amendments and Tax Status

The prototype plan obtained a favorable determination letter on June 30, 2020, in which the Internal Revenue Service stated the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter, and the plan administrator believes the Plan is operating in compliance with the applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Non-Participant-Directed Investments

There are no non-participant-directed investments.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

9. Exempt Party-in-Interest Transactions

Transactions resulting in Plan assets being transferred to or used by a related party are prohibited under ERISA unless a specific exemption applies. Alerus Financial, N.A., the trustee of the Plan, is a party-in-interest, as defined by ERISA, as a result of the investment of Plan assets. However, such transactions are exempt under Section 408(b)(8) and are not prohibited by ERISA.

The Plan paid administrative fees totaling approximately \$1,400 to the trustee during the years ended December 31, 2024 and 2023, both.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. 1. Description of Plan

The following description of Washburn-McReavy Funeral Chapels, Inc. (“Company”) Profit Sharing/401(k) Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General - The Plan is a defined contribution plan covering all full time employees of the Company who have completed one year of service, defined as completing at least 1,000 hours of service during a Plan year, and are age twenty-one or older, except for employees specifically identified in the Plan agreement as employees paid primarily on a commission basis, employees classified by the Company as assistant grounds keepers and equipment maintenance employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA) and the requirements of section 401(k) of the Internal Revenue Code (IRC). Effective January 1, 2021, the Plan was amended and restated to bring the Plan into compliance with legislative and regulatory changes set forth in IRS Notice 2017-37 (i.e. the 6-year pre-approved plan restatement cycle.)

Contributions - The Plan permits participants to make contributions up to 100% percent of eligible compensation, as defined by the Plan, up to the maximum allowed by the Internal Revenue Code sections 401(k), 402(g), 404 and 415. Participants direct the investment of the contributions into various investment options offered by the Plan, currently mutual funds.

The Company, at its discretion, may annually contribute a percentage of each participant’s pre-tax annual base compensation and has currently elected to match 100% of the participant’s contribution, up to 4% of eligible compensation. Contributions are subject to compensation ceiling and annual limitations prescribed by the IRC. Additional profit sharing amounts may be contributed at the option of the Company. For the Plan years ended December 31, 2024 and 2023, the Company made a profit sharing contribution of approximately \$266,000 and \$247,000, respectively, and a matching contribution of approximately \$209,000 and \$201,000, respectively, to the Plan.

Participant accounts - Each participant’s account is credited with the participant’s contribution and the Company’s matching contribution. Each participant account is charged an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

1. Description of Plan (continued)

Vesting - Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Employer contributions are subject to a graded vesting schedule and are fully vested after six years of service. Participants become immediately vested in the Company's contributions if they become disabled or upon death.

Payment of benefits – On termination of service due to death, disability, retirement, or termination of employment, a participant may elect to receive installment payments or a lump-sum amount equal to the value of the participant's vested interest in his or her account. Certain mandatory distribution provisions may apply to balances less than \$5,000 for terminated employees. The Plan also permits in-service distributions for those that have achieved age 59 1/2.

Forfeited accounts – If a participant terminates employment before coming fully vested in their account balance, the forfeited portion of the account balance is used to reduce future employer contributions to the Plan. At December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$0 both years. During the years ended December 31, 2024 and 2023, approximately \$1,700 and \$1,650 of forfeited nonvested account totals in the Plan were used to reduce employer contributions, respectively.

2. Summary of Accounting Policies

Basis of accounting - The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ from those estimates.

Payments of benefits - Benefits are recorded when paid.

Administrative expenses – Custodian and accounting fees are paid primarily by the Company.

Investment valuation and income recognition - The Plan's investments are stated at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year end using quoted market prices. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized gains and losses on investments bought and sold during the year, as well as unrealized gains and losses on investments held during the year, are presented at net appreciation (depreciation) in fair value of investments.

2. Summary of Accounting Policies (continued)

Subsequent events - Plan management has evaluated subsequent events through August 15, 2025, which is the date the financial statements were available to be issued.

3. Certified Investments

At December 31, 2024 and 2023, the Plan's investments were held by the Trustee, Alerus Financial, N.A. Participants in the Plan directed the Trustee as to the investment of their individual account balance.

The Trustee has certified the completeness and accuracy of all investments reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

4. Fair Value Measurements

The Fair Value Measurements Topic of the FASB Accounting Standards Codification establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy are as follows:

Level 1 - Inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.

Level 2 - Inputs are inputs other than quoted prices within Level 1 that are observable for the asset or liability, either directly or indirectly.

Level 3 - Inputs are unobservable inputs for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

4. Fair Value Measurements (continued)

Common Collective Fund: Valued at fair value based on the NAV units held of the collective fund. The NAV is based on the observable market prices of the underlying investments within the fund less liabilities. The NAV for the underlying assets of the fund is a readily determinable measure of their fair value and is the basis used by the fund for current transactions.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

6. Plan Amendments and Tax Status

The prototype plan obtained a favorable determination letter on June 30, 2020, in which the Internal Revenue Service stated the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter, and the plan administrator believes the Plan is operating in compliance with the applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Non-Participant-Directed Investments

There are no non-participant-directed investments.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

9. Exempt Party-in-Interest Transactions

Transactions resulting in Plan assets being transferred to or used by a related party are prohibited under ERISA unless a specific exemption applies. Alerus Financial, N.A., the trustee of the Plan, is a party-in-interest, as defined by ERISA, as a result of the investment of Plan assets. However, such transactions are exempt under Section 408(b)(8) and are not prohibited by ERISA.

The Plan paid administrative fees totaling approximately \$1,400 to the trustee during the years ended December 31, 2024 and 2023, both.
