Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the Financial Statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

(1) Description of the Plan

(a) General

The FuelCell Energy, Inc. Capital Accumulation Plan (the Plan) is a defined contribution plan which was established by FuelCell Energy, Inc. (the Company or Plan Sponsor) on January 19, 1987.

The Plan is a defined contribution profit-sharing plan covering all eligible full-time and part-time employees of the Company who are 18 years of age or older. Participation in the Plan is voluntary, and the Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Participants should refer to the Fidelity Basic Plan Document Number 17 (the "Volume Submitter Plan"), the Adoption Agreement revised October 2014, and the Trust Agreement (collectively, the "Agreement") for a complete description of the Plan's provisions.

Fidelity Management Trust Company (the Trustee) is the Trustee of the Plan. Fidelity Investments Institutional Operations Company, Inc. is the recordkeeper of the Plan. The Retirement Plan Fiduciary Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

(b) Contributions

After participants satisfy the Plan's eligibility and entry date requirements, they may contribute, through payroll deductions, from 1% to 50% of their base pay on a pre-tax basis, as defined by the Plan. Participants may designate some or all of their contributions as Roth deferral contributions. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation, which automatically increases by 1% per year up to a maximum of 8%, and their contributions invested in a designated balanced fund until changed by the participant. These contribution amounts are subject to statutory limitations of the amount of compensation that may be taken into account each Plan year.

The Plan provides that participants who are expected to attain age 50 or older by the end of the calendar year and who are making the maximum amount of pre-tax contributions permitted under the Plan may make an additional contribution called a "catch-up contribution." Participants may only make this contribution if they make pre-tax contributions equal to the lesser of: (1) \$23,000 in 2024 and \$22,500 in 2023 and thereafter as adjusted for changes in the cost of living, or (2) the limits on pre-tax contributions established through non-discrimination testing of the Plan.

Participants may also contribute amounts representing distributions from other qualified defined contribution plans. Effective January 1, 2023, the Company provides a matching contribution equal to 50% of the first 6% of employee contributions (not to exceed 3% of eligible earnings).

(c) Participant Accounts

Upon enrollment in the Plan, separate accounts are maintained for each participant. The participant's account is credited with the participant's contributions and allocations of the Company's contributions, and Plan earnings (losses) and charged with an allocation of administrative expenses paid by the Plan. Allocations to participant accounts are based on participant earnings, account balances, or specific

participant transactions as defined. A participant may direct employee and employer contributions in any of the investment options offered by the Plan in increments of 1%.

Participants may change their investment options at any time. As of December 31, 2024, the Plan investment options consisted of seventeen mutual funds, one money market fund, one common trust fund and a variety of target date funds managed by Fidelity Investments. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants also have the option to invest in a BrokerageLink account, which is a brokerage account established through Fidelity as part of the Plan. There is no minimum amount for direct payroll contributions into a BrokerageLink account; however, to open an account, there is an initial investment of \$2,500 and a \$1,000 minimum for each subsequent transfer from a Standard Plan Option. Participants are prohibited from investing in the common stock of FuelCell Energy, Inc.

(d) Vesting

Participants are immediately vested in their own contributions plus actual earnings (losses) thereon. All employer contributions plus actual earnings (losses) thereon become vested based upon the participant's length of service with the Company. Participants vested at the rate of 20% per year of service and were 100% vested after five years of service. The Plan was amended effective May 1, 2023, where participants vest at a rate of 33.3% per year of service and are 100% vested after three years of service. A participant becomes 100% vested at age 65 regardless of the number of years of service. If a participant is terminated prior to the aforementioned years of service, non-vested Company contributions are forfeited and used to reduce the Company's future employer contributions and/or Plan expenses. If termination is the result of death or disability, the participant is deemed 100% vested in all contributions.

(e) Payment of Benefits and Withdrawals

At age 59½ and thereafter, an active employee can withdraw funds from the balance of their account at any time. On termination of service due to death, disability, or retirement, the entire vested balance in the participant's account may be distributed to the participant in a lump-sum payment, rolled over into another qualified plan, or left in the Plan (subject to minimum required balance).

While employed, a participant can withdraw all, or a portion of their previously contributed after-tax account balance, once each Plan Year, without penalty, upon written request and approval by the Plan Administrator. Withdrawals of other than after-tax contributions are only permitted for financial hardship if other sources are not available until the age of 59 ½. No withdrawals of the employer contributions are allowed regardless of financial hardship until the age of 59 ½.

(f) Notes Receivable from Participants

The loan provisions of the Plan allow participants to have up to two loans outstanding at any given time and loan amounts must be a minimum of \$1,000 and a maximum amount of the lesser of \$50,000, reduced by the highest outstanding loan balance in their account during the prior twelve-month period, or 50% of their vested account balance. Loans are repayable with interest at a rate comparable to the rate that would be available from commercial lending institutions under similar circumstances. The

maximum term for all loans, except loans taken out for the purchase of a primary residence, is five years. For loans taken out for the purchase of a primary residence, the maximum term is ten years.

(g) Forfeitures

Forfeitures used to reduce employer contributions during 2024 totaled \$84,152. As of December 31, 2024 and 2023, the forfeitures balance was \$10,200 and \$14,123, respectively.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

(b) Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(c) Contributions

Contributions from Plan participants and matching contributions from the Company are recorded in the year in which the employee contributions are withheld.

(d) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

(e) Payment of Benefits

Benefits are recorded when paid.

(f) Administrative Expenses

The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Expenses incurred in connection with the administration of the Plan that are paid by the Plan are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

(g) Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles (U.S. GAAP) requires the Plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the

reported changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

(h) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(i) Recently Adopted Accounting Guidance

None.

(j) Subsequent Events

The Plan has evaluated subsequent events through September 22, 2025, which is the date the financial statements were available to be issued.

(3) Information Certified by the Trustee

All investment information and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments at fair value at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, and dividends for the year ended December 31, 2024, were obtained from information supplied to the Plan administrator and certified as complete and accurate by the Trustee, in accordance with section 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

(4) Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include:
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability; and

- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common stock: Valued at the closing price reported on the active market on which the individual securities are traded.

Mutual funds: Valued at the quoted net asset value (NAV) of shares held by the Plan at year-end. The mutual funds held by the Plan are deemed to be actively traded.

Money market funds: Valued at NAV. NAV is based on the fair value of underlying investments in the fund. There are no restrictions on redemption and the Plan can redeem on a daily basis.

Common trust fund: Valued at the NAV of units of a bank common trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common trust fund, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Bonds: Valued using pricing models maximizing the use of observable inputs for similar securities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(5) Tax Status

The Plan uses a volume submitter plan designed by Fidelity Management & Research Company. The Internal Revenue Service (IRS) has informed Fidelity Management & Research Company by an advisory letter dated June 30, 2020 that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (the IRC). The Plan itself has not received a determination letter from the IRS. Although the Plan has been amended since receiving the advisory letter, the Plan administrator believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the IRC and, therefore, the Plan and the related trust are tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(6) Party-In-Interest Transactions

Fidelity Management Trust Company, Fidelity Investments Institutional Operations Company, Inc., the Company, and participants receiving Plan loans are parties-in-interest as defined in section 3(14) of ERISA. Certain of the Plan's investments are managed by Fidelity Management Trust Company or its affiliates. Management fees and investment expenses incurred by the Plan are included in net appreciation in fair value of investments. During 2024, expenses paid directly out of Plan assets to the Trustee and its affiliates were \$73,332. During the years ended 2024 and 2023, there were no prohibited party-in-interest transactions.
