## INDEPENDENT AUDITORS' REPORT

To the Administrative Committee of and participants in  
the C&TDG Management, LLC 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of C&TDG Management, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**1. DESCRIPTION OF PLAN**

The following description of the C&TDG Management, LLC 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for complete information.

**General**

The Plan is a defined contribution plan covering substantially all employees of C&TDG Management LLC dba Oak Dental Partners (the Company or the Sponsor), with the exception of union employees and nonresident aliens. All eligible employees of the Company who have completed six months of service and have attained the age of 21 are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Plan Administration**

The Delaware Charter Guarantee and Trust Company, d/b/a Principal Trust Company (Principal) is the trustee of the Plan.

**Contributions**

Eligible employees may make voluntary tax deferred contributions up to 100% of their eligible compensation, subject to a maximum allowable annual contribution determined by the Internal Revenue Code (IRC). Participants may also designate all or a portion of their salary deferral as Roth elective deferrals. Catch-up contributions are permitted. The Plan will accept eligible rollover contributions on behalf of the participant from qualified plans. Participants may direct the investment of their contributions into various investment options offered by the Plan. Under the Automatic Enrollment Contributions arrangement, all employees who have satisfied the eligibility requirements of the Plan and have not made a salary deferral election are automatically enrolled at a 3% salary deferral rate.

The Company may make a discretionary matching contribution or profit-sharing contribution equal to a uniform percentage of participant deferrals, as will be determined at the end of each Plan year. For the year ended December 31, 2024, there were no discretionary matching or profit-sharing contributions made to the Plan. For the year ended December 31, 2024, the Company made a match correction to a group of participants allowed from a previous acquisition.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, the Company's contributions and allocations of Plan earnings. Each participant account is charged with withdrawals and an allocation of Plan losses and administrative expenses. Allocation of the Plan's investment results is based on relative account balances, as defined. Participants may allocate their contributions, at their discretion, among various investment options offered by the Plan.

**Vesting**

Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. Vesting in the Company's discretionary matching and profit-sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service, as defined. Vesting in the Company's discretionary matching and profit-sharing contributions is as follows:

<u>Years of Service</u>	<u>Percentage</u>
0-2	0%
3+	100%

Participants also become fully vested upon death, disability or retirement.

**Payment of Benefits**

A participant's vested account balance may be withdrawn due to death, disability, retirement or termination of employment. In-service withdrawals are permitted after the age of 59 ½ or due to financial hardship, as defined. A participant may elect to receive an amount equal to the value of the participant's vested interest in their account in either a lump-sum payment or in annual installments over a specified period of time. If the vested amount is \$5,000 or less, a lump-sum distribution is required.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The minimum amount that can be borrowed is \$1,000. The loans are secured by the account balance. Repayments of the loans are made in substantially equal payroll deductions amortized over the life of the loan. Interest rates are 1% over prime published by the Wall Street Journal on the first business day of the month the loan originates.

**Forfeitures**

The Plans provide that forfeitures, the unvested portion of employer contributions for terminated participants, will serve to reduce future Company contributions and reduce Plan expenses. The Company used forfeitures totaling \$166 to reduce Plan expenses for the Plan year ended December 31, 2024. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$33,192 and \$28,753, respectively

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Participant-initiated transaction fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

### **Use of Estimates and Risks and Uncertainties**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates. The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect the amounts reported in the financial statements.

### **Notes Receivable from Participants**

Notes receivable from participants represent participant loans which are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value, except for the fixed annuity contract which is valued at contract value. Contract value is the relevant measure for the portion of net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Notes 3 and 4 for valuation methodologies of the Plan's investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the excess contributions to applicable participants subsequent to year-end.

### **Payment of Benefits**

Benefits are recorded when paid.

**3. INVESTMENT CONTRACT WITH INSURANCE COMPANY**

In May 2022, the Plan entered into a contract with Principal Life Insurance Company (PLIC) in which the Plan invests in a fully benefit-responsive fixed account option investment issued by PLICI. Contract value represents contributions made, plus interest at the contract rate, less funds used to pay participants' benefits. The fixed investment contract (the Fixed Account) held by the Plan is fully benefit-responsive; therefore, contract value reporting is required.

The Fixed Account is part of the general account of PLIC and is guaranteed against loss of principal, less all withdrawals, including surrender charges and market value adjustments. The Fixed Account does not permit PLIC to terminate the agreement prior to the scheduled maturity date. Interest is credited daily at an interest rate that will not be less than the Fixed Account's minimum interest rates, per the contract specifications.

The crediting interest rates are set at the beginning of each calendar quarter and are periodically reviewed for adjustment. The guarantees are based on PLIC's ability to meet its financial obligations from the general assets.

**4. FAIR VALUE MEASUREMENT**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price reported by the mutual funds for shares held by the Plan at the end of the year. The mutual funds held by the Plan are deemed to be actively traded.

*Pooled separate accounts (PSAs):* The Plan's interest in these investments is valued at net asset value (NAV) provided by the fund's trustee or custodian as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments held by the respective fund less its liabilities. This practical expedient would not be used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

**6. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by PLIC, a custodian of the plan; therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for investment management services are included as a reduction of the return earned on each account. Fees paid for the investment management and recordkeeping services totaled \$116,469 for the year ended December 31, 2024.

**7. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in all Company contributions.

**8. TAX STATUS**

The Plan has adopted a prototype non-standardized, pre-approved profit sharing plan with CODA sponsored by CCH Incorporated DBA FTWilliam Company. The IRS has determined and informed CCH Incorporated DBA FTWilliam Company by an opinion letter dated June 30, 2020, that the prototype plan is designed in accordance with applicable sections of the IRC. The prototype plan has been amended since receiving the opinion letter; however, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC; therefore, no provision for taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management does not believe that there are any uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
