As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of June 30, 2024 and 2023, and for the year ended June 30, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF THE PLAN

The following description of WestCoast Children's Clinic, Inc. 403(b) Plan (the "Plan") provides only general information. Participants should refer to the plan documents for a more complete description of the Plan's provisions.

General

The Plan, a defined contribution savings plan sponsored by WestCoast Children's Clinic, Inc. (the "Organization" or the "Employer"), pursuant to Section 403(b) and related provisions of the Internal Revenue Code (IRC), was established July 1, 2004, retroactively restated effective July 1, 2010, and amended on December 1, 2022. The Plan is designed to provide participants with a means to defer a portion of their compensation for retirement and to provide benefits in the event of disability, death, termination of employment, military active duty call-up, or financial hardship. The Plan covers all eligible employees of the Organization upon employment and is subject to the provisions of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA).

Effective March 27, 2020, the Plan administratively adopted the provisions of the Coronavirus Aid, Relief, and Economic Security (CARES) Act, related to participant loans and distributions. The Plan was formally amended on July 15, 2022, to formally adopt the provisions of the CARES Act.

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of provisions within SECURE 2.0 vary through 2026. The Organization has until the end of the first Plan year beginning on or after January 1, 2026, to amend the Plan for the changes related to SECURE 2.0. The Plan has not been formally amended to adopt these provisions as of the date the financial statements were available to be issued.

Plan administration

The Organization is the administrator of the Plan, and, as such carries out the duties imposed by ERISA. The Organization has delegated certain responsibilities for the operation and administration of the Plan. Custodial services are provided by Reliance Trust Company (the "Custodian") and The Standard Insurance Company ("The Standard"), the asset custodian of the Guaranteed Interest Account (collectively, the "Custodians"). Record-keeping services are provided by Standard Retirement Services, Inc.

Eligibility

All employees are eligible to make elective deferrals upon hire.

Eligibility (continued)

All employees, except non-resident aliens, interns, or those who work less than 20 hours per week, who have completed one year of service are eligible to receive Employer contributions. In order to share in Employer nonelective contributions, participants must be employed as of the last day of the Plan year, and have completed of 1,000 hours of service during the Plan year. No additional eligibility requirements are necessary to receive discretionary Employer matching contributions.

Participant accounts

Each participant's account is credited with the participant's contributions and rollovers (if any) and allocations of Employer contributions, if any, and Plan earnings, and charged with an allocation of Plan losses, and any administrative expenses not paid directly by the Organization. Allocations of investment earnings are based strictly on the participant's selection of investments and timing of purchase. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant contributions

Participants may elect to contribute through payroll deductions amounts up to 100% of their annual eligible compensation, as defined by the Plan on a tax-deferred or after-tax basis (as Roth contributions), up to a maximum amount allowed by the IRC. Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions. Participants may also contribute pre-tax amounts representing distributions from other qualified employer-sponsored retirement plans (rollovers). Participants direct the investment of all their contributions into various investment options offered by the Plan.

All newly eligible employees, except relief employees and youth advocate fellows, are automatically enrolled to defer 3% of their eligible compensation on a pre-tax basis, unless the participant makes a contrary election.

Employer contributions

The Organization may make discretionary non-elective and matching Employer contributions to qualifying participants, as defined by the Plan. The Organization made discretionary non-elective Employer contributions equal to 8.75% of qualifying participants' eligible compensation, which totaled \$847,088 for the year ended June 30, 2024. No Employer matching contributions were made for the year ended June 30, 2024.

Vesting

Participants are immediately vested in their voluntary contributions and rollovers plus actual earnings thereon.

Employer matching and non-elective contributions plus actual earnings thereon vest according to the following schedule:

Employer contributions are fully vested at the earliest of 5 years of service, attainment of retirement age, or termination of employment due to full and permanent disability or death.

Notes receivable from participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable (or "loan") terms are generally five years or less, but may exceed five years if the purpose of the loan is to purchase a principal residence. The notes receivable are secured by the remaining balance in participants' accounts and bear interest at a rate commensurate with local prevailing rates. Interest rates on loans outstanding ranged from 3.25% to 8.50% for the year ended June 30, 2024, and mature at various dates through May 2032.

Payment of benefits

Distributions and withdrawals are payable upon retirement, termination, disability, or death, being called up to active military duty, and financial hardship. If a participant's account balance is equal to or less than \$5,000 upon termination, the balance is distributed upon employee termination in a lump-sum amount equal to the value of the participant's vested interest in his or her account. If the participant's account balance is greater than \$5,000 upon termination, the participant can consent to either a distribution paid in the form of a lump-sum cash payment, partial payment, installment payment, or annuity contract, unless a direct rollover into another qualified benefit plan is requested or may postpone payment to a later date and remain in the Plan as described in the Plan documents.

Payment of benefits (continued)

Effective December 1, 2022, the age participants were required to attain prior to taking an in-service distribution was lowered from 65 to 59 ½. Upon attaining the age of 59 ½, the participant may, while still employed by the Organization, request a withdrawal from their vested account balance. The Plan also allows participants to obtain a distribution to satisfy any of the following immediate and heavy financial needs: (1) medical expenses; (2) purchase of a principal residence; (3) to prevent eviction from principal residence (4) to pay for education expenses; (5) funeral expenses; or (6) repair damage on principal residence. Qualified reservist distributions are permitted under limited circumstances as outlined in the plan documents.

Forfeitures

Participants' forfeited non-vested accounts can be used to pay Plan expenses or reduce Employer contributions. Forfeited non-vested accounts totaled \$78,710 and \$32,547 as of June 30, 2024 and 2023, respectively. No forfeitures were used to reduce pay Plan expenses or to reduce Employer contributions for the year ended June 30, 2024.

Administrative expenses

Certain administrative expenses of the Plan, including recordkeeping and audit fees, were paid directly by the Organization for the year ended June 30, 2024. Investment fees, which may vary according to the individual funds selected, are paid indirectly out of the assets of the Plan and impact Plan earnings.

Participants may be charged for some or all the costs and expenses of operating the Plan. Such expenses include, but are not limited to investment expenses and costs to process distributions and qualified domestic relations orders. Generally, the Organization pays for any administrative expenses of the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting and financial statement presentation

The financial statements have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Risks and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and changes therein.

Investment valuation and income recognition

The Plan's investments are stated at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (Note 4).

Contract value is the relevant measurement for assets invested in fully benefit-responsive investment contracts because contract value is the amount participants normally receive if they were to initiate permitted transactions under the terms of the Plan (Note 5).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Contributions and contributions receivable

Contributions from participants are recorded based on the date the contributions have been separated from a participant's pay by the Organization, which is the pay date. Employer contributions are recorded in the year they are earned and to coincide with the year in which the Organization records the contribution in its general ledger. The Plan records receivables for contributions based upon the contributions recognized, less amounts received by the Plan as of the last day of the Plan year.

Rollover contributions from participants are recorded based on the date the contributions are received by the Reliance Trust Company.

Notes receivable from participants

Notes receivable from participants are carried and measured at their unpaid balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. No allowance for credit losses has been recorded as of June 30, 2024 or 2023.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

Administrative expenses are recorded when incurred.

Subsequent events

The Plan has evaluated subsequent events through September 2, 2025, the date the financial statements were available to be issued. Plan management is not aware of any subsequent events which would require recognition or disclosure in the financial statements.

3. INFORMATION PREPARED AND CERTIFIED BY THE CUSTODIANS (UNAUDITED)

The plan administrator, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to the Plan's investment information, and related activity, certified by the Custodians, determined to be qualified institutions by the plan administrator, as complete and accurate, except for comparing such information to corresponding information included in the Plan's financial statements and supplemental schedule of assets (held at end of year) ("supplemental schedule"). The Custodians have certified that the following data included in the financial statements and supplemental schedule is complete and accurate:

- Investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of June 30, 2024 and 2023;
- Net appreciation in fair value of investments, dividends and interest income, and interest income on notes receivable from participants reflected on the accompanying statement of changes in net assets available for benefits for the year ended June 30, 2024; and,
- Investments and notes receivable from participants reflected in the supplemental schedule as of June 30, 2024.

4. FAIR VALUE MEASUREMENTS

Accounting standards require that fair value be determined based on the price that would be received for an asset or paid to transfer a liability ("exit price") in the principal or most advantageous market, in an orderly transaction between market participants. Such fair value is a market-based measurement, not an entity-specific measurement. U.S. GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority measurements involving significant unobservable inputs (Level 3 measurements).

The fair value hierarchy consists of three levels of inputs that may be used to measure fair value as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and,
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full-term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at June 30, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported on an open exchange. Mutual funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price.

The preceding method may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. GUARANTEED INTEREST ACCOUNT

The Standard Stable Asset Fund (the "Fund" or "contract") is a guaranteed interest account issued under a group annuity contract with The Standard (the "issuer"). The Fund is a fully benefit-responsive investment contract available to the Plan's participants. Contributions to the Plan under this contract are maintained in The Standard's general account. Contract value represents contributions made, under the contract, plus interest credited, less participant withdrawals and administrative expenses.

The Standard is contractually obligated to pay the principal and specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with The Standard, but generally may not be less than 1%. The crediting rates are 2.94% and 2.51% at June 30, 2024 and 2023, respectively and are reviewed by The Standard on an annual basis for resetting.

The Plan's ability to receive amounts due is dependent on the contract issuer's ability to meet its financial obligations. The contract issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) the Plan's failure to qualify under Section 401(a) of the IRC; (2) amendments to the plan documents (including complete or partial Plan termination or merger with another plan), (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) premature termination of contracts; (5) the failure of the Plan's trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; (6) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions. None of the events that would limit the Plan's ability to transact at contract value with the issuer or with participants of the Plan are probable of occurring.

The contract value of the Fund is \$209,699 and \$124,905 at June 30, 2024 and 2023, respectively.

6. TAX STATUS

The Plan has adopted Standard Retirement Services, Inc. 403(b) Volume Submitter Plan #20. The Internal Revenue Service informed Standard Retirement Services, Inc. by a letter dated March 31, 2017, that its plan is designed in accordance with the applicable sections of the IRC and is appropriate for use by employers for the benefit of their employees. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified and is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

7. PLAN TERMINATION

Although the Organization has not expressed any intent to do so, the Organization has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the full value of each participant's account shall become fully vested and non-forfeitable.

8. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

ERISA defines party-in-interest similar to the definition of a related party under U.S. GAAP, except that ERISA's definition is broader and includes all entities and individuals that provide services to the Plan; however, these entities may not necessarily be related parties. The Plan Sponsor did not identify any related parties to the Plan that were not also considered to be parties-in-interest.

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, and a person who owns 50% or more of such an employer or employee association or relatives of such persons.

8. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS (continued)

Certain fees and expenses of the Plan are paid by the Organization. The Plan is not required to repay expenses paid by the Organization on its behalf. Investment fees, which may vary according to the individual funds selected, are paid indirectly out of the assets of the Plan and impact Plan earnings.

Certain Plan investments are owned and/or managed by the Custodians or their affiliates, therefore, these investment transactions qualify as exempt party-in-interest transactions.

The Custodians retain, as compensation for services provided to the Plan, any interest on amounts earned while certain transactions are pending. This applies to both contributions and distributions. Earnings are at institutional money market rates.
