INDEPENDENT AUDITOR'S REPORT

To the Plan Sponsor
Operation Dental, LLC Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Operation Dental, LLC Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Operation Dental, LLC Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We



are required to be independent of Operation Dental, LLC Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Operation Dental, LLC Retirement Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.



NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024

NOTE 1 - DESCRIPTION OF PLAN

The following description of Operation Dental, LLC Retirement Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions. The plan administrator and trustee are responsible for the oversight of the Plan.

General

The plan began January 1, 2021 and is a defined contribution plan, qualified under Section 401 of the Internal Revenue Code (“IRC” or the “Code”) and subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Eligible employees must be full-time employees for at least one year for one of the following participating affiliated companies defined as the controlled group:

The controlled group listed above excludes affiliates that have no participation. The Plan excludes union and nonresident aliens from participation. The Plan is subject to the provisions of Section 401(k) of the Code whereby the participants' discretionary contributions would not be reportable as compensation for federal and state income tax purposes.

Contributions

Subject to certain limitations, under the Internal Revenue Code (“IRC”) Section 401(k), participants may contribute up to 60% of their annual compensation, subject to 2024 annual limits of \$23,000 and an additional \$7,500 for catch-up contributions for participants that are age 50 or older. Participants may also rollover amounts representing distributions from other qualified retirement plans. Participants may also contribute amounts representing distributions from other qualified retirement plans. Automatic deferrals are withheld at a rate of 3% of eligible compensation for that pay period.

The Company shall make a safe harbor nonelective contribution to the Plan for each eligible participant at a rate of 4% of the participant's eligible compensation. For the year ended December 31, 2024 and 2023, the Company made safe harbor nonelective contributions of \$166,148 and \$165,970, respectively. The Company may also make an additional annual discretionary contribution to the Plan. During the year ended December 31, 2024, the Company did not make any discretionary contributions.

Investment Options

The participants direct the investment of their account balance and may select from various investment options maintained by Capital Bank and Trust Company (“Capital”), the custodian of the Plan. Participants may change their investment option selections on any business day, as defined by the Plan.

Vesting

Participants are always 100% immediately vested in their elective deferral account, rollover contribution account, qualified non-elective contribution account and safe harbor matching contribution account. Profit sharing, non-elective employer contributions and earnings vest based on a six-year graded schedule as follows:

Participant Accounts

Plan participants are offered a choice of various investment options and allowed to change their investment options daily. Each participant’s account is credited and/or reduced by the participant’s elective deferral contributions and distributions, the Company’s contributions, and an allocation of the Plan’s investment earnings/losses and investment fees and any administrative expenses paid out of the Plan. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided by the participant’s vested account balance.

Payment of Benefits

All of a participant’s vested balance is payable upon the participant’s normal retirement (at 65 years), at age 59 1/2, termination of employment, total and permanent disability or death, and financial hardship, subject to certain limitations. Participants may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or various installment and annuity options as provided by the Plan.

Forfeited Accounts

Forfeitures may arise from the correction of employer contribution errors or refunds of excess employer contributions. There were \$14,501 of forfeitures during 2024 and \$2,366 of forfeited non-vested accounts as of December 31, 2024. \$12,174 of forfeitures were used to pay plan expenses during the year. There were no forfeited accounts during 2023 and no non-vested accounts as of December 31, 2023.

Recently Adopted Accounting Standards

Effective January 1, 2023, the Plan adopted accounting standards update (ASU) 2016-13, Financial Instruments - Credit Losses (Topic 326): Measurement of Credit Losses on Financial Instruments (FASB ASC 326), which significantly changed how entities measure credit losses for most financial assets. The most significant change in the standard is a shift from the incurred loss methodology to an expected loss methodology. Financial assets held by the Plan that are subject to the guidance in FASB ASC 326 were employer contributions receivable. There was no material impact to the financial statements as a result of the adoption of ASU 2016-13.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following is a summary of significant accounting policies followed in the preparation of these financial statements, which have been prepared in accordance with accounting principles generally accepted in the United States of America.

Basis of Presentation

The financial statements of the Plan are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

All investments are stated at their fair values. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment Valuation and Income Recognition (*Continued*)

The underlying securities in each mutual fund account are listed on national securities exchanges and valued on the basis of year-end closing prices. Securities traded in the over-the-counter market are valued at the closing price on the last business day of the year. Gains or losses on securities sold are based on average cost. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Plan Expenses

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Investment-related expenses are included in net (depreciation)/appreciation of fair value of investments. Incurred and paid plan expenses for the year ended December 31, 2024 totaled \$1,375 ((Note 1) excluding forfeiture activity).

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

Plan management has evaluated subsequent events and transactions that occurred after December 31, 2024 up to the date that the financial statements were available to be issued.

NOTE 3 – CERTIFICATION OF INVESTMENT INFORMATION

Capital Bank and Trust Company, the custodian of the Plan, has supplied the plan administrator with certifications as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, Fair Value Measurements and Disclosures, are described as follows:

- Level 1: Quoted market prices in active markets for identical assets or liabilities.
- Level 2: Observable market-based inputs or unobservable inputs that are corroborated by market data.

Level 3: Unobservable inputs that are not corroborated by market data.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Mutual Funds: Valued using the net asset value ("NAV") of units, which are based on observable market prices for the underlying assets, held by the Plan at year end. The NAV is used as a practical expedient to estimate fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values.

Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement.

Mutual Funds described above are deemed to be Level 1 investments and are measured at fair value on a recurring basis.

NOTE 5 - TAX STATUS

The Plan adopted a volume submitter plan which has received an opinion letter from the Internal Revenue Service ("IRS") dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the IRC. The Plan has not requested a determination letter from the IRS stating that the Plan is qualified under Section 401(a) of the IRC. The plan administrator believes that the adopted and amended Plan continues to qualify and will remain exempt from federal income taxes under Section 401(a). As of December 31, 2024, with certain exceptions, the Plan is no longer subject to income tax examinations by U.S. federal taxing authorities for any tax years before 2023.

NOTE 6 - PLAN TERMINATION

The plan sponsor intends to continue the Plan indefinitely for the benefit of its employees, but reserves the right to modify, amend, or terminate the Plan at any time by resolution of its Board of Directors. In the event of termination of the Plan, all amounts credited to participants' accounts shall be 100 percent vested and non-forfeitable. All participants shall receive a total distribution of their accounts as described in the Plan.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 – PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer, and certain others. The Plan holds investments managed by Capital, the Plan custodian, which qualify as party-in-interest investments. The Plan's payments of custodian fees to Capital and audit fees qualify as party-in-interest transactions.

Capital provide certain administrative services to the Plan pursuant to a Master Plan Services Agreement ("MSA") between the Company and the custodian. The custodian receives revenue from providers for services provided to the funds. This revenue is used to offset certain amounts owed to the custodian for its administrative services to the Plan.

Capital serves as a custodian and directed trustee for employer-sponsored retirement plans and individual retirement accounts invested in American Funds.

If the revenue received by Capital from such fund service providers exceeds the amount owed under the MSA, Capital remits the excess to the Plan's trust. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024, there were no excess amounts. The Plan or Company may make a payment to Capital for administrative expenses not covered by revenue sharing.
