NOTES TO FINANCIAL STATEMENTS

**Note 1 - Plan Description:**

The following brief description of Credit Bureau Systems, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document and Summary Plan Description for more complete information.

**General**

The Plan, which was adopted on January 1, 1994, by Credit Bureau Systems, Inc. (the Company or Plan Sponsor) and amended and restated effective January 1, 2020, is a defined contribution Plan covering all full-time employees of the Company who are age 21 or older and have six months of service. The Plan is subject to the Employee Retirement Income Security Act of 1974, as amended (ERISA). American United Life Insurance Company (AUL) is the trustee of the Plan. Benefit Plans Plus, LLC is the record-keeper for the Plan.

**Contributions**

For the year ended December 31, 2024, participants may contribute up to 100 percent of pre-tax annual compensation, as defined in the Plan, up to an annual maximum of \$23,000, per Internal Revenue Service (“IRS”) regulations. The total of participant and employer contributions for a given year cannot exceed the lesser of \$69,000 or 100 percent of the employee’s annual compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of up to \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

Each year the Company may make a discretionary matching contribution and a discretionary profit-sharing contribution to be determined annually based on a percentage of each participant’s eligible compensation for the year. There were no discretionary profit-sharing contributions made for the year ended December 31, 2024.

**Participant Accounts**

Each participant’s account is credited with the participant’s contributions, the Company’s matching and profit-sharing contributions, and an allocation of Plan earnings net of any Plan expenses. Allocations are based on participant account balances and current contributions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts is based on years of continuous service. A participant is 100 percent vested after six years of credited service, based upon a graduating schedule. A participant is vested 20 percent after two years and 20 percent for each additional year of service.

**Forfeitures**

Participants who terminate their employment and are less than 100 percent vested in their employer account will forfeit the non-vested portion. Forfeitures will be used to reduce future employer contributions. During 2024, employer contributions were reduced by \$6,499 from forfeited non-vested accounts. Forfeited non-vested accounts totaled \$0 at December 31, 2024 and 2023.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their employer contributions.

**Note 1 - Plan Description (Continued):**

**Notes Receivable from Participants**

Participants may borrow from their account balances in the Plan in accordance with the loan policy statement. The maximum number of loans which a participant may have outstanding at any one time is two. Loan amounts can range from a minimum of \$1,000 to an aggregate maximum of the lesser of \$50,000 or 50 percent of participant's vested balance. The loans are secured by the balance in the participant's account. Loans must be repaid within five years, with the exception of real estate loans, which may be extended beyond five years. The interest rate on loans reflects a rate based on the prime rate published in the Wall Street Journal on the first business day of each month plus 1 percent at the time of loan origination. Principal and interest are paid ratably through payroll deductions.

**Notes Receivable from Participants - Defaulted**

Defaulted loans are loans resulting from the failure of a participant to make the required loan repayment on an outstanding loan. These loans are considered a distribution to the participant for which a Federal 1099 tax form is issued. For 2024, defaulted loans totaled \$10,211.

**Payment of Benefits**

The Plan provides for normal retirement to begin when the participant reaches the age of 65. A participant will be fully vested and may retire prior to normal retirement. Upon death or disability of a participant, while employed, the account balance becomes fully vested. In-service withdrawals are allowed on attainment of age 59 ½, provided the participant is fully vested.

On termination of service, participants may elect to receive a lump sum equal to the value of their vested account balance, as described under the Plan Document. As an alternative to a cash distribution, the participant may have the payment paid as a "direct rollover" to an IRA or another qualified plan. However, if a participant's account balance does not exceed \$1,000, it will be paid in one lump-sum cash payment. Participants may also withdraw their elective contributions in the case of financial hardship under guidelines promulgated by the Internal Revenue Service (IRS).

**Investment Options**

Upon enrollment in the Plan, a participant may direct employer and participant contributions to any of the applicable investment options available to Plan participants.

**Note 2 - Summary of Significant Accounting Policies:**

**Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts.

**Basis of Accounting (Continued)**

Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

**Valuation of Investments and Income Recognition**

Investments are in units of pooled separate accounts or in a guaranteed investment contract of American United Life Insurance Company, a party-in-interest to the Plan. The Plan's investments are stated at fair value based on the unit values of the pooled separate accounts based on the fair value of the underlying investments as reported by AUL. The pooled separate account options include various mutual funds offered by registered investment companies. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year end. The AUL Stable Value account is a guaranteed investment contract and is a fully benefit-responsive investment. The fair value of the guaranteed investment contract is equal to the contract value because it is not tradable or assignable and there are no defined maturities of the cash flows.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**Notes Receivable from Participants**

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related participant loan maintenance fees are recorded as administrative expenses when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced, and a benefit payment is recorded.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Payment of Benefits**

Payments are recorded when paid.

**Note 3 - Information Prepared and Certified by Trustee:**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by AUL (the trustee of the Plan).

**Note 4 - Fair Value Measurements:**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts:* Valued based on quoted market prices of the underlying net asset values of the investments in mutual funds as reported to the Plan by AUL.

*Mutual funds:* The fair value of mutual funds is based on quoted net asset values (NAV) of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

*Money market fund:* Valued based on fair market value; this fund is based on cash held at year-end.

**Note 5 - Investment Contract:**

The Plan has a fully benefit-responsive guaranteed investment contract with AUL. AUL maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the Statement of Net Assets Available for Benefits at contract value. Contract value, as reported to the Plan by AUL, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$353,869 and \$304,208, respectively. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 0.0 percent. Such interest rates are reviewed on an annual basis for resetting.

Certain events limit the Plan's ability to transact at contract value with AUL. Such events include the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**Note 6 - Risks and Uncertainties:**

Participant accounts are invested in various investment securities. Investment securities are exposed to various risks such as interest rates, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the accounts reported in the Statements of Net Assets Available for Benefits.

**Note 7 - Income Tax Status:**

The IRS has determined and informed AUL, the trustee, by a letter dated January 1, 2018, that the volume submitter profit-sharing plan with CODA as amended through that date is in a form acceptable under section 401 of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRS.

The Plan and related trust are designed to be a qualified trust under Section 401(a) of the IRC, which provides that a qualified trust is exempt from federal income taxes. The Plan is required to operate in accordance with the Plan Document and the applicable federal laws in order to maintain its qualification. The Company is not aware of any action or event that has occurred that might affect the Plan's qualified status.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**Note 8 - Related-Party Transactions:**

Plan investments consist of pooled separate accounts managed by AUL. AUL is also the custodian and trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Certain administrative costs incurred by the Plan are paid by the Company. The total costs paid by the Company were \$9,700 for the period ended December 31, 2024.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
