Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of AstenJohnson Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, are complete and accurate.

Opinion

1. DESCRIPTION OF PLAN

The following description of the AstenJohnson Retirement Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Document and Summary Plan Description for more complete information.

General—The Plan is a defined contribution plan covering substantially all employees of AstenJohnson, Inc. (the “Company”) who have attained age 18 and have completed 90 days of qualified service. The Retirement Committee of the Company controls and manages the operation and administration of the Plan. Fidelity Management Trust Company (“Fidelity”) serves as the trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions—Each year, participants may contribute between 1% and 75% of their pretax or after tax eligible annual compensation, limited to \$23,000 for 2024 and \$22,500 for 2023. Participants who are age 50 or older by the end of the calendar year may make an additional catch up contribution up to \$7,500 for 2024 and 2023. Eligible compensation is defined as most salaries and wages, including overtime, bonuses and commissions, and excluding severance, reimbursements, moving expenses, fringe benefits and deferred compensation. Eligible compensation is limited to \$345,000 and \$330,000 for years 2024 and 2023, respectively. Contributions are subject to certain other Internal Revenue Code (“IRC”) limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Plan allows for safe harbor employer contributions, except for bargaining unit employees. The safe harbor match is equal to \$1.00 for each \$1.00 by which such participant defers their compensation in amounts up to 6% including catch-up contributions. Safe harbor employer contributions are 100% vested for participants. During 2024 and 2023, the Company matched 100% of the first six percent of compensation that a non-union and non-per diem participant contributes to the Plan.

The Company contributes amounts to union participants according to their respective collective bargaining unit agreements. Additional amounts may be contributed at the discretion of the Company’s Board of Directors. No additional amounts were contributed during 2024 and 2023.

Participant Accounts—Individual accounts are maintained for each plan participant. Each participant’s account is credited with the participant’s contribution, the Company’s contributions, and an allocation of plan earnings, and charged with withdrawals and allocations of plan losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investments—Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers mutual funds and common collection trust funds as investment options for participants.

Vesting—Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their account, and actual earnings thereon, is based on years of continuous service. A participant is 100 percent vested after three years of credited service or upon death or attainment of the normal, early, or disability retirement date. Forfeitures in the Plan are used to offset future employer contributions.

Forfeitures— At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$63,558 and \$45,037, respectively. These accounts may be used to reduce plan administrative expenses and fund additional employer contributions. During the year \$1,367 was used to reduce employer contributions.

1. DESCRIPTION OF THE PLAN (CONTINUED)

Notes Receivable from Participants—Participants may borrow from their fund accounts up to a maximum of \$50,000 or 50 percent of their account balances, whichever is less. The source of the loaned funds is restricted to the portion of the account balance related to participant deferrals. The loans are secured by the balance in the participant’s account and bear interest at rates commensurate with local prevailing rates as determined appropriate by the Plan administrator. Principal and interest is paid ratably through bi-weekly (for hourly participants) or monthly/semi-monthly (for salaried participants) payroll deductions. Participants may only have one loan outstanding at a time.

Payment of Benefit and Withdrawals—On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account, or annual installments as provided in the Plan document. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting—The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of Estimates—The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment, Valuation and Income Recognition—The Plan’s investments in mutual funds are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a increase in net depreciation in fair market value of investments for such investments.

Contributions - Contributions from Plan participants and Employer matching contributions are recorded in the year in which the employee contributions are withheld.

Notes Receivable from Participants —Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses have been recorded as of December 31, 2024 and 2023.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Payment of Benefits—Benefits are recorded when paid.

Administrative Expenses—Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events—The Plan has evaluated subsequent events through the August 30, 2025, the date the financial statements were available to be issued.

Revenue Sharing—In accordance with Financial Accounting Standards Board (FASB) ASC No.606, Revenue from Contracts with Customers revenue sharing amounts are not considered revenue under ASC No. 606 due to the fact that they are intended to reduce administrative costs for the plan and not paid to the plan for delivering or producing goods, rendering services or undertaking other activities for the investment manager. The adoption did not have a material impact to the Plan’s financial statements.

3. INVESTMENT INFORMATION CERTIFIED BY TRUSTEE

As permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA, and as instructed by the Plan administrator, no audit procedures have been performed on certain information certified as complete and accurate by the Fidelity Management Trust Company, (“the Trustee”), except to compare such information to the information included in the accompanying financial statements and supplemental schedule. Information certified by the Trustee includes investments and notes receivable from participants included in the Statements of Net Assets Available for Benefits at December 31, 2024 and 2023, investment related income and interest on notes receivable from participants as included in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and investments included in the Schedule of Assets (Held at End of Year).

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1- Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2-Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by the observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

4. FAIR VALUE MEASUREMENTS (CONTINUED)

Level 3-Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Fair value measurements are classified within the valuation hierarchy based on the lowest level of any input that is significant to the fair value measurement.

The valuation methodology for the Plan’s assets are as follows at December 31, 2024 and 2023:

Mutual Funds – Mutual funds are registered investment companies that pool the funds of multiple investors into a portfolio. The fund offers shares of the portfolio, which an investor may redeem for current value (NAV, or net asset value) of the fund’s assets through a public market.

Common collective trust funds: The value of a fund unit will be based on the net asset value as a practical expedient (“NAV”) per unit of each of the portfolios in which assets of a fund are invested. The NAV per unit is determined by the portfolio and equals the total value of its assets, less its liabilities, divided by the number of its outstanding units. Units are only valued as of the close of regular trading on the New York Stock Exchange (“NYSE”) each day the exchange is open for trading.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

* The Plan invests in common/collective trust funds which trade at the net asset value (NAV) per share as a practical expedient of the fund. These funds are not categorized within the fair value hierarchy.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

6. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by an affiliate of the Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Fees totaling \$35,000 were returned for recordkeeping for the Plan year ended December 31, 2024. Fees totaling \$26,726 were returned for recordkeeping for the Plan year ended December 31, 2023. In addition, the Trustees maintain a special ERISA account funded with 12b-1 fees plus earnings. The account is to be used to pay for Plan expenses. The ending balance of the accounts were \$207,592 and \$249,768 as of December 31, 2024 and 2023, respectively.

7. PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100 percent vested in their accounts.

8. INCOME TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated March 11, 2016, that the Plan and related trust were designed in accordance with the applicable regulations of the IRC. Although, the Plan has been amended since receiving the determination letter; the Company and the Plan administrator believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC and the Plan and related trust continue to be tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be substantiated upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. RISKS AND UNCERTANTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as an international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

10. PLAN AMENDMENTS

On March 6, 2024, the Plan was amended, retroactively effective March 1, 2023 to include hourly employees at Appleton, Wisconsin location who are covered by collective bargaining agreement, allowing them to make Roth Contributions.
