Basis for Opinion

NOTE 1 - DESCRIPTION OF PLAN

The following description of the RPM Employers 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan with an original effective date of January 1, 1993. The Plan covers all eligible employees at RPM Warehouse, Inc. and RPM Warehouse SC LLC. In 2019 RPM Warehouse, Inc. was reorganized to form RPM Group, Inc. which adopted the Plan. The Plan is available to employees who are twenty-one years of age or older. Employees are eligible to participate after one year of service with at least 1,000 hours of service completed, on the first day of the first or seventh month of the Plan Year. Ineligible employees include those under a collective bargaining agreement, union employees, leased employees, and non-resident aliens.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers a discretionary employer match. In order to share in the allocation of matching contributions, a participant is required to be employed by the Company on the last day of the Plan year or complete 1,000 hours. In both 2024 and 2023 employer matching contributions were \$0. Contributions are subject to IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution, including any roll over balances, Company matching contributions, profit sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, including rollover contributions, plus actual earnings thereon. Employer matching contributions and profit sharing contributions require a participant to be vested. Vesting is based on the Plan year and each year requires a minimum of 1,000 hours of service to be qualified. Vesting is based on a 2 - 6 year graded model. Upon death or permanent disability a participant becomes fully vested.

Notes Receivable Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. Interest shall be charged at a rate to be fixed by the Plan Administrator. Principal and interest are paid through bi-weekly payroll deductions. The maximum term for a loan is five years unless the funds are to be used for the purchase of a residence.

NOTE 1 - DESCRIPTION OF PLAN (Continued)

Payment of Benefits

On termination of service due to disability, retirement or other reasons, a participant may receive a lump sum amount equal to the value of the participant's vested interest in his or her account. On termination of service due to death, a participant's beneficiary may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account or annual installments.

Required Minimum Distributions - A participant's benefits must begin to be distributed no later than April 1 of the calendar year following the later of the calendar year in which the participant attains age 73 (age 72 if the participant reached 72 before January 1, 2023) or the calendar year in which the participant retires. However, if the participant is a 5% owner at any time during the plan year ending in the calendar year in which the participant attains the applicable age, distributions must commence no later than April 1 of the calendar year following the year the participant attains that age, regardless of retirement status.

Forfeited Accounts

Forfeitures may be used in any permissible method, such as to reduce Company contributions, or to pay Plan expenses. These amounts remained segregated from participant funds in a separate forfeiture account. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$4,472 and \$9,234, respectively.

Hardship withdrawals

The Plan allows for hardship withdrawals from participant funds derived from participant contributions, roll over contributions and employer match contributions. Hardship withdrawals may be made by the participant of the Plan or a participant beneficiary, and must be taken in an amount equal to or greater than \$1,000.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared in accordance with Generally Accepted Accounting Principles in the United States of America ("US GAAP"), which uses the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fixed contract account, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Exchange Traded Funds and Mutual Funds

The value of each separate account is determined at the close of each business day based on market value. The value of the account is expressed in units. Contributions to the account increase the number of units; withdrawals decrease the number of units. The unit value is the dollar value of one unit and is determined at the close of each business day by dividing the value of the entire account by the total number of units in the account. The value of a participant's account on any date is determined by multiplying the number of units held by the unit value at the close of the business day. Redemptions can be made daily.

Financial Instruments - Credit Losses

In June 2016, FASS issued Financial Instruments - Credit Losses (Topic 326): Measurement of Credit Losses on Financial Instruments. ASU 2016-13 significantly changes the impairment model for most financial assets and certain other instruments. ASU 2016-13 will require immediate recognition of estimated credit losses expected to occur over the remaining life of many financial assets, which will generally result in earlier recognition of allowances for credit losses on loans and other financial instruments. ASU 2016-13 is effective for the Plan's fiscal year beginning January 1, 2023 and subsequent interim periods.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses was needed for the plan as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Risks and Uncertainties

The Plan invests in various investments. Investments are exposed to various risks, such as interest rate, market and credit risks.

Risks and Uncertainties (Continued)

Due to the level of risk associated with certain investment securities, and the level of uncertainty related to changes in the value of mutual funds, it is at least reasonably possible that changes in values of mutual funds will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Subsequent Events

Subsequent events have been evaluated through the date of the report, the date the financial statements were available to be issued.

NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820, are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Exchange Traded Funds: Valued at the daily closing price as reported by the fund. Exchange traded funds held by the Plan are open-ended funds that are registered with the Securities Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and transact at that price. The exchange traded funds held by the Plan are deemed to be actively traded.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities Exchange Commission. These funds are required to publish their daily NAV and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 5 - GROUP ANNUITY CONTRACT WITH VOYA

The Plan maintains two traditional fully benefit-responsive guaranteed investment contracts with Voya totaling \$1,061,818 and \$1,273,463 at December 31, 2024 and 2023, respectively. Voya maintains the contributions in two general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contracts issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.00%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its contractual obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibition exemption under ERISA, (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 7 - TAX STATUS

On March 30, 2012, the IRS stated that the prototype adopted by the Plan, as then designed, qualifies under Internal Revenue Code 401. The Plan has not received a determination letter specific to the Plan itself; however, the Plan Administrator and the Plan's tax counsel believe the Plan was designed and was operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 - RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

RPM Group, Inc. is the plan sponsor of the Plan. Certain Plan investments are managed by Voya Financial. Voya Financial is the custodian and recordkeeper for the Plan. Cg Tax, Audit and Advisory, is the auditor of the Plan for the years ended December 31, 2024 and 2023. These transactions qualify as party in interest transactions.

During 2024 and 2023, Voya Financial provided certain administrative services to the Plan pursuant to a Master Plan Services Agreement (MSA) between the Company and Voya Financial. Voya Financial receives revenue from mutual fund service providers for services Voya Financial provides to the funds. This revenue is used to offset certain amounts owed to Voya Financial for its administrative services to the Plan.

If the revenue received by Voya Financial from such mutual fund service providers exceeds the amount owed under the MSA, Voya Financial remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024 and 2023, there were no excess amounts. The Plan or Plan Sponsor may make a payment to Voya Financial for administrative expenses not covered by revenue sharing.
