## REPORT OF INDEPENDENT AUDITORS

To the Plan Administrator and Trustees of the  
Section 403(b) Retirement Plan for Mountain Comprehensive Health Corporation  
Whitesburg, Kentucky

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Section 403(b) Retirement Plan for Mountain Comprehensive Health Corporation (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion on the Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### Basis of Accounting

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements and supplemental schedule is prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

### Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the modified cash basis of accounting described in Note 2; this includes determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. #### 1. DESCRIPTION OF PLAN

The following description of Section 403(b) Retirement Plan for Mountain Comprehensive Health Corporation (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### General

The Plan is a defined contribution plan that includes salary deferral features of Section 403(b) of the Internal Revenue Code. The Plan is intended to meet the requirements of a qualified plan under Section 403(b) of the Internal Revenue Code (IRC). The Plan provides for retirement benefits and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended.

All employees of Mountain Comprehensive Health Corporation ("Employer") who do not regularly work less than 20 hours per week and are not considered an intern may elect to participate in the Plan. Participants must also have been employed for at least two years in order to be eligible to receive an Employer match.

##### Contributions

The Plan permits eligible employees through a salary reduction deferral election to make annual contributions of up to 100% of eligible compensation. An Employer matching contribution is paid based on employees' years of service and is not to exceed a scheduled amount as outlined below:

<u>Years of Service</u>	<u>Maximum Matching Amount</u>
3 – 4	\$2,000
5 – 9	\$3,000
10 – 14	\$4,000
15 – 19	\$5,000
20 – 24	\$6,000
25 or more	\$12,500

##### Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Employer's matching contributions and allocations of Plan earnings. Allocations are based on participants' earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. Participants can direct investments in their account into several investment options and are allowed to change investment selections on a daily basis.

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loan term may not exceed five years unless such loan is for the purpose of the participant's primary residence. The loans are secured by the balance in the participant's account and bear interest at a fixed rate of prime rate plus 1%. Principal and interest are paid through manual payments to the custodians of the Plan. If the sum of the payments in the quarter is not received when due, and payment is not received by the end of the following calendar quarter pursuant to IRC rules and regulations, the loan is considered to be in default and the entire outstanding balance plus accrued interest but unpaid interest, shall be deemed distributed and will be reported as a taxable distribution. The maximum number of loans a participant can have at one time is two.

#### Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may receive a lump sum, annuity, or installment amount equal to the value of the participant's vested account balance. Participants may also receive in-service withdrawals upon attaining age 59½, incurring disability or in case of hardship.

#### Vesting

Participants are vested immediately in their contributions and the Employer's matching contributions plus actual earnings thereon.

#### Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### Basis of Accounting

The accompanying financial statements of the Plan are prepared on the modified cash basis of accounting. As such, contributions are recorded when received and benefits and expenses are recorded when paid. The modified cash basis differs from the cash basis in that investments are recorded at fair value and notes receivable from participants are recorded as receivables (reductions) when the amounts have been advanced to (repaid from) the participant.

Although the modified cash basis of accounting represents a departure from accounting principles generally accepted in the United States of America, it is an allowable method of accounting for employee benefit plans under the reporting requirements of ERISA.

#### Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers, custodian, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a settlement-date basis. Interest income is recorded on the cash basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

#### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are recorded as a distribution based upon the terms of the Plan document.

#### Payment of Benefits

Benefits are recorded when paid.

#### Risks and Uncertainties

The Plan invests in various securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in future financial statements.

#### Administrative Expenses

Administrative expenses may be paid by the Employer or the Plan, at the Employer's discretion.

#### Subsequent Events

The Plan has evaluated events or transactions occurring subsequent to the statement of net assets available for benefits date for recognition and disclosure in the accompanying financial statements through the date the financial statements are available to be issued, which is September 23, 2025.

### **3. INVESTMENTS CERTIFIED BY THE PLAN'S CUSTODIANS**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, State Street Bank and Trust Company (State Street) and Transamerica Financial Life Insurance Company, Inc. (TFLIC), the custodians of the Plan, have certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits and the schedule of assets (held at end of year) as of December 31, 2024 and 2023 and the related investment income reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

### **4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- *Mutual funds*: Valued at the daily closing price as reported by the fund. Mutual funds are held by the Plan and are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.
- *Unallocated insurance contract*: Investment contracts are valued at fair value by TFLIC by discounting the cash flows of the guaranteed interest account using a discount rate that represents the interest rate that would be credited on accounts of similar duration. Reasonableness of the methodology is evaluated through a variety of factors including review of existing contracts, economic conditions, industry and market development, and overall credit ratings.

#### 5. INCOME TAX STATUS

The Plan has adopted a volume submitter plan sponsored by Transamerica Retirement Solutions, LLC, which has received an opinion letter from the Internal Revenue Service (IRS) dated March 31, 2017 stating that the form of the volume submitter plan document, as than designed, was in compliance with applicable requirements of the internal revenue code (IRC). The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believes that the plan is qualified.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require disclosure in the accompanying financial statements. The Plan is subject to routine audits by taxing jurisdictions; However, there are currently no audits for any tax periods in progress.

#### 6. PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer and certain others. The Employer provides certain accounting, recordkeeping, and administrative services to the Plan for which it is not compensated.

TLFIC and State Street are the custodians and Transamerica Retirement Solutions is the third party administrator and receive payment from the Plan. Meridian Wealth Management is the investment advisor and receives payment from the Plan. Blue & Co., LLC is the independent auditor of the Plan and receives payment from the Employer for these services.
