Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Franklin Institute Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Franklin Institute Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Franklin Institute Retirement Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Franklin Institute Retirement Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

(1) THE PLAN

The following description of The Franklin Institute Retirement Savings Plan (“*Plan*”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan covering eligible employees of The Franklin Institute (“*Institute*”) who have completed two consecutive months of service and attained the age of 18. Participation in the Plan commenced on April 1, 2007. Eligible employees must achieve 1,000 hours of service in the first 12 months of employment in order to qualify for the company matching contribution and the 2% non-elective employer contribution. If eligibility was not achieved in the first 12 months of employment, eligibility is attained by achieving 1,000 hours of service in any following Plan year. The Plan is a qualified 401(k) Plan subject to the provisions of the Employer Retirement Income Security Act of 1974 (“*ERISA*”).

Contributions – Participants may contribute pre-tax and post-tax annual compensation as defined in the Plan document subject to Internal Revenue Service (“*IRS*”) statutory limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

All participants will receive a 2% non-elective employer contribution based on eligible compensation upon meeting certain service milestones. In addition, the Institute will match 100% of an employee’s contribution up to 5% of his or her eligible compensation when the service milestones have been met.

Participant Accounts – Participants direct the investment of their account balances into various investment options offered by the Plan and may change their investment options at any time subject to the terms of the funding vehicles. Each participant’s account is credited with the participant’s contributions and allocations of (1) the Institute’s contribution, and (2) investment earnings. Participants’ accounts are charged with investment losses and expenses, as applicable. Allocations are based on participants’ earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

Vesting – Participants are immediately vested in their voluntary contributions and any rollover contributions, as applicable. Vesting in the employer matching contributions is 100% and occurs immediately upon meeting employer match service milestones and vesting in the 2% non-elective contribution is 100% after three years of eligible service. Upon termination of service, if the participant’s vested benefit is not more than \$5,000, payment will be in a lump sum. Forfeitures of participant non-vested balances of employer discretionary contributions or employer matching contributions reduce those contributions, respectively, for the Plan year in which those forfeitures arise.

Forfeited Accounts – When certain terminations of participation of the Plan occur, the non-vested portion of a participant’s account represents a forfeiture. Forfeitures are used to reduce employer contributions and expenses in accordance with the Plan provisions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$5,312 and \$2,125, respectively. During 2024, no forfeited nonvested accounts were used to reduce contributions. Forfeitures used to pay administrative expenses of the Plan totaled \$4,600 during 2024.

NOTES TO FINANCIAL STATEMENTS – (Continued)

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. No more than one loan to a participant may be outstanding at any time. Loan terms may extend to a period not to exceed five years, or for a reasonable period of time over five years for the purchase of a principal residence. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. Interest rates for loans outstanding at December 31, 2024 4.25% to 9.50%.

Payment of Benefits – A participant is eligible to receive the vested interest in his or her account on retirement, disability or death. A participant's beneficiary or estate will receive the distribution in the event of the participant's death. The normal form of benefit payment is a single lump-sum cash payment. The Plan also provides for in-service withdrawals for hardship reasons and for participants who have attained the age of 59-1/2. Minimum required distribution for participants who have reached age 70-1/2 also apply per IRS regulations.

(2) SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING

The financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America on the accrual basis of accounting.

USE OF ESTIMATES

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

INVESTMENT VALUATION AND INCOME RECOGNITION

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the Plan's Trustee and Custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net investment income includes the Plan's realized and unrealized gains and losses on investments bought and sold, as well as held during the year.

NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant's loan to be in default, the participant's loan balance is reduced, and a benefit payment is recorded.

PAYMENT OF BENEFITS

Benefits are recorded when paid.

ADMINISTRATIVE EXPENSES

Certain administrative expenses of the Plan are paid by the Institute.

(3) PLAN TERMINATION

Although it has not expressed any intent to do so, the Institute has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination, all amounts credited to participants' accounts will continue to be 100% vested.

(4) INFORMATION CERTIFIED BY TRUSTEE

The Plan Sponsor has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus Trust Company, the Trustee of the Plan, has certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment income and interest earned on loans to participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, Line 4i - schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent accountants did not perform auditing procedures with respect to information certified by the Trustee, except for comparing such information to the related information included in the financial statements and supplemental schedule.

(5) FAIR VALUE MEASUREMENTS

The Plan utilized various methods to measure the year-end value of its investments on a recurring basis. Generally accepted accounting principles establish a hierarchy that prioritizes inputs to valuation methods. The three levels of inputs are described below:

- Level 1 – Unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.
- Level 2 – Observable inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly or indirectly. These inputs may include quoted prices for the identical instrument on an inactive market, prices for similar instruments, interest rates, prepayment speeds, credit risk, yield curves, default rates and similar data.)
- Level 3 – Unobservable inputs for the asset or liability, to the extent relevant observable inputs are not available, representing the Plan's own assumptions about the assumptions a market participant would use in valuing the asset or liability, and would be based on the best information available.

The inputs methodology used for valuing securities are not necessarily an indication of the risk associated with investing in those securities.

NOTES TO FINANCIAL STATEMENTS – (Continued)

The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs). The investment in the common collective trust fund is valued at the net asset value (the “NAV”) per unit, as determined by the trustee at year end. This fund seeks to provide income while preventing price fluctuations. Redemptions occur daily. There are no unfunded commitments as of December 31, 2024 and 2023. The NAV is used as the practical expedient to estimate fair value and is based on the fair value of the underlying investment held by the fund, less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. In accordance with ASC Subtopic 820-10, certain investments that are measured at fair value using the NAV per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in the tables below are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

(6) TAX STATUS

The Plan administrator received an opinion letter from the IRS dated January 1, 2018, stating that the Plan meets the requirements of Section 401(a) of the Internal Revenue Code of 1986 (the “Code”), as amended. The Plan administrator believes that the Plan is in compliance with the applicable requirements of the Code, and that the Plan’s related trust is exempt from federal income tax under the provisions of Section 401(a) of the Code. As a result, no provision for income taxes has been incorporated into the financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the taxing authorities. Management has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(7) RELATED PARTY TRANSACTIONS

The Plan allows notes receivable from participants. These qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

(8) RISKS AND UNCERTAINTIES

The Plan invests primarily in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

(9) SUBSEQUENT EVENTS

The Plan evaluated its financial statements for subsequent events through September 24, 2025, the date the financial statements were available to be issued. Management has determined that there are no subsequent events that would require disclosure or adjustment in the financial statements.
