Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Capstone Real Estate Services, Inc. Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

NOTE A - DESCRIPTION OF PLAN

The following description of the Capstone Real Estate Services, Inc. (the Company) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established effective January 1, 1993. Effective January 1, 1997, the Company elected to become a participant in the Pension Investors Corporation Prototype Plan under Adoption Agreement #004 Standardized Code 401(k) Plan (Paired Profit Sharing Plan). Effective January 1, 2022 the Plan adopted the Standard Retirement Services, Inc. Non-Standardized Defined Contribution Pre-Approved Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees that have completed two months of service are eligible to participate. Plan entry dates are April 1 and October 1.

Contributions

For the 2024 and 2023 plan years, participants could contribute an amount equal to not less than 1 percent nor more than 100 percent of compensation up to the IRS maximum deferral allowed. The Company may also make matching and discretionary non-elective contributions. There were no such company contributions for 2024 or 2023.

Participants direct the investment of contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocation of the Company's contribution and plan earnings. Earnings are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. The balance of vesting in the participants' accounts is based on years of service. A participant becomes 20 percent vested after two years of service, 40 percent vested after three years of service, 60 percent vested after four years of service, 80 percent vested after five years of service, and 100 percent vested after six years of service. However, if an active participant dies prior to attaining the normal retirement age, the participant's estate becomes 100 percent vested.

Payment of Benefits

Upon termination of service, a participant may elect to receive benefits in one of the following ways: lump sum payment or periodic installments over a fixed reasonable period of time. All distributions are subject to the applicable provisions of the plan document.

Administrative Expenses

Generally, all plan expenses are paid by participants of the Plan or by the Plan, itself. The Plan Sponsor may, at its discretion, pay any such expenses.

NOTE B - SUMMARY OF ACCOUNTING POLICIES

Method of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States requires the Plan's management to use estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions

Employee contributions are recorded in the period during which the Company makes payroll deductions from the participants' earnings. Matching company contributions, if any, are recorded in the same period.

Benefits

Benefit claims are recorded as expenses when they have been approved for payment and paid by the Plan.

Fair Value Measurements

The Plan follows Accounting Standard Codification (ASC) 820, issued by the Financial Accounting Standards Board (FASB). That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in active markets;

Inputs other than quoted prices that are observable for the asset or liability;

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value:

Pooled separate accounts: Valued at net asset value (NAV) of shares held at the end of the year and considered to be within Level 2 of the fair value hierarchy.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

Subsequent Events

Management of the Plan has evaluated subsequent events for disclosure through the date of the Independent Auditors' Report, the date the financial statements were available to be issued.

NOTE C - CERTIFIED FINANCIAL INFORMATION (UNAUDITED)

As permitted by the rules and regulations of the Department of Labor with respect to reporting and disclosure under ERISA, Standard Insurance Company has certified to the Plan Administrator that all investments (stated at fair value or contract value) and participant loans, together with all other transactions which affect those assets, are complete and accurate.

The Plan's investments and participant loans are held by the custodian, Standard Insurance Company. Investments are presented at fair value as determined by quoted market or contract prices as determined by the custodian. The Plan's assets and related transactions certified by the custodian as of and for the years ended December 31, 2024 and 2023, are summarized as follows:

NOTE D - INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has entered into a guaranteed interest contract with the custodian. The custodian maintains an unallocated fund to which it adds interest. Withdrawals are permitted at any time without penalty and the contract has been determined to be fully benefit responsive as defined in FASB ASC 962. The investment is reported at contract value on the Statement of Net Assets Available for Benefits.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (c) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

NOTE E - PARTICIPANT LOANS

Under the terms of the Plan, participants may borrow from their accounts up to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer to/from the investment fund from/to the Participant Loans Fund. A loan is secured by the balance in the participant's account and bears interest at a rate commensurate with market rates for similar loans.

NOTE F - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

NOTE G - PARTY-IN-INTEREST TRANSACTIONS

During the years ended December 31, 2024 and 2023, the Plan paid various service providers administrative, accounting, and consulting fees of \$8,870 and \$8,647, respectively.

NOTE H - INCOME TAXES

The Company has adopted the Standard Retirement Services, Inc. Non-Standardized Defined Contribution Pre-Approved Plan which has been determined by the Internal Revenue Service to be in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has received an opinion letter from the Internal Revenue Service as to the prototype plan's qualified status dated June 30, 2020. The Plan's administrator believes that the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE I - FORFEITURES

Forfeitures result from nonvested benefit payments remaining in the Plan for terminated employees. Upon reaching the break-in-service, as defined in the plan document, forfeitures generated are added to the forfeiture reserve balance. The forfeiture reserve of \$7,219 at December 31, 2024, and \$7,958 at December 31, 2023, is available to offset company contributions or to pay plan expenses, which would be otherwise payable by the Company, in accordance with the plan document. The Plan used \$750 and \$750 in forfeitures during 2024 and 2023, respectively.
