Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule H, Line 4i - Schedule of Assets Held (At End of Year), is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to our derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

A. DESCRIPTION OF THE PLAN

The following description of the 401(k) Savings Plan and Trust of Universal Field Services, Inc. (the Plan) provides only general information. Refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Universal Field Services, Inc. and Universal Surveying and Mapping, LLC (collectively, the "Employer"). The Plan is subject to the provisions of the Department of Labor's (DOL's) Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). The Plan's 401(k) committee is responsible for oversight of the Plan. Plan management determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's Board of Trustees (the Board).

Some administrative functions are performed by employees of the Employer. No compensation is remitted to the Employer for these services.

Plan assets are held and managed by John Hancock Life Insurance Company (U.S.A.), the custodian and the qualified institution for the Plan, which invests contributions and Plan earnings, makes investment transactions as directed by the Board and provides certain recordkeeping services. Beasley & Company, a division of USI, acts as the third-party administrator for the Plan, which performs certain plan administration and annual ERISA compliance testing.

Eligibility

Employees may become a participant of the Plan after two months of service. An eligible employee may enter the Plan on the first day of the month following the completion of eligibility requirements.

Contributions

Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catchup contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (i.e. rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. During the years ended December 31, 2024 and 2023, the Employer matched 25% of the first 8% of base compensation that a participant contributes to the Plan.

As of the end of the Plan year, the Employer also may contribute on behalf of each participant a discretionary "year-end" matching contribution to be announced by the Board. During the year ended December 31, 2024, the Employer made a discretionary contribution doubling all employer contributions made during the plan year. Contributions are subject to certain Internal Revenue Services (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, as well as allocations of the Employer's matching and nonelective contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, ranging from 5.25% to 10.50%, determined monthly, is set at 2% above the Prime rate as published by the Wall Street Journal. Principal and interest is paid ratably through payroll deductions.

Vesting and Forfeitures

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Employer's matching and discretionary contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of credited service. Participants vest in Employer's contributions and related earnings as follows:

<u>Years of vesting service</u>	<u>Vesting Percent</u>
Less than 2 years	None
2 years but less than 3 years	20%
3 years but less than 4 years	40%
4 years but less than 5 years	60%
5 years but less than 6 years	80%
6 or more years	100%

The forfeited nonvested accounts did not have a balance at December 31, 2024 or 2023. These accounts will be used to reduce future Employer contributions. In 2024, Employer contributions were reduced by \$4,731 from forfeited nonvested accounts.

Payment of Benefits

Upon termination of service, an employee may elect to receive either a lump-sum amount equal to the value of their account or to roll over the amount to another qualified retirement plan.

Hardship Withdrawals

As permitted by the Internal Revenue Code (IRC) and in accordance with the plan agreement, a participant may request a financial hardship withdrawal if they experience a severe financial hardship. The financial hardship withdrawal may not exceed the amount of the financial hardship or the value of the vested portion of the participant's balance, whichever is less.

Plan Expense Reduction Account (PERA)

During year ended December 31, 2014, the Plan's trustees entered into an agreement with the Plan custodian to establish a Plan Expense Reduction Account (PERA). Amounts credited to the PERA represent a reduction of 0.14% on asset-based costs. Amounts are credited with respect to each one-year period commencing on the first day of the first month following the date the PERA was established, and each anniversary thereafter, to be calculated monthly based on applicable investment assets determined as of the close of each applicable calendar month following the date of establishment of the PERA, and are credited monthly after the close of such calendar month.

Plan Expense Reduction Account (PERA) (Continued)

The credit will only be made when the Plan's applicable investment assets are equal to or greater than \$12,000,000 at the end of each month. The Plan's trustee has the option to use the credits to pay Plan expenses for services obtained from third parties or to allocate the credits to participant's accounts. For the year ended December 31, 2024, credits used to pay third-party fees for services provided to the Plan totaled \$26,923. These amounts are included in administrative expenses in the accompanying statement of changes in net assets available for benefits. The Plan did not have any credits available as of December 31, 2024 or 2023.

B. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP). The Financial Accounting Standards Board (FASB) provides authoritative guidance regarding U.S. GAAP through the Accounting Standards Codification (ASC) and related Accounting Standards Updates (ASUs).

Estimates

The preparation of U.S. GAAP financial statements requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments generally are reported at fair value, but may also be reported at net asset value (NAV). Fair value is the price that would be received to sell an asset or paid to transfer liability in an orderly transaction between market participants at the measurement date. See Note D for further discussion of fair value measurements and NAV. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisers and custodians.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of Benefits

Distributions to participants are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. During the year ended December 31, 2024, \$19,266 in credits were allocated to Plan participants by the Plan's custodian for investment related expenses.

During the year ended December 31, 2024, expenses of \$34,038 were paid by the Plan and allocated to participant accounts. The administrative expenses consisted of \$7,115 and \$26,923 in certain contract administration and third-party administration fees, respectively.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in value of investment securities will occur in the near term and that these changes could materially affect amounts reported in the Plan's financial statements.

Subsequent Events

Management has evaluated subsequent events through the date that the financial statements were available to be issued, September 24, 2025, and determined there were no events that occurred that require disclosure. No subsequent events occurring after this date have been evaluated for inclusion in these financial statements.

C. INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Custodian has certified that the following data included in the accompanying financial statements and supplemental schedule of assets (held at end of year) is complete and accurate:

- Total investments, at fair value, included in the statements of net assets available for benefits at December 31, 2024 and 2023.
- Notes receivable from participants, included in the statements of net assets available for benefits at December 31, 2024 and 2023.
- Net appreciation in fair value of investments and interest income from notes receivable, information included in the statement of changes in net assets available for benefits for the year ended December 31, 2024;
- All amounts included in Note D, *Fair Value Measurements*
- All information included in the supplemental schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule of assets (held at end of year).

D. FAIR VALUE MEASUREMENTS

Fair value is the exchange price that would be received for an asset or paid to transfer a liability (exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date. There are three levels of inputs that may be used to measure fair values:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs, other than quoted prices, that are:
 - Observable; or
 - Can be corroborated by observable market data.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Pooled Separate Accounts: The Plan's pooled separate accounts at John Hancock Life Insurance Company are valued based on net asset value (NAV) per share at the close of each business day as reported by each fund, which is these adjusted for dividends and separate account fees. Accordingly, these NAV based investments are reported using the NAV practical expedient and have been excluded from the fair value hierarchy levels since they are not traded on an active market.

The John Hancock Stable Value Fund pooled separate account is invested solely in the John Hancock Stable Value Fund Collective Investment Trust, which invests primarily in diversified fixed income funds and separately managed bond accounts run by internal and external sub managers selected by John Hancock and in book value stabilizing agreements offered by state and federally regulated financial institutions. John Hancock reports the John Hancock Stable Value Fund at fair value. Fair value is calculated as the number of units of the sub-account held on a particular date, multiplied by the unit value published by the Trust on that data, and generally is the value that would be paid out for participant-initiated benefit withdrawals.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in different fair value measurements at the reporting date.

E. TAX STATUS

The IRS has determined and informed the Plan's third-party administrator by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

E. TAX STATUS (Continued)

Tax positions are recognized only if it is "more likely than not" that the tax position be sustained in a tax examination, with a tax examination being presumed to occur. The amount recognized is the largest amount that is greater than 50% likely of being realized on examination. For tax positions not meeting the "more likely than not" test, no tax position is recorded. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

F. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are managed by John Hancock Life Insurance Company. John Hancock Life Insurance Company is the investment custodian for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Fees paid by participants for investments management and certain recordkeeping services are included as a reduction of the return earned on each fund. John Hancock Life Insurance Company is the custodian of the Plan, and, therefore, these transactions qualify as party-in-interest transactions.

G. PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.
