As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note 2.
- The information in the accompanying financial statements referred to above, related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“U.S. GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Emphasis of Matter - Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors’ Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors’ report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with U.S. GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. Description of the Plan

Shepley Bulfinch Richardson and Abbott, Incorporated (the “Employer”) established the Shepley Bulfinch Richardson and Abbott, Incorporated Profit Sharing Plan (the “Plan”) on January 1, 1972. The following description of the Plan provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Shepley Bulfinch Richardson and Abbott Incorporated who have attained 21 years of age and have met the six-month service requirement (Participants). Participants meeting the eligibility requirements will be automatically enrolled in the Plan. The Plan is subject to the provisions of the Internal Revenue Code (“IRC”) and the Employee Retirement Income Security Act of 1974 (“ERISA”). All investments are participant-directed.

Fidelity Management Trust Company (“FMTC” or the “Trustee”) provides asset custodian services and also serves as trustee for the Plan. Fidelity Workplace Services, LLC (“FWS” or the “Recordkeeper”), an affiliate of the Trustee, provides recordkeeping services. Fidelity Investments, an affiliate of the Trustee, manages the investments in the Plan.

Plan Administration

The Employer is the plan administrator and has the authority to appoint person(s) for the Plan or entities to carry out the operations of the Plan. Individual Participant accounts may be charged directly with an allocation of administrative expenses, if not paid by the Employer. Individual participant accounts are charged directly for loan recordkeeping, if applicable. Expenses that are paid by the Employer are excluded from these financial statements.

Subsequent Events

The Plan Administrator has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which is September 24, 2025.

Participant Deferral Contributions

Participants may voluntarily contribute up to 90% of their annual eligible compensation as limited by the Internal Revenue Code (the "IRC") and as defined by the Plan. Participants may make pre-tax or Roth contributions to their accounts. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. In addition, Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans and individual retirement accounts ("Participant Rollovers"). Employees, upon eligibility to participate in the Plan, will be automatically enrolled to defer 5% of their eligible compensation as defined. In addition, employees who are enrolled in the Plan will have their deferral percentage increased annually by 1% until a maximum deferral rate of 15% is reached unless the employee elects otherwise. If no investment election is made at the time of auto-enrollment, contributions will be automatically directed by the Trustee to the age-appropriate American Funds Target Date Retirement Fund Class R-6 based on the Participant's date of birth.

Employer Contributions

The Employer, at its discretion, may elect to contribute a safe harbor nonelective contribution as determined by the Board of Directors. The Employer made a safe harbor contribution equal to 3% of the participants' compensation for the year ended December 31, 2024. Annual elections are made by the Employer to indicate whether the Employer's safe harbor contributions or nonelective employer contributions will be made for the coming year. During the year ended December 31, 2024, \$704,914 was contributed as a safe harbor nonelective contribution to the Plan.

The Employer may also make a discretionary nonelective contributions to the Plan. Nonelective contributions are allocated to each eligible participant in the ratio that the participant's total compensation bears to the total compensation for all eligible participants for that year. An employee is eligible for the nonelective contribution if they had at least 1,000 hours of service during the Plan year. During 2024, no nonelective contributions were made to the Plan.

Participant Accounts

Each Participant's account is credited with the Participant's deferral contribution, the respective Employer contributions, an allocation of the Plan's earnings or losses, and is charged with certain administrative expenses. Allocations are based on Participant compensation or account balance, as defined. The benefit to which a Participant is entitled is the benefit which can be provided from the Participant's vested account.

Vesting

Participants are immediately 100% vested in their voluntary contributions, rollover contributions and the Employer's safe harbor contributions, plus actual earnings thereon. Participants become 10% vested in the employer nonelective contributions after their first year of service, 20% after their second year of service, and 20% each year thereafter until they are 100% vested after year six.

Payment of Benefits

The Plan provides for a normal retirement benefit to be paid to participants who have reached the age of 65, with no option for early retirement. Upon termination of service due to death, disability, retirement, termination, or other reason, a participant or beneficiary may elect to receive a partial withdrawal, or a lump-sum amount equal to the value of the participant's vested interest. The payment can either be a cash distribution to the Participant, subject to income tax withholdings, or a cash rollover to an individual retirement account or another qualified plan as defined. If a Participant's vested account is more than \$1,000 but less than \$5,000, the plan administrator, after notification, may distribute the benefit into an individual retirement account. If the vested account balance is less than \$1,000, the plan administrator, after notification, may distribute the account balance to the Participant. The Plan also allows for in-service distributions of the participant's vested accounts upon reaching the age of 59 ½ or from a participant's deferral accounts due to hardship, as defined in the Plan. Participants may also withdraw employee contributions including rollover contributions at any time not to exceed two withdrawals in a twelve month period.

Notes Receivable from Participants

Subject to approval by the plan administrator, Participants may borrow a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range up to five years (or longer for the purchase of a primary residence). All loans shall bear a reasonable rate of interest as determined by the plan administrator based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances. Principal and interest are paid ratably through payroll deductions. If a Participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the Participant's loan balance is reduced and a benefit payment is deemed to be made upon the occurrence of a distributable event. Loans to Participants are reported as notes receivable from participants at the unpaid principal balance plus any accrued but unpaid interest.

Interest rates for outstanding loans range from 9.75% to 10.50% at December 31, 2024 and mature at various dates through November 2029.

Forfeitures

A Participant who leaves the employment of the Employer forfeits any non-vested balance. Forfeited balances of terminated Participants' accounts are used to first pay administrative expenses and then to reduce all Employer contributions in the year of forfeiture. During 2024, \$16 of forfeitures were used to offset administrative fees. At December 31, 2024 and 2023, there are unallocated forfeiture amounts of \$69,983 and \$4,516, respectively.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the modified cash basis of accounting, which differs from accounting principles generally accepted in the United States of America ("U.S. GAAP"). This basis differs from U.S. GAAP in that contributions to the Plan are recorded as an addition to net assets available for benefits when received and disbursements from the Plan are recorded as a deduction to net assets available for benefits when paid. Modifications to the cash basis of accounting in the accompanying financial statements include recognition of dividend and interest income as earned rather than when received. Accordingly, the financial statements are not intended to present the net assets available for benefits and changes in net assets available for benefits of the Plan in accordance with U.S. GAAP.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Fair Value Measurements

The Plan's investments are stated at fair value, as determined by FMTC. *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Mutual funds: As of December 31, 2024 and 2023, mutual funds amounted to \$39,493,634 and \$33,557,881, and are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified as Level 1 investments.

Fair Value Measurements (continued)

Common collective trust fund: As of December 31, 2024 and 2023, common collective trusts amounted to \$653,567 and \$550,378, and are valued at the net asset value (“NAV”) of units in the collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Participants do not have beneficial ownership in the specific underlying securities or other assets in the fund, but do have an interest therein represented by units which are valued daily. The fund earns dividends and interest which are automatically reinvested in additional units. Generally, contributions to and withdrawals from the fund are converted to units by dividing the amounts of such transactions by the unit values as last determined, and the Participants’ accounts are charged or credited with the number of units properly attributable to each Participant. The fund has no unfunded commitments as of December 31, 2024 and 2023. Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the net asset value (“NAV”) per share as a practical expedient is not categorized within the fair value hierarchy.

The Plan's investment in the common collective trust fund is represented by the common collective trust fund's underlying investment in the Fidelity Advisor Stable Value Fund, which invests in fully benefit-responsive investment contracts, commonly referred to as guaranteed investment contracts (GICs), synthetic investment contracts, and similarly designed contracts issued by insurance companies, banks and other financial institutions. The Plan's investment in the common collective trust fund is not considered to be a fully benefit-responsive investment contract and is reported at fair value.

Investments, Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when received. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from Participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recognized when received. Related fees are recorded as administrative fees and expensed when incurred.

Benefits Paid

Benefit payments are recorded in the period in which the Participants are paid.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i, Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, dividend and interest income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Trustee, a qualified institution.

4. Risks and Uncertainties

The Plan invests in various investment securities which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect Participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

5. Party-In-Interest Transactions

Plan investments include funds that are managed by an affiliate of FMTC, Fidelity Investments. These transactions qualify as exempt party-in-interest transactions. Administrative fees of \$35,807 were paid to FMTC during 2024. Administrative fees of \$60,735 were paid to Fidelity Investments during 2024. Notes receivable from Participants qualify as exempt party-in-interest transactions as defined by ERISA.

6. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time or to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, any unallocated assets of the Plan will be allocated to Participant accounts and distributed in such a manner as the Employer may determine.

7. Tax Status

The underlying volume submitter non-standardized pre-approved profit sharing plan has received its latest opinion letter from the Internal Revenue Service ("IRS"), dated June 30, 2020, stating that the form of the plan is qualified under section 401(a) of the IRC and that the plan, as then designed, was in compliance with the applicable requirements of the IRC. Any employer adopting this form of the plan will be considered to have a plan qualified under section 401(a) of the IRC. The Plan has been amended since receiving the opinion letter; however, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that the Plan is qualified and the related trust is tax-exempt as of the date of this report.

7. Tax Status (*continued*)

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
