### (1) Description of the Plan

#### (a) *Basis of Presentation*

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General:* The Plan is a defined contribution plan covering all employees of the Employer who are least 18 years of age and have completed one year of service with the Employer, in which the participant worked at least 1,000 hours. The Plan is subject to the provisions of ERISA. Plan sponsor appointed management members are responsible for the oversight of the Plan. The Plan management determines the appropriateness of the Plan's investment offerings and monitors investment performance.

*Contributions:* Each year, participants may contribute up to 100% of pretax annual compensation as defined in the Plan agreement, subject to qualified limitations. Participants who have attained age 50 before the end of the Plan year, are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of both their contributions and employer contributions into various investment options offered by the Plan. Participants may change their investment options daily. Contributions are subject to certain IRS limitations.

Each year, the Employer contributes 5% of each eligible participant's compensation, up to a maximum of \$200,000 of compensation for each participant, to the Plan. To receive the Employer 5% contribution, Plan participants must be actively employed by the Employer at the end of the Plan year.

The Employer may make discretionary contributions to eligible employees each year. The Employer's discretionary contribution to the Plan is determined by the board of directors and shall come from the Employer's current or accumulated net profits. Allocation of the current year's employer discretionary contribution is based on units assigned to a participant for compensation and years of service. Units assigned to participants for allocation of the Employer's discretionary contribution to the Plan were 178,653 and 169,233, and the unit values were approximately \$14.55 and \$14.57 for the years ended December 31, 2024 and 2023, respectively.

Employer 5% contributions and Employer discretionary contributions to the Plan were \$861,591 and \$2,600,000, respectively, for the year ended December 31, 2024, and Employer 5% contributions and Employer discretionary contributions to the Plan were \$807,310 and \$2,465,000, respectively, for the year ended December 31, 2023.

*Participant Accounts:* Each participant's account is credited with the participant's contributions and the Employer's contributions, as well as allocations of the Plan earnings (losses) and forfeitures of terminated participants' non-vested accounts. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting:* Participants are immediately vested in their contributions plus actual earnings (losses) thereon. The vesting in Employer contributions is based on years of continuous service. Participants are credited with a year of service for each year in which they have 1,000 or more hours of service as defined by the Plan agreement. A participant is 100% vested after six years of credited service, with 20% vested each year after two years of credited service.

*Payment of Benefits:* On termination of service, a participant's vested account balance will be paid under one or more of the optional forms available under the Plan, which includes a lump-sum payment or the purchase of a type of annuity contract. The amount of payment from an annuity contract will depend on the participant's vested account balance, the participant's age, the age of the participant's survivor, and the payment option selected.

*Forfeited Accounts:* For the years ended December 31, 2024 and 2023, forfeited non-vested accounts totaled \$26,594 and \$35,409, respectively. Forfeitures may be used first to pay Plan administrative expenses, remaining amounts (if any) are reallocated to current participants in the same manner as the allocation of Employer contributions. \$25,230 and \$23,290 of forfeitures were reallocated to current participants in 2024 and 2023, respectively.

### (2) Summary of Accounting Policies

#### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

#### *Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or transfer a liability in an orderly transaction between market participants at the measurement date. The Plan management determines the Plan's valuation policies utilizing information provided by the investment advisers and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal). See note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Payment of Benefits***

Benefits are recorded when paid.

***Expenses***

Certain administrative functions are performed by employees of the Employer. No such employee receives compensation from the Plan. Certain other administrative expenses are paid by the Employer with remaining administrative expenses paid directly by the Plan.

***Subsequent Events***

The Plan management has evaluated subsequent events through September 17, 2025, the date the financial statements were available to be issued.

Effective on April 1, 2025, Fidelity Trust Company assumed the responsibility for the plan administration, trustee, custodial and recordkeeping services for the Plan replacing the Principal Trust Company.

**(3) Investments**

Management having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 102(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan Administrator has obtained a certification from Principal that information provided to the Plan Administrator by Principal, relating to the following investments is complete and accurate. The following is a summary of the investment information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and supplemental schedule, that was prepared or derived from information provided by Principal, the trustee of the Plan, and furnished to the Plan Administrator:

**(4) Related-Party Transactions and Part in Interest Transactions**

Certain Plan investments are shares of pooled separate accounts and common/collective trusts managed by Principal Life Insurance Company (Principal). Principal is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services are included in net appreciation (depreciation) in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. The Plan made direct payments to Principal of approximately \$169,900 and \$156,600 for the years ended December 31, 2024 and 2023, respectively, which was not covered by revenue sharing. The Plan Sponsor pays directly other fees related to Plan operations.

**(5) Tax Status**

The Plan is based on a volume submitter plan which has received a letter from the Internal Revenue Service dated in June of 2020, stating that the volume submitter plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by the taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**(6) Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are shown as Level 1.

*Pooled Separate Accounts:* The net asset value is used as a practical expedient to determine fair value for all pooled separate accounts. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Each pooled separate account provides for redemptions by the Plan at the net asset value per share, with no advance notice requirement. Investments in pooled separate accounts are not classified according to fair value hierarchy, in accordance with ASU 820, as the net asset value is used as a practical expedient to value the investment.

*Common/Collective Trust Funds:* Common/collective trust funds are composed of investment contracts that are valued at the net asset value of the units of the common/collective trusts. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur immediately. If the Plan initiates a

full redemption of the collective trust, no notice to the issuer is required. Investments in common/collective trust funds are not classified according to fair value hierarchy, in accordance with ASU 820, as the net asset value is used as a practical expedient to value the investment.

**(7) Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan, subject to the provisions of ERISA.

**(8) Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments securities, it is reasonably possible that changes in the values of these investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**(9) Stable Value Fund**

The Principal Stable Value fund (the Fund) is a collective trust fund sponsored by Principal. The beneficial interest of each participant is represented by units. Units are issued and redeemed daily at the Fund's constant net asset value of \$1 per unit. Distributions to the Fund's unit holders is declared daily from the net investment income and automatically reinvested in the Fund on a monthly basis, when paid. It is the policy of the Fund to use its best efforts to maintain a stable net asset value of \$1 per unit, although there is no guarantee that the Fund will be able to maintain this value.

Participants ordinarily may direct either the withdrawal or transfer of all or a portion of their investment at contract value. The contract value represents contributions made to the Fund, plus earnings, less participant

withdrawals and administrative expenses. Certain events, such as the Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code, premature termination of the investment contract by the Plan or termination of the Plan, would limit the Plan's ability to transact at contract value with Principal. The Plan Administrator believes the occurrence of such events that would limit the Plan's ability to transact at contract value with participants is unlikely.
