Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Outten & Golden LLP 401(k) Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Opinion

Note 1. Description of the Plan

General

The following description of Outten & Golden LLP 401(k) Plan (formerly known as Outten & Golden LLP 401(k) Profit Sharing Plan & Trust) (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by Outten & Golden LLP (Firm) for the benefit of its employees (excluding certain classes) who have at least three months of service and are age 21 or older. The Plan became effective January 1, 1998 and is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Effective October 16, 2023, the Plan was amended to designate Fidelity Management Trust Company (Fidelity) as its Trustee and terminated its relationships with The Angell Pension Group, Inc. (former Plan trustee) and John Hancock Life Insurance Company of New York (John Hancock or former Plan custodian). Plan assets transferred to the new Trustee were transferred into funds comparable to those offered by the previous custodian. The conversion initiated a "Black Out" period beginning October 9, 2023 and continued through November 12, 2023. During this period, funds could not be applied to the employee-selected funds with the Trustee or withdrawn from the Plan until the Trustee had time to accurately complete the conversion. At the end of the Black Out period, these funds were transferred to the new Trustee and invested in funds as requested by each participant. The name of the Plan was changed to Outten & Golden LLP 401(k) Plan.

Contributions and Participant Investment Account Options

The Plan permits eligible employees through a salary deferral election to have the Firm make annual contributions of up to 100% of their eligible compensation. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan has an auto-enrollment feature whereby participants hired on or after October 1, 2021 after meeting the eligibility criteria, are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated default fund until changed by the participant. Participants direct the investment of contributions credited to his or her accounts into various investment options offered by the Plan.

The Firm can make discretionary safe harbor and nonelective employer contributions. Participants are eligible for these employer contributions on the first day of the month immediately following one year of service. One year of service is credited upon completion of 1,000 hours of service. Nonelective employer contributions are provided at the Firm's discretion at an amount and allocation formula as determined by the Firm, which was 0.5% and 1.5% of eligible compensation for 2024 and 2023, respectively. The Firm has also elected to make a safe harbor contribution of 4% and 3% of eligible compensation for 2024 and 2023, respectively. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Firm's contributions and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and all the Firm's safe harbor contributions plus earnings thereon. Vesting in the Firm's matching contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after six years of continuous service. Upon attainment of normal retirement age of 65, when a participant retires, becomes disabled, or in the event of death, the participant becomes fully vested.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The vested loan interest rate, at the time of the loan application, is current interest rate charged by financial institutions for similar loans. Principal and interest are paid ratably through bi-weekly payroll deductions or directly from the borrower and credited to the borrower's account balance.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the vested interest in their account. Upon termination, the Firm may make automatic rollover distributions of vested account balances or may elect payment in a lump sum or installments of vested account balances that are not more than \$5,000, in accordance with the provisions of the plan document. Under certain circumstances (hardship), and with approval of the Firm, a participant can elect at any time to receive a portion of his or her vested account balance subject to the provisions of the Plan. In-service withdrawals are permitted once a participant has attained age 59 ½.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$23,210 and \$28,178, respectively. These accounts will be used to restore forfeitures, reduce future Firm contributions (or reallocate as Firm contributions), or pay plan expenses. The Plan used approximately \$32,000 and \$4,000 of forfeited non-vested accounts to reduce Firm contributions or pay plan expenses during 2024 and 2023, respectively.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared under the accrual basis of accounting. Investments held by a defined contribution plan are required to be reported at fair value.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds and investments in the self-directed brokerage accounts are valued at the net asset value (NAV) of shares held by the Plan at year-end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the plan document.

Contributions

Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Other Income and Administrative Expenses

Administrative expenses may be paid by the Firm or the Plan, at the Firm's discretion.

The Plan has a revenue sharing arrangement with Fidelity. During the plan year ended December 31, 2024, Fidelity funded approximately \$4,000 of revenue credits, which are included in other income, net of administrative expenses, in the statements of changes in net assets available for benefits.

Note 3. Certification of Plan Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity and John Hancock, qualified institutions, have certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment.

The Plan paid \$40,051 of administrative fees to Fidelity during the year ended December 31, 2023. See Note 2 for discussion on 2024 administrative fees. Fidelity and John Hancock were the trustee and custodian, respectively, as defined by the Plan, during the years ended December 31, 2024 and 2023, and therefore, these transactions qualify as party-in-interest transactions.

The Firm provides certain administrative services at no cost to the Plan.

Note 5. Disclosures About Fair Value of Plan Assets and Liabilities

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

Note 7. Tax Status

The Plan operated under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by The Angell Pension Group Inc. until their transition to Fidelity. Since the transition, the Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by FMR, LLC. Both prototype plan documents have been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified, and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances, and the amounts reported in the statements of net assets available for benefits.

Note 9. Subsequent Events

Subsequent events have been evaluated through September 3, 2025, which is the date the financial statements were available to be issued.
