### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Everwise Credit Union 401(k) Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Everwise Credit Union 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). **Note 1. Description of Plan**

The following description of the Everwise Credit Union 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

**General**

The Plan is a defined-contribution plan sponsored by Everwise Credit Union (Credit Union) for the benefit of its employees. The Plan allows other employers to adopt its provisions. Prior to January 1, 2024, employees were eligible for the Plan who had completed three months of service and attained the age of 18. Effective January 1, 2024, employees that are aged 18 are eligible immediately upon hire. It is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Members of the Credit Union management serve as Plan trustees. Effective October 1, 2024, Principal Trust Company (Principal) serves as the custodian of the Plan. Previously, Matrix Trust Company and CFMG Life Insurance Company (CFMG) served as custodians of the Plan.

Effective June 2023, the Sponsor changed their name from Teachers Credit Union to Everwise Credit Union. Effective October 15, 2023, the Plan was amended to change the Plan's name to Everwise Credit Union 401(k) Plan. Effective October 1, 2024, the Plan was amended and restated with the custodian change to Principal.

Effective October 7, 2024, assets were transferred to Principal as the new custodian of the Plan. The conversion initiated a "Black Out" period beginning September 25, 2024, and continued through October 20, 2024. During this period, funds could not be applied to the employee-selected funds with the custodian or withdrawn from the Plan until the custodian had time to accurately complete the conversion. During this period, employee contributions continued to be made through payroll deductions, and the contributions were deposited and held in the holding fund until the completion of the Black Out period. At the end of the Black Out period, these funds were transferred to the new custodian and invested in funds as requested by each participant.

**Contributions**

The Plan permits eligible employees through a salary deferral election to make annual contributions up to 100% of eligible compensation. Employee rollover contributions are also permitted. The Plan Document also includes an automatic deferral feature whereby a participant is treated as electing to defer 3% of eligible compensation unless the participant made an affirmative election otherwise. Prior to January 1, 2024, the automatic deferral amount included an automatic increase of 1% of compensation up to the maximum of 5%. Effective January 1, 2024, the maximum automatic increase changed from 5% to 6% of compensation.

Prior to January 1, 2024, the Credit Union made matching contributions of 100% of employees' salary deferral amounts on the first 3% of employees' compensation. In addition, the Credit Union made safe harbor matching contributions up to 100% of the first 3% for a total contribution of 6% by the Credit Union. The Plan Document permitted profit-sharing contributions; however, no such contributions were made during the 2023 Plan year. Effective January 1, 2024, the Plan was amended and the Credit Union makes QACA safe harbor matching contributions of 100% of employees' salary deferral amounts up to 6% of employees' compensation for the Plan year. The Plan also allows for discretionary employer matching contributions and employer discretionary contributions. There were no discretionary contributions made in 2024.

**Participant Investment Account Options**

Investment account options available include various funds. Each participant has the option of directing his contributions into any of the separate investment accounts and may change the allocation daily.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, allocation of the Credit Union's contribution and Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Credit Union's contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is 100% vested in employer matching contributions and employer discretionary contributions after five years of credited service. Effective January 1, 2024, a participant is 100% vested after 1 year of service in QACA safe harbor matching contributions. The nonvested balance is forfeited upon termination.

***Payment of Benefits***

Upon termination of service, participants may receive, among other options, a lump-sum amount equal to the value of their accounts. Withdrawals other than for termination are permitted under circumstances provided by the Plan.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$3,900 and \$4,667, respectively. Also, in 2024 and 2023, employer contributions were reduced by \$108,989 and \$120,616, respectively, from forfeited nonvested accounts. Fees of \$543 and \$0 were paid using forfeitures in 2024 and 2023, respectively.

***Notes Receivable From Participants***

The Plan Document includes provisions authorizing loans from the Plan to active eligible participants. Loans are made to any eligible participant demonstrating a qualifying need. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loans is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are covered by demand notes and are repayable over a reasonable period of time through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is based on local prevailing rates as determined by the Plan Administrator.

Notes receivable from participants are reported at the amortized principal balance plus accrued but unpaid interest. Delinquent participant loans are reclassified as benefit payments based upon the terms of the Plan Document.

***Plan Termination***

Although it has not expressed any intent to do so, the Credit Union has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

## **Note 2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in conformity with the accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets available for benefits. Actual results could differ from those estimates.

### ***Valuation of Investments and Income Recognition***

Mutual funds are valued at estimated fair value as provided by Principal and CMFG. The Plan's fully benefit-responsive insurance contracts are carried at contract value as determined by Principal and CMFG as described in Note 6. Pooled separate accounts are valued at the net asset value (NAV) of share held by the Plan at year end. Collective investment trusts are valued based on information reported by the investment advisor using the audited financial statements of the collective trust at year end. These investments may be redeemed daily.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

### ***Plan Tax Status***

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by Principal Life Insurance Company. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

### ***Transfers Between Fair Value Hierarchy Levels***

Transfers in and out of Level 1 (quoted market prices), Level 2 (other significant observable inputs) and Level 3 (significant unobservable inputs) are recognized on the period ending date.

### ***Administrative Expenses***

Administrative expenses may be paid by the Credit Union or the Plan, at the Credit Union's discretion.

### **Note 3. Certification of Plan Custodians**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Trust Company, Matrix Trust Company and CMFG Life Insurance Company, the custodians of the Plan and qualified institutions, have certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments, accrued investment income and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investments information included in the financial statements and ERISA-required supplemental schedule.

### **Note 4. Disclosures About Fair Values of Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the year ended December 31, 2024. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

***Investments***

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. Level 1 securities include mutual funds. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. There are no Level 3 securities in the Plan.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual funds:* Valued at the quoted market price of shares held by the Plan at year end.

*Pooled separate accounts:* Valued at estimated fair value as provided by Principal Life Insurance Company, utilizing quoted market prices of the underlying mutual funds on the last business day of the Plan year.

*Collective investments trusts:* Valued at the quoted market price of shares held by the Plan at year end. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

## **Note 5. Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The Plan invested in various funds of the Plan custodian, and fees for custodial services were paid by the Credit Union in 2024 and 2023. The Plan paid \$53,370 to Principal for custodial services and recordkeeping fees in 2024. The Plan paid \$95,140 and \$93,127 to CMFG for custodial services and recordkeeping fees in 2024 and 2023, respectively. The Plan paid \$62,602 and \$80,335 to Members Capital Advisors for investment advisory services in 2024 and 2023, respectively.

The Credit Union provides certain administrative services at no cost to the Plan.

## **Note 6. Investment Contract With Insurance Company**

The Plan has a fully benefit-responsive investment contract with Principal Life Insurance Company. Principal Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

As described in the basis of accounting disclosure, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by CMFG, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no penalties assessed by this contract for benefit payments or other withdrawals taken by participants.

The investment contract included in Plan assets may be subject to withdrawal charges upon contract termination. Crediting interest rates on the guaranteed interest portion of the investment contract included in Plan assets are determined annually (2.85% at December 31, 2024 and 2.05% at December 31, 2023) by the issuer (subject to limitations relating to Plan termination, early retirements, etc.).

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.
