### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of AstenJohnson Nonwovens Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, are complete and accurate.

### *Opinion*

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### *Basis for Opinion*

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other matter - Supplemental Schedules Required by ERISA***

The supplemental schedules of schedule of assets held at end of year and schedule of delinquent contributions as of December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of the Plan's management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**1. DESCRIPTION OF THE PLAN**

The following description of the AstenJohnson Nonwovens Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Document and Summary Plan Description for more complete information.

**General**—The Plan is a defined contribution plan covering substantially all employees, excluding nonresident aliens and leased employees who have attained age 21 and have completed sixty days of qualified service. The Retirement Committee of the Company controls and manages the operation and administration of the Plan. Fidelity Management Trust Company (“Fidelity”) serves as the trustee of the Plan. In accordance with Internal Revenue Code (IRC) Section 414(b), the following Companies are a controlled group of corporations whereby all employees of each company shall be treated as employees of a single employer. These companies are included in the control group; Foss Performance Materials, LLC (Foss), Eagle Nonwovens, Inc. (Eagle) and AstenJohnson Nonwovens Manufacturing, Inc. (AstenJohnson). The Plan was restated on November 18, 2021 for the Cycle 3 qualified pre-approved profit-sharing plan as required by the Internal Revenue Service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Contributions**—Participants are auto enrolled at 3% once they become eligible and may contribute between 1% and 90% of their pretax or after tax eligible annual compensation, limited to \$23,000 for 2024 and \$22,500 for 2023. Participants who are age 50 or older by the end of the calendar year may make an additional catch-up contribution up to \$7,500 for 2024 and 2023. Eligible compensation is defined as most salaries and wages, including overtime, bonuses and commissions, and excluding severance and auto allowances. Eligible compensation is limited to \$345,000 and \$330,000 for the year 2024 and 2023. Contributions are subject to certain other Internal Revenue Code (“IRC”) limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company may elect to contribute to the Plan amounts in the form of discretionary employer match and nonelective contributions. During the year 2024, discretionary employer match of \$700,207 was made to the eligible participants.

The Company contributes amounts to union participants according to their respective collective bargaining unit agreements. Additional amounts may be contributed at the discretion of the Company’s Board of Directors. No additional amounts were contributed during 2024.

**Participant Accounts**—Individual accounts are maintained for each plan participant. Each participant’s account is credited with the participant’s contribution, the Company’s contributions, and an allocation of plan earnings, and charged with withdrawals and allocations of plan losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Investments**—Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers mutual funds and common collection trust funds as investment options for participants.

**1. DESCRIPTION OF THE PLAN (CONTINUED)**

**Vesting**—Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their account, and actual earnings thereon, is based on years of continuous service. Employer contributions and any earnings thereon will be vested in accordance with the following schedule:

**Forfeitures**—Forfeitures represent the non-vested portion of employer contributions that are forfeited by participants upon termination of employment before becoming fully vested. In accordance with the provisions of the Plan, forfeitures may be used to reduce future employer contributions, pay plan expenses, or be reallocated to participants. During the years ended December 31, 2024 and 2023 respectively, forfeitures in the amount of \$25,823 and \$0 were used to reduce employer contributions or pay plan expenses. As of December 31, 2024 and 2023 the balance of unallocated forfeitures available for future use was \$81,748 and \$77,738

**Notes Receivable from Participants**—Participants may borrow from their fund accounts up to a maximum of \$50,000 or 50 percent of their account balances, whichever is less. The source of the loaned funds is restricted to the portion of the account balance related to participant deferrals. The loans are secured by the balance in the participant’s account and bear interest at rates commensurate with local prevailing rates as determined appropriate by the plan administrator. Principal and interest is paid ratably through weekly payroll deductions. Participants may also submit loan payments directly to the Trustee on at least a quarterly basis outside of payroll deductions. Participants may have two loans outstanding at a time.

**Payment of Benefit and Withdrawals**—On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account, or annual installments as provided in the plan document. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Participants may also request a withdrawal due to financial hardship.

The Company may elect to distribute funds to terminated participants through the automatic mandatory involuntary cash-out provision for any balances less than \$5,000 as an individual retirement account rollover and amounts less than \$1,000 directly to the participant.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***—The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

***Use of Estimates***—The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

***Investment, Valuation and Income Recognition***—The Plan’s investments in mutual funds and common/collective trust funds are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds and common/collective trust funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of net appreciation in fair market value of investments for such investments.

***Contributions*** - Contributions from Plan participants and Employer matching contributions are recorded in the year in which the employee contributions are withheld.

***Notes Receivable from Participants*** —Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses have been recorded as of December 31, 2024 and 2023.

***Payment of Benefits*** —Benefits are recorded when paid.

***Administrative Expenses***— Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

***Subsequent Events***—The Plan has evaluated subsequent events through September 5, 2025, the date the financial statements were available to be issued.

**3. INFORMATION CERTIFIED BY TRUSTEE**

As permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA, and as instructed by the Plan administrator, no audit procedures have been performed on certain information certified as complete and accurate by the Fidelity Management Trust Company, (“the Trustee”), except to compare such information to the information included in the accompanying financial statements and supplemental schedule. Information certified by the Trustee includes investments and notes receivable from participants included in the Statements of Net Assets Available for Benefits at December 31, 2024 and 2023, investment related income and interest on notes receivable from participants as included in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and investments included in the Schedule of Assets (Held at End of Year).

**4. FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by the observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Fair value measurements are classified within the valuation hierarchy based on the lowest level of any input that is significant to the fair value measurement.

The valuation methodology for the Plan’s assets are as follows at December 31, 2024 and 2023:

Mutual Funds – Mutual funds are registered investment companies that pool the funds of multiple investors into a portfolio. The fund offers shares of the portfolio, which an investor may redeem for current value (NAV, or net asset value) of the fund’s assets through a public market.

Common collective trust funds – The value of a fund unit will be based on the net asset value as a practical expedient (“NAV”) per unit of each of the portfolios in which assets of a fund are invested. The NAV per unit is determined by the portfolio and equals the total value of its assets, less its liabilities, divided by the number of its outstanding units. Units are only valued as of the close of regular trading on the New York Stock Exchange (“NYSE”) each day and the exchange is open for trading.

**4. FAIR VALUE MEASUREMENTS (CONTINUED)**

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation

methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**6. EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are shares of mutual funds managed by an affiliate of the Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Fees for recordkeeping and financial advisor services of \$19,226 was paid for the plan year ended December 31, 2024.

**7. PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100 percent vested in their accounts.

**8. INCOME TAX STATUS**

The Plan has timely adopted a restated, via a non-standardized pre-approved profit-sharing plan. The pre-approved plan has received an opinion letter from the IRS dated June 30, 2020, whereby the IRS stated that the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). While the Plan cannot rely on the pre-approved opinion letter, the Plan administrator believes that the Plan has been operated in compliance with the applicable requirements of the IRC and, therefore, believes that the plan is qualified and the related trust is tax exempt.

**8. INCOME TAX STATUS (CONTINUED)**

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be substantiated upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**9. RISKS AND UNCERTANTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as an international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**10. PROHIBITED TRANSACTION**

The Plan Sponsor did not remit to the Plan's trust certain employee contributions totaling \$36,019 for the year ended December 31, 2022 within the period prescribed by the Department of Labor regulations. Delays in remitting contributions to the trust were due to administrative errors. Plan management has not made the necessary corrections for these late deposits, including calculating and remitting the lost earnings to affected participants accounts in accordance with the U.S. Department of Labor and/or Internal Revenue Service guidelines as of December 31, 2024.

Except as discussed in the following paragraph, in planning and performing our audits of the financial statements of AstenJohnson Nonwovens Savings Plan as of and for the years ended December 31, 2024 and 2023, in accordance with auditing standards generally accepted in the United States of America, we considered AstenJohnson Nonwovens Savings Plan's internal control over financial reporting (internal control) as a basis for designing audit procedures that are appropriate in the circumstances for the purpose of expressing our opinion on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the plan's internal control. Accordingly, we do not express an opinion on the effectiveness of AstenJohnson Nonwovens Savings Plan's internal control.

We were engaged to perform an ERISA Section 103(a)(3)(C) audit of those financial statements as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Our audit did not include all of the procedures required by U.S. generally accepted auditing standards and did not include a consideration of internal control relating to the information summarized in Note 3 to those financial statements and the additional scope limitations described in the auditors' report. Because of the significance of the information that we did not audit, we were unable to, and did not, express an opinion on those financial statements.

Our consideration of internal control was for the limited purpose described in the preceding paragraph and was not designed to identify all deficiencies in internal control that might be material weaknesses or significant deficiencies and, therefore, material weaknesses or significant deficiencies may exist that were not identified. However, as discussed below, we identified certain deficiencies in internal control that we consider to be significant deficiencies.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis. A material weakness is a deficiency, or a combination of deficiencies, in internal control over financial reporting, such that there is a reasonable possibility that a material misstatement of the plan's financial statements will not be prevented, or detected and corrected on a timely basis. A reasonable possibility exists when the likelihood of an event occurring is either reasonably possible or probable as defined as follows:

- *Reasonably possible.* The chance of the future event or events occurring is more than remote but less than likely.
- *Probable.* The future event or events are likely to occur.

A significant deficiency is a deficiency, or a combination of deficiencies, in internal control over financial reporting that is less severe than a material weakness, yet important enough to merit attention by those charged with governance. We consider the following deficiencies in the plan's internal control to be significant deficiencies:

Late Deposits

As noted in prior years, the Plan has late deposits of 2022 which were not corrected in 2023 and 2024. Participant contributions totaling \$36,019 for 2022 was not remitted timely based on payroll controls. Failure to remit participant contributions to the plan in a timely manner results in a prohibited transaction that must be separately reported to the DOL and may result in penalties to the Plan Sponsor
