Note 1 - Description of Plan

The following description of the Talk to Me Technologies 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General and eligibility – The Plan is a defined contribution plan covering substantially all employees of Talk to Me Technologies (the Company), who are 18 years of age or older and have completed two months of service as defined by the Plan. Eligible employees are allowed to enroll monthly on the first day of each month. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions – Participants may contribute a percentage of their pretax annual compensation subject to an annual limit by federal regulations, as defined by the Plan. Participants who have attained age 50 before the end of the plan year are also eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Plan includes an auto-enrollment provision, whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively select not to participate, with a default deferral rate set at 6% of eligible compensation. The Company makes safe harbor matching contributions in an amount equal to 100% of the first 3% of employee salary deferral contributions. The Plan also allows the Company to make discretionary nonelective contributions, which are determined annually by the Company. To be eligible an employee must complete two months of service. No discretionary contributions were made during 2024 and 2023.

Participant Accounts – Each participant’s account is credited with the participant’s contributions, the Company matching and safe harbor contributions, and allocations of nonelective contributions, plan administrative expenses and plan earnings. Allocations are based on participant earnings or on account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participants account. The Plan allows each participant to choose their own investment mix for salary deferrals and employer contributions. Participants can change their investment mix daily.

Vesting – Participants are immediately vested in their salary deferral contributions and employer safe harbor matching contributions plus actual earnings thereon. Vesting in the Company’s discretionary nonelective contributions is based on continuous years of service according to the following schedule:

Note 1 - Description of Plan (Continued)

Forfeited Accounts – Forfeitures of terminated participants' nonvested accounts may be used to pay plan expenses and reduce employer contributions. Unallocated forfeitures included in net assets available for benefits was \$-0- as of December 31, 2024. No forfeitures were applied to pay plan expenses for the year ended December 31, 2024.

Payment of Benefits – Upon termination of service, retirement, death or disability, a participant may elect to receive an amount equal to the value of their vested account balance in a lump-sum payment. If the participant's vested account balance does not exceed \$1,000, then the participant will receive their benefit as a mandatory cash out lump-sum payment. In-service withdrawals after age 59 ½ and hardship withdrawals are also allowed under the terms of the Plan.

Loans – Loans to participants are not permissible under the plan.

Note 2 - Summary of Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits – Benefits are recorded when paid.

Administrative Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Risks and Uncertainties – The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances, and the amounts reported in the statement of net assets available for benefits.

Date of Management Review – Management has evaluated subsequent events through September 23, 2025, the date which the financial statements were available to be issued.

Note 3 - Investments and Fair Value Measurements

The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly or indirectly such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable for the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Investment assets are classified in their entirety based upon the lowest level of input that is significant to the fair value measurement.

Mutual funds: Valued at the net asset value (NAV) of units of the fund held by the Plan based on the fair value of the underlying investments of the fund. NAV is a readily determinable fair value and is the basis for current transactions.

Fixed annuities: The reported values for fixed annuity options are reported daily based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. The plan had no transfers between levels during the year ended December 31, 2024 and 2023.

Note 4 - Information Certified by Plan Custodian

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental information, including investments from participants held at December 31, 2024 and 2023, and net appreciation in the fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC (the trustee of the Plan).

Note 5 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their employer discretionary nonelective contributions.

Note 6 - Tax Status

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable section of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt. Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 - Party in Interest Transactions

Certain plan assets are held in investment options managed by Empower Trust Company, LLC. Empower Trust Company, LLC is the current custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Note 8 - Prohibited Transactions

In 2024, the Plan Sponsor erroneously failed to remit certain employee deferrals totaling \$392,593 to the Plan in a timely manner. The Plan Sponsor subsequently remitted the deposits and lost earnings thereon.

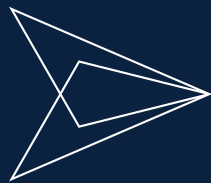

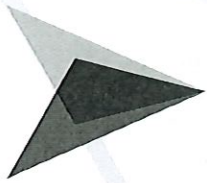

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Talk to Me Technologies 401(k) Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users made on the basis of the financial statements.

In performing an audit in accordance with GAAS, we:

Accordingly, no such opinion is expressed.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103 (a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedules Required by ERISA

The supplemental schedule of assets (held at end of year) and schedule of delinquent participant contributions are presented for the purpose of additional analysis and are not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, have been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 - Description of Plan

The following description of the Talk to Me Technologies 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

General and eligibility – The Plan is a defined contribution plan covering substantially all employees of Talk to Me Technologies (the Company), who are 18 years of age or older and have completed two months of service as defined by the Plan. Eligible employees are allowed to enroll monthly on the first day of each month. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions – Participants may contribute a percentage of their pretax annual compensation subject to an annual limit by federal regulations, as defined by the Plan. Participants who have attained age 50 before the end of the plan year are also eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Plan includes an auto-enrollment provision, whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively select not to participate, with a default deferral rate set at 6% of eligible compensation. The Company makes safe harbor matching contributions in an amount equal to 100% of the first 3% of employee salary deferral contributions. The Plan also allows the Company to make discretionary nonelective contributions, which are determined annually by the Company. To be eligible an employee must complete two months of service. No discretionary contributions were made during 2024 and 2023.

Participant Accounts – Each participant’s account is credited with the participant’s contributions, the Company matching and safe harbor contributions, and allocations of nonelective contributions, plan administrative expenses and plan earnings. Allocations are based on participant earnings or on account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participants account. The Plan allows each participant to choose their own investment mix for salary deferrals and employer contributions. Participants can change their investment mix daily.

Vesting – Participants are immediately vested in their salary deferral contributions and employer safe harbor matching contributions plus actual earnings thereon. Vesting in the Company’s discretionary nonelective contributions is based on continuous years of service according to the following schedule:

Note 1 - Description of Plan (Continued)

Forfeited Accounts – Forfeitures of terminated participants' nonvested accounts may be used to pay plan expenses and reduce employer contributions. Unallocated forfeitures included in net assets available for benefits was \$-0- as of December 31, 2024. No forfeitures were applied to pay plan expenses for the year ended December 31, 2024.

Payment of Benefits – Upon termination of service, retirement, death or disability, a participant may elect to receive an amount equal to the value of their vested account balance in a lump-sum payment. If the participant's vested account balance does not exceed \$1,000, then the participant will receive their benefit as a mandatory cash out lump-sum payment. In-service withdrawals after age 59 ½ and hardship withdrawals are also allowed under the terms of the Plan.

Loans – Loans to participants are not permissible under the plan.

Note 2 - Summary of Accounting Policies

Basis of Accounting – The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits – Benefits are recorded when paid.

Administrative Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Risks and Uncertainties – The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances, and the amounts reported in the statement of net assets available for benefits.

Date of Management Review – Management has evaluated subsequent events through September 23, 2025, the date which the financial statements were available to be issued.

Note 3 - Investments and Fair Value Measurements

The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly or indirectly such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable for the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Investment assets are classified in their entirety based upon the lowest level of input that is significant to the fair value measurement.

Mutual funds: Valued at the net asset value (NAV) of units of the fund held by the Plan based on the fair value of the underlying investments of the fund. NAV is a readily determinable fair value and is the basis for current transactions.

Fixed annuities: The reported values for fixed annuity options are reported daily based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period. The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. The plan had no transfers between levels during the year ended December 31, 2024 and 2023.

Note 4 - Information Certified by Plan Custodian

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental information, including investments from participants held at December 31, 2024 and 2023, and net appreciation in the fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC (the trustee of the Plan).

Note 5 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their employer discretionary nonelective contributions.

Note 6 - Tax Status

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable section of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt. Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 - Party in Interest Transactions

Certain plan assets are held in investment options managed by Empower Trust Company, LLC. Empower Trust Company, LLC is the current custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Note 8 - Prohibited Transactions

In 2024, the Plan Sponsor erroneously failed to remit certain employee deferrals totaling \$392,593 to the Plan in a timely manner. The Plan Sponsor subsequently remitted the deposits and lost earnings thereon.

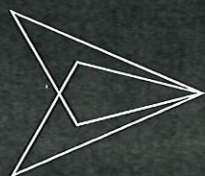
