### **Note 1 - Plan Description**

The following description of Sprouts Farmers Markets Holdings, LLC Employee 401(k) Savings Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan established on January 1, 2002 and since restated and amended. The Plan is available to all employees age 18 years or older who have completed three months of service. The entry date for eligible participants is first day of the month following obtaining eligibility. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### ***Administration***

Sprouts Farmers Markets Holdings, LLC (the "Company") is the sponsor of the Plan and administers the Plan. Fidelity Management Trust Company (Fidelity) serves as trustee, manages plan assets, and maintains the Plan's records. Fidelity offers plan participants various investment options. Individual accounts are invested in the various investment options at the direction of the participants.

#### ***Contributions***

The Plan provides for employee salary deferral contributions up to a maximum of 75 percent of annual eligible compensation. Eligible employees who have reached age 50 during the plan year may elect to make catch-up contributions, as limited by the IRS. The Plan also allows for after-tax Roth contributions. Employee contributions to the Plan are made through regular payroll deductions. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Company is required to make matching contributions of 50 percent of the first 6 percent of eligible compensation deferred by the participant. The Company may also, in its discretion, make additional nonelective contributions from time to time, as limited by the IRS. The Company has the right to designate all or a portion of the matching contributions as qualified. To the extent matching contributions are so designated, they are nonforfeitable and may be withdrawn from the Plan prior to separation from service or attainment of age 59½.

#### ***Participant Notes Receivable***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balances. Participants may have a maximum of one note outstanding at any given time. The notes receivable are secured by the balance in the participant's account and bear interest at rates that range from 4.25 percent to 10.5 percent, which are commensurate with local prevailing rates determined quarterly by the plan administrator at note origination, and mature at various dates through July 2034. Notes have a maximum term of 5 years, unless such note is for the purchase of the participant's primary residence, in which case the repayment period may not exceed 15 years from the date of the note origination. Principal and interest are paid ratably through weekly payroll deductions. Participant notes are recorded in the financial statements at amortized cost, which represents unpaid principal plus accrued interest. Upon termination of a participant from employment, the participant's note shall continue to be payable in accordance with the provisions of the participant's note or be due in full. Participant notes receivable are written off when deemed uncollectible.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Note 1 - Plan Description (Continued)

#### **Benefit Payments**

Distributions are payable upon retirement, death, disability, or termination of employment in the form of a lump-sum amount equal to the vested balance of a participant's account.

The Plan allows in-service distributions and partial distributions to participants age 59½ or older who have not terminated employment with the plan sponsor. The Plan also provides for hardship withdrawals for defined hardship events. Furthermore, the Plan allows for terminated participant vested account balances of \$1,000 or less to be automatically distributed and balances of \$1,000 to \$5,000 to be automatically rolled out of the Plan. The IRS has required minimum distributions once a participant reaches age 73 during the previous plan year and is no longer employed by the Company.

#### **Vesting**

Participants are immediately 100 percent vested in their voluntary contributions, any income or losses thereon, and any qualified matching contributions.

#### **Forfeitures**

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited account balances totaled \$106,601 and \$119,757, respectively. The Plan used approximately \$675,581 and \$93,754 for the year ended December 31, 2024 to reduce plan expenses and pay for employer contributions, respectively.

#### **Related Party, Party-in-interest, and Nonexempt Transactions**

Certain plan assets are in investment funds managed by Fidelity or its affiliates. Fidelity is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines. The Plan provides for notes to participants, which are party-in-interest transactions. Both of the aforementioned are exempt from the prohibited transaction rules.

**Note 1 - Plan Description (Continued)**

***Termination***

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

**Note 2 - Summary of Significant Accounting Policies**

***Basis of Presentation***

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

***Benefit Payments***

Benefits are recorded when paid.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

***Investment Valuation and Income Recognition***

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

***Administrative Expenses***

Various administrative costs are paid by the Company.

***Subsequent Events***

The plan administrator has evaluated all subsequent events up through and including September 24, 2025, which is the date these financial statements were available to be issued.

**Note 3 - Certified Information**

Fidelity (the "Trustee") holds the Plan's investments and participant notes receivable and executes all investment transactions. The investment balances, participant notes receivable, and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

### Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

#### Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

#### Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

#### Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

#### **Mutual Funds and Money Market Fund**

Mutual funds and the money market fund are valued at quoted market prices reported in active markets.

#### **Common Collective Trust Fund**

The common collective trust fund is valued at net asset value per share (NAV) or its equivalent of the fund, which is based on the fair value of the fund's underlying assets.
