### Summary of Significant Accounting Policies Years Ended December 31, 2024 and 2023

#### **Basis of Accounting**

Ottawa Bancshares Profit Sharing Plan & Trust (the Plan) presents its financial statements on the accrual basis of accounting.

#### **Use of Estimates**

In preparing financial statements in conformity with accounting principles generally accepted in the United States of America, Plan management is required to make estimates and assumptions that affect the reported amounts of net assets available for Plan benefits and changes therein, and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the Plan's trustee. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as investments held during the year.

#### **Receivables and Allowance for Credit Losses**

Receivables are stated at the amount management expects to collect from balances outstanding at year-end. The allowance estimate, if any, is derived from a review of the Plan's historical losses in relation to the Plan's historical receivable balances as well as management's assessment of current conditions, reasonable and supportable forecasts regarding future events, and any other factors deemed relevant by the Plan. Management has concluded that realized losses on balances outstanding at year-end will be immaterial. Accordingly, no allowance for credit losses has been recorded. There were no write-offs or recoveries during either year ended December 31, 2024 and 2023.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Expenses**

Certain expenses of administering and maintaining the Plan are paid directly by the participating employers and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and payment of benefits are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

### 1. Description of Plan

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

The Plan is a qualified automatic contribution arrangement 401(k) safe harbor plan, also known as a "QACA" and covers all employees of the participating employers: First Kansas Bank, The Lyon County State Bank, First Bank Kansas, and Advantage Trust Company (collectively, the "Company").

The Plan is intended to satisfy all of the requirements for a qualified retirement plan under the appropriate provisions of the Internal Revenue Code (IRC) and similar state tax laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The steering committee is responsible for oversight of the Plan, including determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

An employee is eligible to become a participant in the Plan on the first day of each month provided he has attained the age of 21. A participant specifies the amount, not to exceed Internal Revenue Service (IRS) limits, of eligible compensation to be contributed to the Plan (participant salary deferral contributions). If a participant fails to make an affirmative elective deferral election or an affirmative election not to participate, the Company will automatically withhold 5% of the participant's compensation. The automatic deferral percentage will increase by 1% each Plan year to a maximum of 10%. Participants may elect to designate their salary deferral contributions as a pre-tax deferral or as a Roth deferral.

In order to maintain "QACA safe harbor" status, the Company makes a safe harbor matching contribution equal to 100% of the elective deferrals that do not exceed 3% of the employee's compensation, plus 50% of the elective deferrals that exceed 3% but are less than 5% of the employee's compensation. The employer may also make a discretionary contribution, which is not a safe harbor contribution. For the years ended December 31, 2024 and 2023, the Company made a discretionary contribution equal to 2% of eligible compensation. Participants do not need to make salary deferral contributions in order to receive the discretionary employer contribution. Those who are employed on the last day of the Plan year and have completed 1,000 hours of service share in the discretionary contribution. The total of the annual employee and employer contributions on behalf of each participant cannot exceed certain IRS limits. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Rollover contributions are not subject to contribution limitations.

A participant may direct contributions to any of the investment options available from the Plan. Salary deferral contribution amounts can be changed at any time and take effect as soon as administratively possible. Allocation changes and fund transfers can be done daily. Each participant's directed account is credited/charged with an allocation of the directed investment's earnings/losses based on the participant's account balance and credited with the following contributions:

- Participant's salary deferral contributions.
- Participant's rollover contributions.
- Employer safe harbor matching contributions.
- Employer discretionary contributions.

Participants are always 100% vested in all Plan accounts.

### 1. Description of Plan (continued)

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance of the participant's account and bear interest at rates ranging from 3.25% to 8.50% at December 31, 2024 and 2023. The rate of interest is based on the prime rate as published by the Wall Street Journal. Loan terms range from one to five years, or longer for the purchase of a primary residence. Principal and interest are paid ratably through payroll deductions.

Upon termination of service, a participant is entitled to a distribution of his vested interest in his current balance in the form of a lump sum payment or in installments. Upon termination of service, the Plan allows for partial distributions of vested amounts. If a participant's benefits are \$1,000 or less, his benefits will be paid in a lump sum automatically unless otherwise requested by the participant. If a participant's benefits are over \$1,000 and less than \$5,000, his benefits will be rolled over into an individual retirement account for the participant unless otherwise requested by the participant. Under terms of the Plan, normal retirement age is the date the participant attains age 65. The Plan also allows for hardship distributions and distributions after a participant attains age 59.5 if certain conditions are met.

On December 29, 2022, the Consolidated Appropriations Act of 2023 was signed into law, which includes the package of retirement provisions referred to as "SECURE Act 2.0." These provisions continue the themes and reforms that began with the 2019 SECURE Act, focusing on getting more participants into the retirement system, finding ways for them to accumulate more assets, and then ensuring they get connected with those assets when retirement comes. Plan management is monitoring the SECURE Act 2.0 provisions and will implement mandatory provisions as they become effective and relate to the plan.

### 2. Certified Information

Certain information in the accompanying financial statements and ERISA-required supplemental schedule related to investments and notes receivable from participants held as of the date of the financial statements under audit and covered by the certification, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023 was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (Fidelity), the trustee of the Plan.

#### 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs other than quoted market prices that are observable. These include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used to determine the fair value of investments. There have been no changes in the methodology used at December 31, 2024 and 2023.

- Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding valuation method may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. For the years ended December 31, 2024 and 2023, there were no transfers.

#### 4. **Tax Status**

The Plan has adopted a pre-approved plan which has received an opinion letter dated June 30, 2020 from the IRS indicating that the Plan, as then designed, was qualified for tax-exempt status under the appropriate sections of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan is qualified and tax-exempt as of the financial statement date and no provision for income taxes has been recorded in the financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

#### 5. **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will remain 100% vested in their accounts.

#### **6. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for Plan benefits and the statements of changes in net assets available for Plan benefits.

#### **7. Related Party Transactions and Party-in-Interest Transactions**

Certain Plan investments are managed by Fidelity. Fidelity is the trustee, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing.

Fidelity Investments Institutional Operations Company, LLC (FIIOC) is the Plan's recordkeeper and is considered a party-in-interest. Administrative expenses paid to FIIOC were \$2,806 and \$2,531 for the years ended December 31, 2024 and 2023, respectively.

Additionally, notes receivable from participants are considered party-in-interest transactions.

#### **8. Subsequent Events**

Management of the Plan has evaluated subsequent events through September 19, 2025, the date the financial statements were available to be issued.
