1. Plan Description

Otterstedt Insurance Agency, Inc. (the “Company”) established a 401(k) plan effective July 1, 1995, known as Otterstedt Agency 401(k) Plan (the “Plan”) for the exclusive benefit of its eligible employees. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

Administration of the Plan

The Company is the Plan administrator and is responsible for day-to-day administration and operation of the Plan. Nationwide Trust Company, FSB, Nationwide Life Insurance Company (collectively, “Nationwide”) and Pruco Life Insurance Company (“Prudential”), held the Plan’s investments as of December 31, 2023 and executed investment transactions from January 1, 2024 through June 30, 2024. Starting on July 1, 2024, The Voya Retirement Insurance and Annuity Company (“Voya”), and Pruco Life Insurance Company (“Prudential”), hold the Plan’s investments and execute investment transactions. FuturePlan Administrative Services LLC (formerly Intac Actuarial Services, Inc.) is the Plan’s recordkeeper as of December 31, 2024 and 2023.

On June 30, 2024, the Plan’s assets were liquidated and transferred from Nationwide to Voya and subsequently reinvested on July 1, 2024. There was a blackout period from June 24, 2024 to July 19, 2024.

Eligibility

Employees of the Company and certain affiliated entities are eligible to participate in the Plan, except for those covered by a collective bargaining agreement and nonresident aliens. Eligible employees are able to participate in the Plan once they are at least twenty-one years of age and complete 83.33 hours within the first 3 months of eligible service.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, employer matching contributions, their respective share of interest and dividend income earned, and appreciation of the Plan investments. The participant’s account is reduced by withdrawals, depreciation on investments, fees, and any forfeitures. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Contributions

Participants can contribute a portion of their compensation as pre-tax and Roth deferrals, up to the Internal Revenue Service (“IRS”) maximum allowance. Certain participants (age 50 or older), are also permitted to make catch-up contributions subject to IRS limitations.

The Company has the option to contribute discretionary matching contributions to participants with salary deferrals during the year. For the years ended December 31, 2024 and 2023, the Company made a discretionary contribution in the amount of \$200,000 and \$150,000, respectively.

Investment Options

Participants direct their contributions and Company contributions to any of the investment options offered by the Plan. Participants may change their investment elections among these various investment options at any time.

Payment of Benefits

Distributions are permitted from the Plan upon the participant's retirement at or after attaining retirement age, death, total disability, or termination of employment prior to retirement age. Participants may also request in-service distributions upon attaining age 59 1/2 or for certain hardships. A participant or his or her beneficiary is entitled to receive the vested amount allocated to the participant's account as a lump sum distribution as soon as administratively feasible. Vested balances under \$5,000 are automatically distributed upon a participant's severance of employment.

Vesting and Forfeitures

Participants are immediately vested, in full, in their elective deferrals, Roth deferrals, rollover contributions and actual earnings and losses thereon. Participants are fully vested in Company contributions upon completion of five years of service, based on the vesting schedule below.

Unvested Company contributions shall be forfeited after a five-year break in service, or upon the distribution of the entire vested portion of a former participant's account if earlier. Forfeitures can be used to reduce Company contributions or pay Plan administrative expenses. At December 31, 2024 and 2023, balances in the forfeiture account amounted to \$2,952 and \$854, respectively. During the year ended December 31, 2024 and 2023, there were \$831 and \$5,046 of forfeitures used to reduce Company matching contributions, respectively.

Notes Receivable from Participants

Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested balance. The loans bear interest at 1% above the prime rate at the time of the loan, and principal and interest are repaid ratably through payroll deductions. The maximum repayment period is five years with the exception of loans to purchase a home, which have a repayment period of up to ten years.

The interest rate on notes receivable from participants ranged from 4.25% to 9.50% at December 31, 2024, maturing at various dates through 2029.

Administrative Expenses

Certain expenses incurred in connection with the administration of the Plan are paid by the Company and are not reflected in these financial statements. Additionally, certain investment-related fees are reflected as an offset of net investment income.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements are prepared in accordance with accounting principles generally accepted in the United States of America ("GAAP"). The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income from notes receivable is recorded when earned. No allowance for losses is deemed necessary by Plan management as principal and interest are repaid through payroll deductions. A note receivable is considered to be in default if no payment is made by the end of the calendar quarter following the calendar quarter in which the loan payment is due, at which point the defaulted note receivable is considered to be a distribution to the participant, and the note would be removed from the Plan's assets.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustees determine the Plan's valuation policies utilized information provided by investment advisors and custodians.

See Note 4 for a discussion of investment contracts and Note 3 for further discussion of fair value measurements. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the Plan year.

Payment of Benefits

Benefits to participants are recorded when paid.

Subsequent Events

Plan management has evaluated subsequent events and transactions after December 31, 2024 through September 23, 2025, which is the date the financial statements were available to be issued. Based upon that evaluation, the Plan has determined that no subsequent events have occurred which require adjustment to, or disclosure in the financial statements.

3. Fair Value Measurements

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the most observable level of any input that is significant to the fair value measurement. The valuation techniques used by the Plan maximized the use of observable inputs and minimized the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds: Valued at the closing prices of the mutual fund shares held by the Plan as reported on the active market on which the funds are traded. As such, the mutual funds are valued using Level 1 measurements.

Common/Collective Trust: Valued at the net asset value (NAV) of units of a bank or insurance company collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be profitable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Variable Annuity Contracts: These contracts are considered Level 3 investments, as they are not available for sale or transfer on any securities exchange and, accordingly, transactions in similar investment instruments are not observable. The contracts are valued based on the investment performances of the participants' individual fund allocations (and reallocations as required to meet the projected benefit of the contract) less applicable fees. There was no transfer into or out of Level 3 investments during the years ended December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. Fully Benefit - Responsive Investment Contracts

The Plan participated in the Nationwide Fixed Select Contract, which was guaranteed by Nationwide Life Insurance Company. The contract is an insurance company issued general account-backed group annuity contract (“GAC”). On July 1, 2024, the Plan no longer participated in the Nationwide Fixed Select Contract, but participates in Voya Fixed Account, which is guaranteed by Voya.

The Plan also holds a Guaranteed Principal Annuity (“GPA”) contract, which is guaranteed by Nationwide Life and Annuity. The contract is a principal protected annuity account that bases gains and losses on the underlying investment index. The contract value resets on a three-year cycle and the term of the contract is on a nine-year surrender schedule.

The GAC and GPA meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. The total contract value for all fully benefit-responsive investments at December 31, 2024 and 2023 is \$708,599 and \$539,359, respectively.

For the GAC, the contract issuer is contractually obligated to repay the principal and interest at the specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. The minimum guaranteed rate of interest may not be less than 0.5%. The crediting rate is reviewed on a quarterly basis for resetting. The contract continues in force until all assets have been distributed, or no further payments are due.

Certain events limit the ability of the Plan to transact at contract value with the issuers. Such events include the following: (1) amendments to the Plan documents, (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transactions exemption under ERISA. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

6. Party-in-Interest Transactions

Certain Plan investments are issued/managed by affiliates of Nationwide, Prudential and Voya, the Plan's custodians. Investment management and recordkeeping fees are paid from Plan earnings. Certain fees and expenses of the Plan are paid by the Company. Notes receivable from participants also qualify as party-in-interest transactions. All such transactions are exempt transactions pursuant to ERISA.

7. Tax Status

The Plan adopted a volume submitter defined contribution plan which obtained its latest advisory letter dated June 30, 2020, in which the Internal Revenue Service (“IRS”) stated that the Plan, as then designed, was in compliance with the applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRS. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America, require the Plan’s management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. In addition, there have been no tax-related interest or penalties for periods presented in these financial statements.

8. Plan Termination

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. Whole or partial termination of the Plan shall result in the full and immediate vesting of employer profit sharing contributions and earnings thereon. Each participant is entitled to full distribution of such amounts.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities in general are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.
