Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Bristol Bay Native Corporation 401(k) Savings Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Bristol Bay Native Corporation 401(k) Savings Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Bristol Bay Native Corporation 401(k) Savings Plan and Trust and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Bristol Bay Native Corporation 401(k) Savings Plan and Trust's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. - conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Bristol Bay Native Corporation 401(k) Savings Plan and Trust's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter

Notes to Financial Statements

Note 1 – Description of Plan

The following description of the Bristol Bay Native Corporation 401(k) Savings Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan agreement, as amended, for a more complete description of Plan provisions.

General – The Plan was originally adopted January 1, 1985, and is a defined-contribution multiple employer plan that covers substantially all employees of Bristol Bay Native Corporation (the Plan sponsor), its subsidiaries, and qualified affiliates. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility – Employees become eligible to participate on the first day of the calendar month following or coincident with the employee's first hour of service. For matching contributions, a participant becomes eligible on January 1 or July 1, immediately following the date on which the participant completes 1,000 hours of service. The initial computation period is the 12-month period beginning on the first day of work. An employee is credited with a year of eligibility service as soon as the employee completes at least 1,000 hours of service. If an employee does not have at least 1,000 hours of service in their first 12 months of employment, a year of eligibility service can be earned by completing 1,000 hours of service during any plan year beginning after their first day of work.

Contributions

Participant contributions – Each year, participants may contribute up to 75% of pretax annual compensation, as defined in the Plan. Participants may also elect to make Roth contributions utilizing pre-tax contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants may create an annual increase program to gradually raise their contribution rate each year, subject to contribution limits.

Employer contributions – The employer's matching contribution is 5% of each participant's eligible compensation, not to exceed the amount of the participant's deferral amount. The employer's discretionary profit-sharing contribution ranges from 0% to 5% of each participant's eligible compensation. Each subsidiary establishes, and the Plan sponsor's Board of Directors approves, a profit share percentage applicable to its employees, between 0% and 5%, on an annual basis. Participants' eligibility is similar to the employer match, except the employee must also complete 1,000 hours in the current Plan year and be employed at December 31. The profit-sharing contribution amount is determined at Plan year-end and included as a receivable at year-end. The Plan sponsor's Board of Directors, at its discretion, may elect to make an additional contribution to the Plan.

Contributions are subject to regulatory limitations.

Participant accounts – Each participant's account is credited with the participant's contributions, employer contributions and Plan earnings. Participant accounts are charged a quarterly administration fee, and administrative expenses are paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account into various investment options offered by the Plan. Participants may change their investment elections and make transfers between investment options on a daily basis. Participants have the option of having self-directed brokerage accounts for which they may choose to buy any mutual fund.

Vesting – Participants are vested immediately in their contributions, the employer’s matching, and actual earnings thereon. Vesting in the employer’s profit-sharing portion of participant accounts plus actual earnings thereon is based on years of completed service according to the following schedule:

Participants become 100% vested in their accounts if, while employed by the Plan sponsor, they attain normal retirement age (age 65), early retirement age (age 55 and five years of service), or if they become totally and permanently disabled or deceased.

Notes receivable from participants – Participants may borrow from participant accounts. The amount borrowed must be less than 50% of the participant’s vested account balance minus the current outstanding loan balance or \$50,000 minus the highest outstanding loan balance within the prior 12 months. The notes receivable are secured by the balance in the participant’s account, bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator, and have a defined maturity date not exceeding five years except for loans used to acquire a primary residence, in which the term shall not exceed 15 years. Principal and interest are paid ratably through periodic payroll deductions. Outstanding notes receivable as of December 31, 2024, bear interest at various rates ranging from 3.25% to 6.45%, with maturity dates ranging through July 2047.

Payment of benefits – On termination of service due to retirement, disability, or death a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account, or payment in monthly, quarterly, or annual installments over a fixed reasonable period of time, not exceeding the life expectancy of the participant. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

For termination of service with vested benefits of \$1,000, or less, a participant or beneficiary will automatically receive the value of the vested interest in his or her account as a lump-sum distribution.

Hardship withdrawal – Under certain conditions, participants, while still employed by the Plan sponsor, are permitted to withdraw, in a single sum, the employee contribution or non-safe harbor employer matching contribution portion of their account balance. A participant’s right to make deferrals to the Plan will be suspended for six months after the receipt of a hardship withdrawal.

Forfeitures – Forfeitures are the nonvested portion of a participant’s account that are lost upon termination of employment. Any forfeitures occurring during a Plan year are applied to reduce the contributions of the employer. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,425,676, and \$981,322, respectively. For the years ended December 31, 2024 and 2023, matching and profit-sharing contributions by the Employers were reduced by \$1,383,882 and \$980,752, respectively, from forfeited nonvested accounts.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

Use of estimates – The preparation of financial statements in accordance with GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment valuation – The investments are reported at fair value. The Plan's trustee, Matrix Trust Company, certified investments held at fair value from participants held at December 31, 2024 and 2023. If available, quoted market prices are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Contributions – Contributions from participants and corresponding matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants – Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions upon the occurrence of a distributable event, based on the terms of the Plan agreement. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of benefits – Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid directly by the Plan sponsor and are excluded from these financial statements. Administrative expenses paid by the Plan may include notes receivable and distribution fees charged to participants' accounts and administrative Plan fees. Investment related expenses are included in net appreciation in fair value of investments. The Plan operates on a per participant fee that is deducted from participant accounts.

Subsequent events – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued. The Plan has evaluated subsequent events through September 23, 2025, which is the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust – Units held in the collective trust (CT) are valued using the net asset value practical expedient (NAV practical expedient) of the CT as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CT, minus its liabilities, and then divided by the number of units outstanding.

Self-directed brokerage accounts – This asset category represents separate brokerage accounts that offer a wide range of investment opportunities. The investments held within these accounts are mutual funds valued at net asset values of shares held at year-end.

Note 4 – Tax Status

The Internal Revenue Service has determined and informed the plan sponsor by a letter dated November 9, 2017, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statement of net assets available for benefits.

Note 6 – Certified Investment Information

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Matrix Trust Company, the trustee of the Plan, has certified to the completeness and accuracy of the following:

- Investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments, dividends, and interest reflected on the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investments reflected on the schedule of assets (held at end of year).

Note 7 – Party-in-Interest Transactions

Matrix Trust Company provides certain administrative services to the Plan pursuant to an Investment Retirement Plan Service Agreement (IRPSA) between the plan sponsor and Matrix Trust Company. Matrix Trust Company receives revenue from mutual fund service providers for services provided to the funds. This revenue is allocated to the participants that generate the revenue. Revenue sharing income allocated to participants was \$101,650 and \$40,810 for the years ended December 31, 2024 and 2023, respectively.

Note 8 – Plan Termination

Although it has not expressed any intent to do so, the plan sponsor has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. If the Plan is terminated, amounts allocated to a participant's account become fully vested.

Note 9 – Delinquent Participant Contributions

As disclosed in the accompanying supplemental schedule, certain employee deferrals were not remitted to the Plan within the timeframe required by the Department of Labor. The Plan administrator has determined the amount of related lost earnings and has remitted these amounts to participants' accounts during 2024, and subsequent to year-end for the portion that was not corrected as of December 31, 2024.

Note 10 – Reconciliation to Form 5500

The Form 5500 has certain items that differ from amounts shown on the accompanying financial statements. These differences relate to classification only and have no effect upon net assets available for benefits for either period.
