Scope and Nature of the ERISA Section 103(a)(3)(c) Audit

We have performed audits of the accompanying financial statements of 403(b) Thrift Plan for Employees of Valley Opportunity Council, Inc. (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above, related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Notes to the Financial Statements

December 31, 2024 and 2023

NOTE 1 – DESCRIPTION OF PLAN

The following description of the 403(b) Thrift Plan for Employees of Valley Opportunity Council, Inc. (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a participant-directed defined contribution 403(b) plan covering all employees of Valley Opportunity Council, Inc. (the “Organization”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Contributions

Each year, participants may contribute a percentage of their includable compensation. Participants that are age 50 or older may elect to defer additional amounts (age-50 catch-up contribution) to the Plan. However, a participant’s total deferral in any taxable year may not exceed a dollar limit which is set by law. In addition, participants who have completed at least 15 years of service are eligible to make an additional contribution (special catch-up contribution). Participants may also contribute amounts representing distributions from other eligible plans.

All employees who are age twenty-one or older are eligible for matching and base contributions to the Plan. The Organization makes matching contributions equal to the lesser of 50% of a participant’s salary reduction amount or 1% of a participant’s compensation received during the plan year. Age-50 catch up contributions are not eligible for a matching contribution. The Organization also makes an employer base contribution equal to 2% of a participant’s compensation for the plan year. The base contribution was made whether or not the participant elects to make a salary reduction contribution.

The matching contribution is 8% of a participant’s compensation, plus an additional 4% if the participant had employee contributions of 2% or more of their compensation for the Plan year.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, the Organization’s contributions and Plan earnings, and charged with actual administrative expenses. Allocations are based on participant compensation or account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options

A participant may direct the Organization to invest their contributions in a variety of investment options allowed by the Plan. All investments are participant directed.

NOTE 1 – DESCRIPTION OF PLAN – (CONTINUED)

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Organization’s matching and base contribution portion of their accounts plus actual earnings thereon is based on years of continuous service.

The vesting schedule for the Plan is as follows:

Plan Loans

Loans are permitted by the Plan and are issued by Mutual of America Life Insurance Company (“Mutual of America”), the Plan custodian. Plan loans may be requested by a participant, using their account balance as collateral. A Plan loan is not treated as a distribution from the Plan and is not considered a Plan asset. Therefore, Plan loans are not reported on the statements of net assets available for benefits. Loans may not exceed the lesser of (i) \$50,000 or (ii) 50% of the participant’s vested account balance in the Plan. The interest rate is re-evaluated each calendar quarter. Principal and interest is paid ratably through payroll deductions. Loan balances collateralized by participants’ vested account balances at December 31, 2024 and 2023 were \$92,444 and \$87,513, respectively.

Payment of Benefits

On termination of employment, a participant is entitled to the full value of the participant’s contributions to the Plan, all vested Organization contributions and all related earnings. There are various options available for distributions. For vested account balances under \$1,000, lump sum distributions or direct rollovers will be made. Distribution of vested account balances of more than \$1,000 cannot be made before the participant’s normal retirement date without the participant’s written consent. In addition, during employment, a participant may withdraw all or a portion of their vested account balance, to the extent necessary, to meet a qualifying financial hardship, or for childbirth and adoption expenses.

NOTE 1 – DESCRIPTION OF PLAN – (CONTINUED)

Forfeitures

If a participant leaves the Organization for any reason other than retirement, disability or death, they are entitled to all their contributions, the vested portion of Organization contributions and related earnings. The nonvested portion of Organization contributions and the related earnings will be forfeited. If a terminated participant is re-employed, the forfeited account will be restored upon re-employment if the break-in service does not exceed five years and the participant did not receive a distribution. If the terminated participant received a distribution of their vested account, the Organization will restore the forfeited portion if the participant repays to the Plan the total amount of the distribution within five years of the date of re-employment.

At December 31, 2024 and 2023, unallocated nonvested accounts totaled \$40,836 and \$4,077, respectively. Each year, if there are any forfeitures, they are used to reduce future employer contributions to the Plan unless there are any charges related to forfeitures. Forfeitures of \$93,638 and \$63,609 were used to reduce employer contributions during the years ended December 31, 2024 and 2023, respectively.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition

The Plan's assets are invested with Mutual of America. The Plan's Separate Account No. 2 investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment in the Interest Accumulation Account is reported at contract value which approximates fair value and is comparable to a cash equivalent. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

The Plan Administrator determines the Plan's valuation policies, utilizing information provided by Mutual of America. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits

Benefits are recorded when paid.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – (CONTINUED)

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Certain other expenses including loan set-up fees and other transactional costs are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation of fair value of investments.

Subsequent Events

The Plan monitored and evaluated subsequent events for footnote disclosures or adjustments required in its financial statements for the year ended December 31, 2024 through September 9, 2025, the date on which financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the input to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

Level 1 Fair Value Measurements

The fair value of the separate accounts funds is valued based on the observable net asset value (NAV) of the underlying investment, which consists solely of mutual funds.

NOTE 4 – CERTIFIED INVESTMENTS

Information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including all investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Mutual of America, the custodian of the Plan.

NOTE 5 – RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Substantially all the costs and expenses incurred in connection with the operations of the Plan are paid by the Organization. Mutual of America is the custodian of the Plan's assets and manages the Plan investments. Therefore, these transactions qualify as party in interest transactions and are denoted as such on the supplemental Schedule H, line 4i - Schedule of Assets (Held at Year End).

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intention to do so, the Organization has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 7 – INCOME TAX STATUS

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code ("Code"). The terms of the Plan have been prepared to conform with the sample language provided by the Internal Revenue Service ("IRS") in Revenue Procedure 2007 – 71. The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b).

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken a significant uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investments. These investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of the investment will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
