## Independent Auditor's Report

Participants and Board of Directors  
Tall Tree Foods, Inc. 401(k) Savings Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Tall Tree Foods, Inc. 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

**Emphasis of Matter– Partial Plan Termination**

As discussed in Note 9 to the financial statements, Tall Tree Foods Inc, the Plan sponsor, downsized its operations during the 2024 plan year, which resulted in a partial plan termination. Our opinion has not been modified with respect to this matter.

**Emphasis of Matter– Plan Merger**

As discussed in Note 10 to the financial statements, on May 2, 2024, Klement Sausage Co., Inc. (Klement) was acquired by Milwaukee Crafts Meats, LLC. Klement employees began participating in the Milwaukee Crafts Meats, LLC 401(k) Plan (MCM Plan) at that time. On August 5, 2024, control of Klement participant assets transferred to the MCM Plan. Our opinion is not modified with respect to this matter.

**Emphasis of Matter– Plan Termination**

As discussed in Note 2 to the financial statements, the Board of Directors of Tall Tree Foods, Inc., the Plan's sponsor, voted on July 24, 2025, to terminate the Plan. Our opinion is not modified with respect to this matter.

**Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

**Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

#### Note 1. Plan Description

The following description of the Tall Tree Foods, Inc. 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan that covers all employees of Tall Tree Foods, Inc. and its subsidiaries, Richard's Cajun Foods Corporation, Klement Sausage Company, Inc., and January Foods Corporation, (collectively, the Company). Oversight of the plan is the responsibility of the Tall Tree Foods, Inc. 401(k) Savings Plan Committee (Committee). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Plan amendment:** Effective July 19, 2025, the Plan was amended to approve the termination of the Plan. (See Note 2. Subsequent event for further details).

**Eligibility:** Nonunion employees who have attained age 18 and have completed 60 days of employment, as defined, are eligible for the Plan. Eligible employees enter the Plan the first day of the month following meeting the eligibility requirements. Employees will be enrolled with an automatic deferral of 3% unless the participant makes a contrary election.

**Contributions:** A participant may elect to contribute a percentage of his/her eligible compensation, as defined by the Plan, up to the maximum allowed by the Internal Revenue Service (IRS). Participants may also contribute amounts representing distributions from other qualified retirement plans. Participants who attain the age of 50 before the end of the year are eligible to make catch-up contributions. The Company may make discretionary matching contributions, as defined. The Company may also make additional discretionary profit-sharing contributions, as defined. The Company made approximately \$165,000 of discretionary matching contributions but did not make a discretionary profit-sharing contribution during the year ended December 31, 2024. All contributions are subject to certain limitations.

**Participant accounts:** Each participant's account is credited with the participant's contributions, Company discretionary matching contributions, if any, and an allocation of Company discretionary profit-sharing contributions, if any, plan earnings and losses, and charged with administrative expenses and investment expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

**Vesting:** Participants are immediately vested in their elective contributions plus the actual earnings thereon. Participants are immediately vested in Company discretionary matching contributions, if any, and discretionary profit-sharing contributions, if any.

**Investment options:** Upon enrollment in the Plan, participants may direct the investment of their account balances into a variety of investment options, as more fully described in the Plan's literature. Participants may change their investment options daily.

**Payment of benefits:** The full value of a participant's vested account balance is payable at normal retirement age, as defined, at termination of employment, or due to death. Benefits are paid either in a lump sum or in an annuity. In-service withdrawals are also allowed at any time for hardship reasons, as defined in the Plan, and at age 59½.

**Notes receivable from participants:** Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of 50% of the vested account balance or \$50,000, subject to other restrictions as provided for in the plan agreement. A participant may not have more than five outstanding loans at any time and only two loans may be issued in a 12-month period. The loans are secured by the balance in the participant's account and bear interest at a rate of current prime lending rate of Principal (as defined) plus 1%. The loans mature over a period ranging from one year to five years, unless the loan is for a principal residence which in that case the loan may extend beyond five years consistent with commercial home loan practices.

#### Note 2. Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared on the accrual basis of accounting.

**Accounting estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's Committee determines the Plan's valuation policies utilizing information provided by the investment custodian. See Note 4 for detailed discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

**Contributions:** Contributions from Plan participants and the related matching contributions from the Company are recorded in the year in which participant contributions are withheld from compensation.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

**Payment of benefits:** Benefits are recorded when paid.

**Administrative expenses:** Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain investment-related expenses are included in net appreciation of fair value of investments.

#### Note 2. Significant Accounting Policies (Continued)

**Subsequent events:** On July 24, 2025, the Board of Directors voted to terminate the Plan effective July 19, 2025. The Company will apply for the termination from the Internal Revenue Service during 2025. Vesting of the participants was not affected as all contributions to the plan are already immediately vested upon deposit to the plan. The financial implications of the termination are currently under evaluation, but no material impact on the Plan's financial position is anticipated at this time. The Plan Administrator has evaluated subsequent events through September 26, 2025, the date the financial statements were available to be issued and identified no additional material items requiring disclosure.

#### Note 3. Information Certified and Provided by the Custodian

#### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets

- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

**Shares of registered investment companies:** Valued at the daily closing price as reported by the fund. Shares of registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Changes in fair value levels:** To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

Plan management evaluated the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Level 3.

#### **Note 5. Fully Benefit-Responsive Investment Contract**

The Plan holds a group annuity contract with Metropolitan Life Insurance Company (Metlife). This contract meets the fully benefit-responsive contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. With this type of contract, the Plan owns only the contract itself and the contract is designed to accrue interest based on crediting rates established by the contract issuer. The contract issuer is contractually obligated to repay the principal and interest at a specific interest rate that was guaranteed to the Plan. The crediting rate for 2024, as established by the contract issuer, was 1.20% during the year ended December 31, 2024. The contract value was \$565,973 and \$1,258,478 at December 31, 2024 and 2023, respectively.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investments contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events may limit the ability of the Plan to transact at contract value with the contract issuer. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code (IRC) or the failure of the trust to be tax-exempt under Section 501(a) of the IRC
2. Premature termination of the contracts
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

The group annuity contract does not permit Metlife to terminate the agreement prior to the scheduled maturity date unless a 90-day notice is provided to the issuer.

#### **Note 6. Related-Party and Party-in-Interest Transactions**

Certain plan investments are managed by Principal Trust Company, the custodian. These transactions, therefore, qualify as party-in-interest transactions. Administrative expenses paid by the Plan to the custodian were approximately \$31,000 during the year ended December 31, 2024.

Rothschild Investment Corporation provides investment advisory services to the Plan. Fees paid for these services, therefore, qualify as party-in interest transactions. There were \$12,000 of fees paid by the Plan for investment advisory services during the year ended December 31, 2024.

#### **Note 6. Related-Party and Party-in-Interest Transactions (Continued)**

The Plan issues loans to participants, which are secured by the balances in the participants' accounts, which also constitute party-in-interest transactions.

Certain employees of the Company provide administrative services to the Plan. These employees do not receive any compensation from the Plan for their services. Also, certain administrative expenses were paid by the Company on behalf of the Plan.

#### **Note 7. Plan Termination**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

#### **Note 8. Tax Status**

The Plan has adopted a pre-approved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with applicable requirements of the IRC. The Plan has been amended since adopting the pre-approved plan document; however, the Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 9. Partial Plan Termination**

In 2024, the Company downsized its operations which resulted in a partial plan termination. This affected 79 plan participants, 71 of whom have taken distributions from the Plan of approximately \$1,046,330 in the current year. Approximately \$253,210 remains payable to affected participants. All participants affected by the partial plan termination were fully vested in their accounts prior to distributions being taken.

#### **Note 10. Plan Merger**

On May 2, 2024, the Klement Sausage Co., Inc. (Klement) was acquired by Milwaukee Crafts Meats, LLC and Klement employees began participating in the Milwaukee Crafts Meats, LLC 401(k) Plan (MCM Plan). On July 31, 2024, the Board of Directors of Tall Tree Foods Inc., the Plan sponsor, approved the merger of the Klement portion of the Tall Tree Foods Inc. 401(k) Plan into the MCM Plan. As a result, net assets of \$1,409,835 were transferred to the control of MCM Plan on August 5, 2024. The merger did not impact participant benefits as the benefit provisions were incorporated into the MCM Plan.

#### **Note 11. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
