Note 1. Description of the Plan

General

The following description of CTLGroup Retirement Savings Plan (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan was established effective January 1, 2007, by Construction Technology Laboratories, Inc. (Company). The Plan is a single employer defined contribution retirement plan that is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended by subsequent legislation. Employees of the Company are eligible to participate in the Plan upon attaining age 18 and being scheduled to complete at least 1,000 hours of service in the succeeding 12-month period.

Contributions

Covered employees may contribute from 1% to 75% of their annual compensation, as defined by the Plan, subject to certain Internal Revenue Code (Code) limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. As specified by the Plan, the Company makes matching contributions of 100% of the first 4% of participant contributions. The Company may also make a discretionary contribution. For the years ended December 31, 2024 and 2023, the Company made matching contributions of \$268,940 and \$262,118, respectively. No discretionary contributions were made during the years ended December 31, 2024 and 2023.

Investment Options

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of Company contributions and plan earnings, and charged with an allocation of any administrative expenses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and Company matching contributions plus actual earnings thereon. Participants in the Plan, as of January 1, 2007, are fully vested in the Company discretionary match plus actual earnings thereon. Participants entering the Plan after January 1, 2007, vest in the Company's discretionary match plus actual earnings thereon based on the following schedule of service:

Payment of Benefits

Upon termination of employment with the Company, participants may elect to receive either a lump-sum amount equal to the value of the vested interest in their account, or a series of equal monthly installments extending over a period not longer than the joint life expectancy of the participant and his or her spouse, or the life expectancy of the beneficiary if other than the participant. Upon proof, to the satisfaction of the plan administrator, of an immediate and heavy financial need, amounts contributed may be withdrawn for a hardship purpose. Certain income tax penalties may apply to withdrawals or distributions prior to age 59½.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$31 and \$41, respectively. These accounts will be used to pay plan administrative expenses and/or reduce future employer contributions. No forfeitures were used in 2024 or 2023.

Participants Loans

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance. Loans are secured by the participant's account balance and are repayable through payroll deductions over periods ranging up to 60 months, except for loans for the purchase of a principal residence, which are repayable over 120 months. The interest rate is determined by the plan administrator based on prevailing market conditions and is fixed over the life of the note. Interest rates ranged from 4.25% to 9.50% at December 31, 2024.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. The Plan's investments in shares of registered investment companies are valued at quoted market prices. The money market fund is valued at amortized cost, which approximates fair value.

The common or collective trust fund is valued at net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. There are no participant redemption restrictions for these investments, and participant redemptions are allowed daily. A redemption notice period is applicable only at the plan level. There were no unfunded commitments at December 31, 2024 and 2023.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold during the year as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

The plan sponsor pays certain expenses of maintaining the Plan without charge or reimbursement. In addition, certain investment related expenses are included in net appreciation in fair value of investments. The Company provides certain administrative services at no cost to the Plan.

Notes Receivable From Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Note 3. Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level or any input that is significant to the fair value measurement. There have been no changes in the methodologies used at December 31, 2024 and 2023.

The fair value of registered investment companies is determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs). The money market fund is valued at amortized cost (Level 2).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4. Information Certified by the Plan's Trustee

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, T. Rowe Price Trust Company, a qualified institution,

has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income components and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information and notes receivable from participants included in the accompanying supplemental schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related information included in the financial statements and ERISA-required supplemental schedule.

Note 5. Party-in-Interest Transactions

Certain plan investments are managed by the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services are included in net appreciation in fair value of investments. Expenses paid to parties-in-interest were \$36,325 and \$19,425 in 2024 and 2023, respectively.

Note 6. Income Tax Status

The Plan operates under a non-standardized pre-approved profit sharing/money purchase/CODA plan sponsored by T Rowe Price Retirement Plan Services Inc. This non-standardized pre-approved plan document has been filed with the appropriate agency and the sponsor has obtained an opinion letter dated August 19, 2020, from the Internal Revenue Service (IRS), stating that the non-standardized pre-approved plan constitutes a qualified plan under Section 401 of the Code and that the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in all employer contributions.

Note 8. Risks and Uncertainties

The Plan provides for investment that, in general, are exposed to various risks such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that

such changes could materially affect the amounts reported in the statement of net assets available for benefits.

Note 9. Subsequent Events

Subsequent events have been evaluated through September 9, 2025, which is the date the financial statements were available to be issued.
