Note 1: Description of Plan

The following description of the Farmers Grain Terminal, Inc. Co-op 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for more complete information.

General

The Plan, established August 1, 1978, is a defined contribution employee benefit plan sponsored by Farmers Grain Terminal, Inc. (the “Employer”) and provides retirement benefits to eligible participants. All employees of the Employer will be eligible to participate in 401(k) employee deferral contributions and employer contributions upon completion of one year of service and attaining age 21. Per the Plan document, one year of service is reached when an employee is credited with 1,000 hours of service in a 12 month consecutive period. An employee will become eligible to participate in the Plan on the first day of the month following the date in which the employee completes all applicable requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective January 1, 2024, The Setting Every Community Up for Retirement Enhancement (SECURE) Act extended eligibility for participation in 401(k) plans to certain long-term part-time (LTPT) employees. LTPT employees must have three consecutive years of eligible service beginning in 2021 in order to make deferral contributions into the Plan. Eligible service is defined as at least 500 hours of service for each 12-month eligibility period. The eligibility service window applies for plan years beginning after December 31, 2020, and excludes service before that. The Plan Sponsor may still require the employee to satisfy any minimum age requirements, and can also decide whether LTPT employees will receive any portion of employer contributions.

Contributions

Participants may contribute up to 50% of their annual compensation not to exceed the limit set by the Internal Revenue Code, which was \$23,000 and \$22,500 in 2024 and 2023, respectively. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of up to an additional \$7,500 in 2024 and 2023. Participants eligible for the Plan are automatically enrolled at 2% of eligible compensation provided they have not elected out of participating. Compensation is defined as the total amount paid to the employee by the employer that is subject to income tax and increased by any compensation reduction elections under Code Sections 125 and 401(k). The Plan also permits participant Roth 401(k) and rollover contributions from other qualified retirement plans.

Participants who meet eligibility requirements will receive employer matching contributions up to 2% of compensation. All eligible employees will receive an additional employer safe harbor contribution of 3% of compensation. Each year, the Employer, at the discretion of its Board of Directors, may contribute profit sharing amounts. To receive an allocation of the Employer’s profit sharing contribution, employees must have completed 1,000 hours of service and be employed on the last day of the Plan year.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of a) the Employer’s contribution, b) Plan earnings, and c) administrative expenses. Participants’ accounts will also be charged with an allocation of the Plan’s administrative expenses. Allocations are based on participant’s earnings or account balances as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options

Participants may instruct the trustee, through an employee election form, on how to invest their account in the various investment options offered by the Plan. The Plan currently offers 16 different mutual funds and a stable value fund as investment options for participants. The stable value fund consists of a common collective trust and guaranteed investment contracts. Participants can change their investment allocations at any time.

Vesting

Participants are immediately vested in their contributions, employer safe harbor contributions and any earnings thereon. Vesting in the portion of their account attributable to the Employer's matching or profit sharing contribution is based on each participant's years of service. Participants are 100% vested after six years of service. A participant will also become fully vested upon death, disability or retirement at age 65 or older.

Administrative Expenses

Processing fees of the Plan are charged against the individual's account balance that is responsible for the expense. Administrative expenses paid to the external service providers are paid by the Plan Sponsor. Administrative expenses related to services of the record keeper are allocated on a pro rata basis to participants, as provided for in the Plan document.

Notes Receivable from Participants

Participants may borrow from their account at a minimum of \$1,000 and to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. All loans are required to be repaid within five years of the loan origination unless the loan is used for the purchase of a principal residence. Participants are limited to one loan at any one time. Interest rates are based on the prime rate on the day the loan is requested plus 1 percent. The participant's account balances serve as collateral for the loans and are repaid through automatic payroll deductions.

Payment of Benefits

Upon death, disability, retirement, or upon termination of service due to other reasons, a participant may elect to receive payments of his or her vested account balance in a lump-sum distribution or direct transfer to an eligible retirement plan. Upon proof to the Plan administrator of an immediate financial need permitted by the Plan documents, a portion of any fully vested account balance may be withdrawn for a hardship purpose. In-service distributions from the portion of the participant's account that is fully vested after a participant's attainment of age 59 1/2 are permitted.

There were no benefits requested during 2024 that were paid in the following year.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting. Under the accrual basis of accounting, revenues and expenses, other than benefit payments, together with the related assets and liabilities are recorded in the accounting period to which they apply, regardless of when the cash transaction occurred.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan administrators to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates. The Plan's most significant estimate relates to the valuation of investments and it is reasonably possible that a change could occur in the near-term.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net change in fair value of investments.

Valuation of Investments and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

Subsequent Events

The Plan has evaluated all subsequent events for potential recognition and disclosure through September 22, 2025, the date these financial statements were available to be issued.

Note 3: Plan Termination

Although it has not expressed the intent to do so, the Employer has the right to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in the employer discretionary contributions portion of their account. Employee contributions and employer safe harbor contributions and their related earnings are always fully vested.

Note 4: Forfeitures

Forfeited account balances will first be used to reduce employer matching and employer basic contributions in accordance with the Plan document. At December 31, 2023, forfeited non-vested accounts totaled \$31. There was no balance in the forfeited non-vested accounts at December 31, 2024. During 2024 and 2023, forfeitures of \$2,012 and \$10,730 were used to reduce Employer matching contributions, respectively.

Note 5: Fair Value

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following section describes the valuation methodologies the Plan uses to measure financial instruments at fair value:

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable Value Collective Trust Fund – Valued at the net asset value of units of the bank collective trusts as well as an underlying portfolio of fixed income securities. The stable value collective trust fund is comprised of fully benefit-responsive investment contracts and the underlying portfolio of fixed income securities. Management previously adopted ASU 2015-07, Fair Value Measurement *Topic 820: Disclosures for Investments in Certain Entities that Calculate Net Asset Value per Share (or Its Equivalent)*, which became effective beginning with plan years ending on December 31, 2015. The investment in a stable value collective trust fund is valued using net asset value as the practical expedient. The practical expedient is used for valuation, unless it is probable that the Fund will sell a portion of the investment at an amount different from the net asset valuation. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 90 days notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the years ended December 31, 2024 and 2023 are reported in net change in fair value of investments. The Plan's investments (including realized gains and losses on investments bought, sold, and held during the year as well as unrealized appreciation of the investments held at the end of the year) appreciated in value by \$945,752 and \$1,336,103 in 2024 and 2023, respectively.

Note 6: Income Tax Status

The Plan adopted a Fox Rothschild LLP defined contribution plan effective January 1, 2022. The defined contribution plan obtained an opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the defined contribution plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has not been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 7: Information Prepared and Certified by Trustee

The Plan's investments are held by Charles Schwab Trust Bank, the Trustee. For the years ending December 31, 2024 and 2023, the amounts set forth in the accompanying financial statements for investments, notes receivable from participants, investment income, and interest income from notes receivable, and the information shown in the supplemental schedule were summarized from information furnished by the Trustee. The Plan administrator received from the Trustee a certification that information furnished by the Trustee is complete and accurate. As permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the information certified as complete and accurate by Charles Schwab Trust Bank was not subjected to any audit procedures except for comparing the information with the related information included in the financial statements and supplemental schedule.

Note 8: Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan; any person who provides services to the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employee association or relatives of such person.

Milliman, Inc. is the third party administrator for the Plan and Charles Schwab Trust Bank is the Trustee for the Plan. They are by definition a party-in-interest and as a result, all investment transactions were with a party-in-interest. The Plan paid administrative costs of \$61,947 and \$47,667 directly to Milliman, Inc. for their services during 2024 and 2023, respectively. These transactions are exempt from being prohibited transactions under ERISA. All remaining administrative expenses were paid by the Employer.

Note 9: Reconciliation of Financial Statements to Form 5500

Certain amounts reported in the Plan's annual Form 5500 for changes in net assets available for benefits are different from the amounts reported in the accompanying financial statements. These differences are due to different presentation of investments and investment income.
