Note 1 - Plan Description

The following description of ProMedica Health System 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan covering all employees of ProMedica Health System, Inc. and Subsidiaries (collectively, the "Company"). An employee is eligible to become a participant in the Plan immediately upon employment. Subsidiaries currently participating in the Plan include ProMedica Central Physicians; Memorial Professional Services; ProMedica Health System, Inc.; Bay Park Community Hospital; The Toledo Hospital; ProMedica Northwest Ohio Cardiology Consultants; ProMedica Genito-Urinary Surgeons; Defiance Hospital, Inc.; Memorial Hospital; Fostoria Hospital Association; ProMedica Physician Group, Inc.; Mercy Memorial Hospital Corporation; Emma L. Bixby Medical Center; Kaitlyn's Cottage, Inc.; ProMedica Monroe Physicians; ProMedica Central Corporation of Michigan; Health Resources, Inc.; ProMedica Innovations, LLC; Community Health Center of Branch County; and, Paramount Care, Inc. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Subsequent to year end, on July 31, 2025, a subsidiary of ProMedica Health Systems, HCR ManorCare, began the process of terminating their defined contribution retirement plans. Previous employees of HCR ManorCare had transitioned to being employees of ProMedica Health System over the past several years. All active employees of the ProMedica system with an account balance in the HCR ManorCare Retirement Savings 401(k) Plan were merged into the Plan. Related to this merger, plan assets of approximately \$49,080,000 were transferred into the Plan in July 2025.

Contributions

The Plan allows participants to contribute up to 75 percent of their compensation, subject to Internal Revenue Code limitations, on pretax or after-tax basis, as designated by the employee. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan provides for nondiscretionary employer matching contributions of 100 percent of the participant's contribution, not to exceed 3 percent of the employee's eligible compensation after the employee completes one year of service, as defined by the plan document, and is employed at the end of the plan year with at least 1,000 hours in a given year.

The Plan provides for an employer discretionary contribution. The Company makes annual contributions to the Plan as approved by the Company's board of directors. In 2024 and 2023, the board approved for an additional contribution ranging from 1 percent to 5 percent based on years of service and hours worked.

The Plan also provides for a fixed percentage nonelective employer contribution for certain union employees, as determined by a collective bargaining agreement between the union and the plan sponsor.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Note 1 - Plan Description (Continued)

Participant Notes Receivable

Participants may borrow from their accounts subject to certain maximum and minimum amounts prescribed in the Plan and in the Internal Revenue Code. Participant notes receivable are collateralized by the participant's account balance and bear interest at a rate commensurate with local prevailing rates determined quarterly by the plan administrator.

Vesting

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. Vesting in the Company's contribution portion of their accounts, plus actual earnings thereon, is based on years of service. Participants vest in contributions made by the Company at 20 percent after one year of service and an additional 20 percent after each year of service until they become fully vested after five years of service as further defined in the plan document.

Benefit Payments

Distributions are payable upon retirement, death, disability, termination of employment, or attainment of 59½ years of age in the form of a lump-sum equal to the vested balance of a participant's account. Participants may also receive the value of the participant's vested interest in his or her account in various installment annuities in certain situations, as further defined in the plan document.

Participants may request that all or a portion of their accounts attributable to employee contributions, plus earnings, be distributed in the case of financial hardship, as defined in the plan document.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

The Plan provides for loans to participants, which are party-in-interest transactions that are exempt from the prohibited transaction rules.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited account balances totaled \$1,677,302 and \$1,386,194, respectively.

The Plan used approximately \$1,511,632 and \$9,610,000 for the years ended December 31, 2024 and 2023, respectively, to reduce employer contributions.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation

The Plan's investments are stated at fair value.

Note 2 - Summary of Significant Accounting Policies (Continued)

The common/collective trust funds are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying net assets. The Plan allows participants to invest in self-directed brokerage accounts. The self-directed brokerage accounts include various investments primarily held in publicly traded securities, which are valued using quoted market prices. The money market funds, demand notes, certificates of deposit, and interest-bearing cash held in the self-directed brokerage account are valued at fair value based on their outstanding balances. All other investments are valued using quoted market prices. See Note 5 for additional information.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Company, as provided in the plan agreement.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including September 19, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Fidelity Management Trust Company (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

Note 4 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

Note 6 - Transfer In

During 2024, \$19,000,000 was transferred from the ProMedica Health System, Inc. Cash Balance Retirement Plan (Cash Balance Plan) into the Plan. These funds were excess plan assets remaining in the Cash Balance Plan after termination and liquidation of participant benefits. The funds were transferred to this Plan and will be used to reduce future employer contributions. During 2024, \$754,412 were used to offset employer contributions. The remaining amounts, totaling approximately \$18,666,000 at December 31, 2024 was unallocated to participants, and invested in common collected trust funds.

Accordingly, the objective of the ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

Note 1 - Plan Description

The following description of ProMedica Health System 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan covering all employees of ProMedica Health System, Inc. and Subsidiaries (collectively, the "Company"). An employee is eligible to become a participant in the Plan immediately upon employment. Subsidiaries currently participating in the Plan include ProMedica Central Physicians; Memorial Professional Services; ProMedica Health System, Inc.; Bay Park Community Hospital; The Toledo Hospital; ProMedica Northwest Ohio Cardiology Consultants; ProMedica Genito-Urinary Surgeons; Defiance Hospital, Inc.; Memorial Hospital; Fostoria Hospital Association; ProMedica Physician Group, Inc.; Mercy Memorial Hospital Corporation; Emma L. Bixby Medical Center; Kaitlyn's Cottage, Inc.; ProMedica Monroe Physicians; ProMedica Central Corporation of Michigan; Health Resources, Inc.; ProMedica Innovations, LLC; Community Health Center of Branch County; and, Paramount Care, Inc. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Subsequent to year end, on July 31, 2025, a subsidiary of ProMedica Health Systems, HCR ManorCare, began the process of terminating their defined contribution retirement plans. Previous employees of HCR ManorCare had transitioned to being employees of ProMedica Health System over the past several years. All active employees of the ProMedica system with an account balance in the HCR ManorCare Retirement Savings 401(k) Plan were merged into the Plan. Related to this merger, plan assets of approximately \$49,080,000 were transferred into the Plan in July 2025.

Contributions

The Plan allows participants to contribute up to 75 percent of their compensation, subject to Internal Revenue Code limitations, on pretax or after-tax basis, as designated by the employee. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Plan provides for nondiscretionary employer matching contributions of 100 percent of the participant's contribution, not to exceed 3 percent of the employee's eligible compensation after the employee completes one year of service, as defined by the plan document, and is employed at the end of the plan year with at least 1,000 hours in a given year.

The Plan provides for an employer discretionary contribution. The Company makes annual contributions to the Plan as approved by the Company's board of directors. In 2024 and 2023, the board approved for an additional contribution ranging from 1 percent to 5 percent based on years of service and hours worked.

The Plan also provides for a fixed percentage nonelective employer contribution for certain union employees, as determined by a collective bargaining agreement between the union and the plan sponsor.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Note 1 - Plan Description (Continued)

Participant Notes Receivable

Participants may borrow from their accounts subject to certain maximum and minimum amounts prescribed in the Plan and in the Internal Revenue Code. Participant notes receivable are collateralized by the participant's account balance and bear interest at a rate commensurate with local prevailing rates determined quarterly by the plan administrator.

Vesting

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. Vesting in the Company's contribution portion of their accounts, plus actual earnings thereon, is based on years of service. Participants vest in contributions made by the Company at 20 percent after one year of service and an additional 20 percent after each year of service until they become fully vested after five years of service as further defined in the plan document.

Benefit Payments

Distributions are payable upon retirement, death, disability, termination of employment, or attainment of 59½ years of age in the form of a lump-sum equal to the vested balance of a participant's account. Participants may also receive the value of the participant's vested interest in his or her account in various installment annuities in certain situations, as further defined in the plan document.

Participants may request that all or a portion of their accounts attributable to employee contributions, plus earnings, be distributed in the case of financial hardship, as defined in the plan document.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

The Plan provides for loans to participants, which are party-in-interest transactions that are exempt from the prohibited transaction rules.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions or to pay administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited account balances totaled \$1,677,302 and \$1,386,194, respectively.

The Plan used approximately \$1,511,632 and \$9,610,000 for the years ended December 31, 2024 and 2023, respectively, to reduce employer contributions.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation

The Plan's investments are stated at fair value.

Note 2 - Summary of Significant Accounting Policies (Continued)

The common/collective trust funds are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying net assets. The Plan allows participants to invest in self-directed brokerage accounts. The self-directed brokerage accounts include various investments primarily held in publicly traded securities, which are valued using quoted market prices. The money market funds, demand notes, certificates of deposit, and interest-bearing cash held in the self-directed brokerage account are valued at fair value based on their outstanding balances. All other investments are valued using quoted market prices. See Note 5 for additional information.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Company, as provided in the plan agreement.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including September 19, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Fidelity Management Trust Company (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

Note 4 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

There were no unfunded commitments or redemption restrictions on the investments described above.

Note 6 - Transfer In

During 2024, \$19,000,000 was transferred from the ProMedica Health System, Inc. Cash Balance Retirement Plan (Cash Balance Plan) into the Plan. These funds were excess plan assets remaining in the Cash Balance Plan after termination and liquidation of participant benefits. The funds were transferred to this Plan and will be used to reduce future employer contributions. During 2024, \$754,412 were used to offset employer contributions. The remaining amounts, totaling approximately \$18,666,000 at December 31, 2024 was unallocated to participants, and invested in common collected trust funds.
