Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Seneca Companies 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Notes to Financial Statements

Note 1. Plan Description

The following description of the Seneca Companies 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General and eligibility: The Plan is a defined contribution plan covering employees of Seneca Companies, Inc. and Seneca Waste Solutions, Inc. (collectively, the Companies). Eligible employees may enter the Plan on the first day of the month following employment of at least one month. The Plan has an automatic deferral provision where employees are automatically enrolled in the Plan at a deferral rate of 5% unless the employee opts for a different deferral rate or not to participate. Bargaining and leased employees are not allowed to participate in the Plan. To be entitled to discretionary employer matching contributions, a participant must be employed on the last day of the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions and investment options: Each year, participants may contribute pretax and Roth amounts up to the maximum limitations imposed by the Internal Revenue Service. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Companies may make a discretionary matching contribution equal to a percentage determined annually by the Companies' Boards of Directors. Participants direct the investment of their contributions and any employer contributions into various investments offered by the Plan. Participants may currently invest their contributions into various mutual funds, common/collective trusts and pooled separate accounts. Participants may change their investment options daily. The discretionary matching contribution total approximately \$861,000 and \$845,000 for the years ended December 31, 2024 and 2023, respectively.

Participant accounts: Each participant's account is credited with the participant's contribution and the Companies' discretionary matching contribution, and an allocation of Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions plus actual earnings thereon. Vesting of discretionary employer matching contributions plus actual earnings thereon is based on years of continual service (minimum of 1,000 hours of service per year). A participant is 20% vested after two years of service and continues to vest at the rate of 20% for each successive year of service until 100% vested after six years of service.

Payment of benefits: Upon termination of service due to death, disability or retirement, a participant may roll over the amount into another qualified plan or elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or a single-sum distribution of a portion of the vested interest of his or her account. For vested account balances of \$7,000 and less, the participant receives the value of the vested interest in his or her account as a lump-sum distribution.

Note 1. Plan Description (Continued)

Notes receivable from participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the highest outstanding loan balance in the previous year, or 50% of their vested account balance. Terms range from one to five years or, in the case of the purchase of a principal residence, up to 15 years. Notes receivable transactions are treated as a transfer to (from) the investment fund from (to) the notes receivable from participant's fund. The notes receivable are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan Administrator. Principal and interest are paid ratably through payroll deductions. Notes receivable outstanding at December 31, 2024 and 2023, bear interest at rates ranging from 4.25% to 9.50%.

Forfeited accounts: Forfeitures are created when participants terminate employment before coming entitled to their full benefits under the Plan. Forfeitures are used to reduce plan expenses or future employers' contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$138,800 and \$108,200, respectively. During the year ended December 31, 2024, forfeitures reduced employer contributions by approximately \$101,000 from forfeited nonvested accounts.

Note 2. Significant Accounting Policies

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements set forth below.

Basis of accounting: The financial statements of the Plan are prepared under the accrual basis of accounting.

Contributions: Contributions from the Plan participants and the matching contributions from the employer are recorded in the year in which participant compensation is earned.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Valuation of investments and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent and defaulted notes receivable are treated as distributions based upon the terms of the plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of benefits: Benefits are recorded when paid.

Note 2. Significant Accounting Policies (Continued)

Administrative expenses: Administrative expenses may be paid by the Company or the Plan, at the Company's discretion. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions to participants are charged directly to the participant's account and are included in administrative expenses. Other reasonable expenses of administration, including investment-related expenses, are paid from the Plan and are included in administrative expenses.

Subsequent events: The Plan Administrator has evaluated subsequent events through September 26, 2025, the date the financial statements were available to be issued.

The Trustee also certified to the completeness and accuracy of \$4,287,798 of net appreciation in fair value of investments, \$59,511 of interest income on notes receivable from participants and \$142,718 of interest and dividends for the year ended December 31, 2024.

Note 4. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification (ASC) Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Pooled separate accounts invest primarily in domestic and international stocks, commercial paper or single mutual funds. The net asset value is used as a practical expedient to determine fair value for these accounts. Each pooled separate account provides for redemptions by the Plan at reported net asset values per share, with little to no advance notice requirement.

Common/collective trusts: Common collective trust funds are composed primarily of fully benefit-responsive investment contracts that are valued at the net asset value of units of the common collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur immediately. If the Plan initiates a full redemption of the collective trust, no notice to the issuer is required.

Mutual funds: Mutual funds are reported at fair value based on the quoted market price of the fund and are classified within Level 1 of the valuation hierarchy.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. Plan management evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits.

Note 5. Plan Termination

Although they have not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 6. Plan Tax Status

The Plan adopted a nonstandardized form of a pre-approved plan sponsored by Principal Life Insurance Company. The pre-approved plan has received an opinion letter dated June 30, 2020, from the Internal Revenue Service as to the pre-approved plan's qualified status. The Plan has been amended since receiving the opinion letter. The Plan Administrator believes the Plan and trust are operating in a manner that does not jeopardize this tax status.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and had taken no uncertain tax positions that require adjustments to the financial statements; therefore, no provision or liability for income taxes has been included in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Related-Party Transactions and Party-in-Interest Transactions

Certain Plan investments are shares of pooled separate accounts and common/collective trusts managed by Principal Trust Company, the trustee as defined by the Plan. These transactions qualify as party-in-interest transactions. The Plan incurred \$120,689 of administrative fees to the trustee for the year ended December 31, 2024. The Plan sponsor pays certain accounting and auditing fees relating to the Plan and provides certain administrative services at no cost to the Plan.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9. Prohibited Transactions

During 2024, the Plan sponsor inadvertently failed to deposit approximately \$643 of participant contributions within the required timeframe as stated by the United States Department of Labor regulations. The Plan sponsor deposited lost earnings in the amount totaling approximately \$7 to correct this failure subsequent to year-end in 2025. The Plan sponsor intends to file Form 5330 and intends to pay applicable excise tax to the Internal Revenue Service. The correction and any excise taxes, if applicable will be made from the Plan sponsor's assets and not from assets of the Plan.
