Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Basis for Opinion

Responsibilities of Management for the Financial Statements

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedules Required by ERISA

The supplemental schedules of Schedule H Item 4i – Schedule of Assets (Held at End of year), is presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO THE FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the Lipsitz Industries Employees Profit Sharing Plan and Trust (the "Plan") provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan which is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Board of Trustees oversees governance of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees.

The Plan is sponsored by M. Lipsitz & Co., Ltd. (the "Company") for the benefit of substantially all of the employees of the Company's affiliates, including M. Lipsitz & Co., Ltd., Bryan Iron & Metal, Ltd., Terrell Iron & Metal, Ltd., Tyler Iron & Metal, Ltd., Texas Commercial Waste, Inc., San Antonio Iron and Metal, Ltd., Oklahoma Iron & Metal, Ltd., Tall City Metal Recycling, L.P., Market Street Recycling, Ltd., Brownwood Iron & Metal, Monohans Iron & Metal, Rockdale Iron & Metal, Kempner Iron & Metal, and Centex Scrap & Metal.

Eligibility

Any eligible employee who has completed one year of service and attained age 18 may participate in the Plan.

Employee Contributions

Pursuant to Section 401(k) of the Internal Revenue Code (the "IRC"), participants may contribute up to the lesser of 100% of their compensation or \$23,000 for 2024. Employees who are age 50 or older may also make catch-up contributions of up to \$7,500 for 2024.

Employer Contributions

The Plan is classified as a "safe harbor 401(k) plan." If the Company elects to satisfy the safe harbor provision, the Company will make a contribution equal to 3% of the participant's base compensation for the Plan year. The Company may also elect to contribute to the Plan a discretionary profit-sharing contribution.

As of January 1, 2018, the Plan reinstated its safe harbor nonelective contribution and appropriately satisfied the safe harbor provisions for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's discretionary profit-sharing contribution, (b) safe harbor contribution, if made by the Plan, and (c) Plan earnings (losses), and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

The participants' vesting percentage is dependent upon the number of years of service the participant has earned and is based on the schedule below. The participant will always be 100% vested in the employee contributions to the Plan and the employer contributions to the Plan that are required to maintain the Plan as a safe harbor 401(k) plan, in the event a nonelective safe harbor contribution is made.

Forfeitures

A forfeiture is the non-vested portion of a terminated participant's account balance. The forfeited amount remains in the Plan and is first used to pay any administrative expenses and any remaining amounts are used to reduce any subsequent employer contributions. As of December 31, 2024, and 2023, there were \$67,624 and \$70,423 of forfeitures that have not yet been applied to expenses or contributions. Also, in 2024, \$6,000 was used to reduce employer contributions or pay administrative expenses.

Payment of Benefits

Upon termination of service due to death, disability or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account.

Investment Options

The assets of the Plan are allocated to the various funds at the direction of the participant.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of the financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of Plan assets and liabilities, and the changes therein, at the date of the financial statements. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies utilizing information provided by investment advisers, custodians, and market data. See Note 5 for further discussion on fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

Certain administrative functions are performed by officers or employees of the Company. No such officers or employees receive compensation from the Plan. Certain administrative expenses may be paid directly by the Company or the Plan, such as recordkeeping, trustee, legal and accounting fees. Investment related expenses are included in net depreciation of fair value of investments.

Payment of Benefits

Benefits are recorded when paid.

3. ASSET INFORMATION CERTIFIED BY TRUSTEE (UNAUDITED)

At December 31, 2024 and 2023, the Plan's investments were held by JP Morgan Investment Holdings LLC (the "Trustee").

The following is a summary of the Plan's financial information that is included in the financial statements based on information certified by the Trustee as complete and accurate in accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

During 2024, the Plan's investments (including gains and losses on investments bought, sold, as well as held during the year), appreciated in value by \$827,018.

4. EMPLOYER CONTRIBUTIONS RECEIVABLE

The Company can contribute a nonelective safe harbor contribution and a discretionary profit-sharing contribution to the Plan. The Company contributed a safe harbor contribution of \$416,742 and \$398,123 for the 2024 and 2023 plan year, respectively. The Company contributed a profit-sharing contribution of \$90,736 and \$304,748 for the 2024 and 2023 plan year, respectively. Receivables of \$507,478 and \$702,871 are recorded as of December 31, 2024 and 2023, respectively, for employer contributions.

5. FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair values using Level 1 inputs because they generally provide the most reliable evidence of fair value.

Following is a description of the valuation methodologies and approaches used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual funds - valued at the daily closing price as reported by the fund. These funds are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at the price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust funds - valued at the net asset value of units of the underlying investments of the collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant's transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

6. RECONCILIATION OF FINANCIAL STATEMENTS TO SCHEDULE H OF FORM 5500

The financial statements agree to the Schedule H of Form 5500 in entirety for the years ended December 31, 2024 and 2023.

7. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by the Trustee of the Plan. These transactions qualify as exempt party-in-interest transactions. There was no direct compensation paid for investment management services during the year ended December 31, 2024.

8. TAX STATUS

The Internal Revenue Service has determined and informed the company by a letter dated November 14, 2022 that the plan and related trust are designed in accordance with applicable sections of the IRC. Although the plan has been amended since receiving the determination letter, the most recent plan document date being November 2020, the plan administration and the plan's tax counsel believe that the plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for three years after filing.

9. PLAN TERMINATION

Although there is no expressed intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

10. RISKS AND UNCERTAINTIES

The Plan invests in a variety of investment funds. Investments in general are exposed to various risks, such as interest rate, credit, and overall volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

11. SUBSEQUENT EVENTS

For the year ended December 31, 2024, the Company has evaluated subsequent events for potential recognition and disclosure through September 25, 2025, the date of financial statement issuance. No events requiring disclosure were noted.
