(1) DESCRIPTION OF PLAN

The following description of the United Insurance 401(k) Retirement Savings Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The plan is a defined contribution plan covering all full-time employees of UIG, Inc. and its subsidiary, RJC Insurance LLC, who work at least 20 hours a week and are age 21 or older. The Plan is subject to the provisions of ERISA. The Board of Trustees is responsible for oversight of the Plan. Significant costs of administering the Plan are absorbed by the Plan Sponsor. Expenses paid by the sponsor are not included in these financial statements.

Contributions

Each year, participants may contribute up to \$23,000 (or \$30,500 if age 50 or more) of annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may designate these contributions as either pre-tax or after tax (ROTH) contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes a discretionary match of 50% on the first 7% of deferred salary.

Participant Accounts

Each participant's account is credited with participant's contributions and Company matching contributions. Participant accounts are charged with an allocation of administrative expenses that are paid by the plan. Allocations are based on participant earnings, account balances, or specific participant transaction, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after 6 years of service at the rate of 20 percent per year of service.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or partial withdrawals or installments but only with respect to minimum required distributions, over a period of not more than your assumed life expectancy (or your and your beneficiaries assumed life expectancies).

In-Service Distributions

Participants may be entitled to receive an in-service distribution. However, this distribution is not in addition to their other benefits and will, therefore, reduce the value of the benefits they will receive at retirement. This distribution is made at their election and will be made in accordance with the forms of distributions available under the Plan. The law restricts in-service distributions from certain accounts which are maintained for participants under the Plan before they reach age 59 1/2.

The following limitations apply to in-service distributions:

- The minimum amount you can receive as an in-service distribution is \$1,000
- In-service distributions can only be made from accounts which are 100% vested

Forfeitures

Amounts which become forfeited due to termination are available to reduce the Employer's matching contribution or plan expenses each year. During 2024, forfeitures of \$15,290 were used to reduce the administrator fees. As of December 31, 2024, forfeitures of \$8,251 were available to reduce the match or pay plan expenses.

(2) SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment Income

The plan's investments pay dividends that are reinvested into the plan. These dividends are reported together with the changes in fair value in the accompanying statement of changes in net assets available for benefits since the breakdown is unknown. The plan custodian does not provide the information necessary to report the dividend income separately from the changes in fair value which is required by generally accepted accounting principles. All of the affected investments are included in the certification from the custodian discussed further in Note 9.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. There were no material excess contributions for the year ended December 31, 2024.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has reviewed subsequent events through August 19, 2025, the date that these financial statements were available to be issued and determined that no additional adjustments or disclosures are required in order for these financial statements to be fairly stated.

(3) FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and December 31, 2023.

- Investment securities in registered investment companies are valued at their quoted market prices from an active market as of the reporting date.
- The fair value of the guaranteed interest accounts reflects the discounted cash flows based on the assets' stated interest rates and current market rates of similar assets with similar maturities.

(4) PARTIES IN INTEREST AND PLAN EXPENSES

The Plan contracts with various service providers to manage its investments, provide recordkeeping and administration services and investment advice. All plan investments, including cash, in the amount of \$13,091,086 are managed by John Hancock Retirement Plan Services. John Hancock is also the record-keeper for the Plan. Healey and Associates is the third-party administrator for the plan. These service

providers qualify as parties in interest, and fees paid to them from plan assets are considered party in interest transactions.

Fees charged to the plan by these service providers amounted to \$70,369 during 2024. The other expenses were absorbed by the plan sponsor and are not included in these financial statements.

(5) PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

(6) TAX STATUS

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the plan is qualified, and the related trust is tax-exempt.

The Plan has implemented certain requirements by Division T of the Consolidated Appropriations Act of 2023 (SECURE 2.0), which are laws that change the Plan to further delay required minimum distributions, expand availability of the plan to certain part-time workers, increase the catch-up contribution limits for certain participants as well as various voluntary provisions which may or may not be elected by the plan sponsor. The plan is currently being operated in accordance with the mandatory provisions of SECURE 2.0 and the plan sponsor has until December 31, 2026 to decide on the voluntary provisions. Written amendments to the Plan to reflect these operational changes will be formalized at a later date in accordance with applicable law and IRS guidance.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the U.S. Government. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(7) RISKS AND UNCERTAINTIES

The Plan invests in various mutual funds, which invest in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Additional risks include, but are not limited to military conflicts in Europe, the oil and gas market, supply chain issues and inflation. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

(8) RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

For the year ended December 31, 2024, Form 5500 has been prepared on the same basis of accounting that is used to prepare the accompanying financial statement. As a result, there are no differences in the net assets available for benefits between the financial statements and the Form 5500 for 2024.
