Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Employees' Profit Sharing and 401(k) Plan of Supreme Systems, Inc. (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Notes to Financial Statements

Note 1. Description of the Plan

The following description of the Employees' Profit Sharing and 401(k) Plan of Supreme Systems, Inc. (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan whereby eligible employees of Supreme Roofing, LP, Supreme Systems, Inc., Supreme Systems, Inc. (a Massachusetts corporation), and Supreme Roofing Done Right, LLC (collectively referred to as the Company) are permitted to make pretax contributions that are tax-deferred under Section 401(k) of the Internal Revenue Code (IRC). The Plan was established in April 1988 and last restated on January 1, 2022. The Plan is intended to satisfy the requirements for a qualified retirement plan under the appropriate provisions of the IRC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees are eligible to participate upon attaining the age of 21 and completing three months of service. The Plan's entry dates are on January 1, April 1, July 1, and October 1.

Contributions

Participants may contribute up to 100 percent of pretax compensation, as defined in the Plan document, not to exceed \$23,000 in 2024 in accordance with Internal Revenue Service (IRS) regulations. In addition, those participants, who are over age 50 or turning age 50 on or before December 31, 2024, are eligible for an additional catch-up contribution of \$7,500 in 2024. Participants may also contribute amounts representing distributions from other qualified defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan is a Safe Harbor Plan. The safe harbor matching contribution is equal to 100% of the first 3% of base compensation that the participant contributes to the Plan, plus 50% of the amount contributed by the participant in excess of 3%, but not to exceed 5% of eligible compensation. The Company made matching contributions of \$214,780 for the year ended December 31, 2024. The Plan also allows the Company to make additional discretionary profit-sharing contributions. The rate and amount of these additional discretionary profit-sharing contributions are determined annually by the Company. In 2024, the Company did not make discretionary profit-sharing contributions.

Participant accounts

Under the Plan, each participant's account is credited with the participant's voluntary contributions, employer contributions and plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

Note 1. Description of the Plan, continued

Vesting

Participants are immediately vested in their contributions plus actual earnings or losses thereon. Participants are immediately vested in the Company's safe harbor matching contributions. Vesting in the Company's non-safe harbor contributions plus actual earnings or losses thereon is based on years of service. Participants vest 20% per year after two years of service and are 100% vested after six years of service.

Notes receivable from participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is determined by the Plan Administrator, as defined in the Plan document. Principal and interest is paid through payroll deductions.

Benefits paid to participants

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

Forfeitures

Forfeited, nonvested accounts are retained in the Plan and may be used to restore forfeitures to participants, reduce Company contributions or to pay Plan expenses. At December 31, 2024 and 2023, unused forfeited nonvested employer contributions amounted to \$2,248 and \$2,141, respectively. During the year ended December 31, 2024, amounts forfeited were \$0, gain on the forfeiture account totaled \$107, and a total of \$0 in forfeitures were allocated to participant balances.

Note 2. Summary of significant accounting policies

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Note 2. Summary of significant accounting policies, continued

Investment valuation and income recognition

Investments are reported at fair value except for the fully benefit-responsive investment contract which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Contract value is the relevant measurement attribute for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation, or depreciation, includes the Plan's gains and losses on investments purchased and sold as well as those held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions based on the terms of the Plan agreement.

Administrative expenses

Reasonable administrative expenses related to maintaining the Plan may be paid by the Plan and charged to the participants' accounts to the extent not paid by the Company. Certain Plan expenses, such as transaction withdrawal fees, or distributions from the Plan, are deducted from individual participants' accounts or investment income.

Payment of benefits

Benefit payments to participants are recorded when paid.

Subsequent events

The Plan Administrator has evaluated subsequent events through September 26, 2025, the date the financial statements were available to be issued.

Notes to Financial Statements

Note 3. Certified investments

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained or derived from information provided to Plan management and certified as complete and accurate by Voya Retirement Insurance and Annuity Company.

Note 4. Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Accounting Standards Codification 820 (ASC 820) are described below:

Level 1 – Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Pooled separate accounts are valued at their "accumulation unit value" (AUV). The pooled separate accounts are valued daily as the number of accumulation units held multiplied by the AUV. The AUV is first established when a new fund starts (typically beginning AUV is \$10) and is then determined daily based on the net asset value (NAV) of shares of the underlying fund, the fund's dividends, and the contract's separate account charges. The NAV is generally based on the fair value of the underlying investments held by the pooled separate account less its liabilities. The AUV, as provided by the custodian, is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the pooled separate account will sell the investment for an amount different than the reported AUV.

Note 5. Investment contract with Voya Retirement Insurance and Annuity Company

The Plan entered into a benefit-responsive investment contract with Voya Retirement Insurance and Annuity Company (VRIAC). VRIAC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by VRIAC. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$934,766 and \$1,056,706, respectively. The average yields and crediting interest rates were 1.50% and 1.37% for the years ended December 31, 2024 and 2023, respectively.

Certain events limit the Plan's ability to transact at contract value with VRIAC. Such events include a percentage limitation or equity wash restriction. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with the Plan participants are probable of occurring. A termination date may be declared with thirty days prior written notification of intent to terminate by either the Plan Sponsor or Voya Retirement Insurance and Annuity Company, subject to the provisions of the investment contract.

Note 6. Related-party transactions and party-in-interest transactions

Plan assets are held and managed by the custodian. The custodian invests cash received, interest income and dividend income as directed by the participants of the Plan. The custodian also makes distributions to participants.

Parties-in-interest are defined under DOL regulations as any fiduciary to the Plan or party rendering services to the Plan, the employer and certain others. As such, transactions conducted with the Company and the custodian of the Plan qualify as party-in-interest transactions.

Certain administrative functions are performed by employees of the Company. However, no such employees receive compensation from the Plan. The Company and the Plan share in administrative expenses for the Plan.

Note 7. Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, participants would become 100 percent vested in their employer contributions.

Note 8. Tax status

Effective June 30, 2020, the Plan adopted a non-standardized form of a prototype profit sharing plan sponsored by RetirementPlans.Com, LLC. The prototype profit sharing plan has received an opinion letter from the IRS as to the plan's qualified status. The prototype profit sharing plan opinion letter has been relied upon by this Plan. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 9. Risks and uncertainties

The Plan may invest in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10. Delinquent participant contributions

As reported on Schedule H, line 4(a) - Schedule of Delinquent Participant Contributions for the year ended December 31, 2024, certain participant contributions were not remitted to the Plan within the time frame specified by the Department of Labor, thus constituting nonexempt transactions between the Plan and the Company.

Delinquent participant contributions amounting to \$400 relating to the 2024 plan year were deposited to the Plan during 2025. The associated lost earnings and excise taxes were paid during 2025.
