**NOTE 1 - DESCRIPTION OF PLAN**

The following is a description of the McBride Orthopedic Hospital Group Medical and Dental Plan Trust (the "Plan"). Participants should refer to the trust document for a detailed description of the Plan's provisions.

**General**

The Plan is an employee welfare benefit plan sponsored by McBride Clinic, Inc. (the "Company"). The effective date of the Plan is December 14, 2004, and the trustee is MidFirst Trust Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The purpose of the Plan is to provide certain medical and dental benefits to the Company's employees and covered dependents who meet the eligibility requirements set forth in the Plan document. Employees should refer to the Plan document for information on eligibility requirements and other detailed provisions of the Plan.

**Contributions**

The Plan is funded by direct contributions from both the Company and its employees. Amounts contributed to the Plan include amounts sufficient for payment of current claims and administrative expenses.

**Payment of Benefits**

Benefits are paid by a claims administrator according to the schedule of benefits. Claims are generally paid from assets in the trust; however, the Plan maintains stop-loss reinsurance coverage to protect the Plan from catastrophic claims. The reinsurance coverage limitations vary each year based upon the claims experience of the Plan. Specific and aggregate stop-loss limits for the year ended December 31, 2024, were approximately \$150,000 and \$6,171,000, respectively.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The Plan's policy is to prepare its financial statements on the modified cash basis. Therefore, additions and deductions to net assets available for benefits are recognized only as cash is received or paid, and receivables, payables (except claims incurred but not reported) and accrued expenses are not reflected.

**Use of Estimates**

The preparation of financial statements requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Contributions**

Contributions from Plan participants and contributions from the Company are recorded in the year in which they are received.

**Payment of Benefits**

Benefits are recorded when paid.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Administrative Expenses**

The Company absorbs certain administrative costs of the Plan. Other administrative costs paid from Plan assets include fees for the processing of claims, reinsurance premiums and fees, trust fees and professional services.

**Estimated Claims Incurred but not Reported**

Claims incurred but not reported are estimated based on actual claims for services rendered during the Plan year but paid subsequent to the Plan year end. The Plan's management believes this method provides the best possible estimate of claims due and any differences from an actuarial determination would be immaterial.

**NOTE 3 - RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

MidFirst Trust Company (the trustee) provides to the Plan certain administrative services for which fees are charged to the Plan. Fees paid by the Plan amounted to \$3,000 for the year ended December 31, 2024.

The Kempton Group, Inc. (medical claims administrator), provides to the Plan certain accounting and administrative services for which fees are charged to the Plan. Fees paid by the Plan for various Plan management services amounted to \$311,950 for the year ended December 31, 2024.

Delta Dental (dental claims administrator) provides to the Plan certain accounting and administrative services for which fees are charged to the Plan. Fees paid by the Plan for various Plan management services amount to \$35,280 for the year ended December 31, 2024.

Medcom (pre-certification and large case manager) provides utilization review services for acute in-patient hospital confinement; 23-hour observation and out-patient pre-authorization for a specified list of procedures for which fees are charged to the Plan. Fees paid by the Plan for the review services amounted to \$24,500 for the year ended December 31, 2024.

HealthCare Highways (PPO network), provides access to PPO network that is utilized by the Plan for which fees are charged to the Plan. Fees paid by the Plan for the PPO network access amounted to \$120,475 for the year ended December 31, 2024.

Payer Compass (PPO network), provides access to PPO network that is utilized by the Plan for which fees are charged to the Plan. Fees paid by the Plan for the PPO network access amounted to \$27,605 for the year ended December 31, 2024.

The Phia Group, LLC (PPO network), provides access to PPO network that is utilized by the Plan for which fees are charged to the Plan. Fees paid by the Plan for the PPO network access amounted to \$9,152 for the year ended December 31, 2024.

ScriptCare, LTD (PPO network) provides access to PPO network that is utilized by the Plan for which fees are charged to the Plan. Fees paid by the Plan for the PPO network access amounted to \$94,894 for the year ended December 31, 2024.

**NOTE 4 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**NOTE 6 - TAX STATUS**

The Plan is established as a taxable trust pursuant to Section 419(e)(3)(B) of the Internal Revenue Code. The Plan's assets are held by MidFirst Trust Company in trust pursuant to an agreement with the Company. The Company believes the Plan qualifies and operates in accordance with applicable provisions of the Internal Revenue Code.

Authoritative accounting standards require the Plan to evaluate its tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 7 - RISKS, UNCERTAINTIES AND CONCENTRATIONS**

The Plan's financial instruments that are exposed to concentrations of credit risk consist primarily of cash and cash equivalents. The Plan places its cash and cash equivalents with one financial institution. At times, such amounts may be in excess of the FDIC insured limit. The Plan has never experienced any losses related to these balances.

**NOTE 8 - SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through September 23, 2025, which is the date the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.
