- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting described in Note 2.

Accordingly, the objective of the ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note 2.

Note 1 - Plan Description

The following description of HLP B Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees who work outside the Cleveland, Ohio office location and all partners of Hahn Loeser & Parks LLP (the "Partnership"), as defined by the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Employees and partners are eligible to participate in the Plan on the date of employment.

Contributions

Under the Plan, only partnership contributions are allowed. Subject to the rules of the Plan, the Partnership may individually determine each participant's contribution. The Partnership made a discretionary contribution of 3 percent to each nonpartner participant based on eligible compensation and a discretionary contribution ranging between 0 percent and 6.67 percent to each partner participant based on eligible compensation. Due to the modified cash basis of accounting, contribution revenue received in 2024 includes approximately \$678,000 related to 2023 contributions and approximately \$273,000 related to 2024 contributions.

Participant Accounts

Each participant's account is credited with allocations of the Partnership's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

The vesting schedule for participants ranges from 20 percent after two years of service, increasing for each additional year in 20 percent increments, until obtaining 100 percent after six years.

Participant Notes Receivable

The Plan allows participants to borrow against their vested account balances in the Plan. Participants may borrow from their accounts a minimum of \$1,000, and no more than three loans may be outstanding at any time. The loans are secured by the balance in the participant's account and bear an interest rate of prime plus 1.5 percent as of the loan date. Principal and interest are paid ratably through monthly payroll deductions over a reasonable period of time, as determined by the Plan.

Benefit Payments

Upon disability, retirement, death, or termination of employment for other reasons, as defined in the plan document, a participant shall receive payment of the value of his or her vested account in the form of annuities unless an election is made to waive the annuity form of benefit for direct rollover or cash distribution in the form of a lump-sum or partial payment. Automatic cash-out of participants' vested account balances of \$5,000 or less is required under the Plan.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future partnership contributions or to pay administrative expenses of the Plan.

Note 1 - Plan Description (Continued)

Party-in-interest Transactions

Certain plan assets are in investment funds managed by John Hancock Trust Company LLC or its affiliates. John Hancock Trust Company LLC is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Termination

While it has not expressed any intent to do so, the Partnership has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The Plan prepares its financial statements on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America (GAAP). Revenue is recognized when cash is received, expenses are recognized when paid, and investments are recognized at fair value. On a GAAP basis of accounting, revenue is recognized as earned and expenses are recognized when the obligations are incurred.

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative costs are paid by the Partnership. These transactions qualify as party-in-interest transactions.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

December 31, 2024 and 2023

Note 2 - Summary of Significant Accounting Policies (Continued)

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including September 3, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

John Hancock Trust Company LLC (the "Trustee") holds the Plan's investments and participant notes receivable, other than the investments included within the self-directed brokerage accounts, and executes all investment transactions. The investment and participant notes receivable balances and related investment income included in the accompanying financial statements and supplemental schedule of assets held at end of year, other than the investments included in the self-directed brokerage accounts, are based solely on information certified by the Trustee.

The Plan's investments in the self-directed brokerage accounts totaling approximately \$2,940,000 and \$1,526,000 as of December 31, 2024 and 2023, respectively, and related investment income of approximately \$184,000 for the year ended December 31, 2024 were not certified by John Hancock Trust Company LLC.

Note 4 - Tax Status

The preapproved plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

Note 5 - Fair Value Measurements (Continued)

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

Money Market Fund and Mutual Funds

The money market fund and mutual funds are valued at quoted prices reported in active markets.

Common/Collective Trust Fund

The common/collective trust fund is valued at net asset value per share or its equivalent of the fund, which is based on the fair value of the fund's underlying net assets. There are no redemption restrictions or unfunded commitments on these investments.

Self-directed Brokerage Accounts

The Plan allows participants to invest in self-directed brokerage accounts. The self-directed brokerage accounts include various investments in publicly traded securities and interest-bearing cash. The publicly traded securities are valued at the quoted prices reported in active markets while the interest-bearing cash is valued based on outstanding balances.
