To the Participants and Investment Committee of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of SAK 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). 1. DESCRIPTION OF THE PLAN

The following description of the SAK 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established April 11, 2008, as a defined contribution plan for the benefit of certain (as defined in the Plan document) employees of Sunlight Peak, LLLP dba SAK, LLC (the "Company" or "Employer"). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan has an automatic enrollment feature for new non-union employees and an automatic increase feature for participants who are not covered under a collective bargaining agreement. Automatic enrollment for a new participant results in withholding 3% of the participant's eligible compensation. Automatic increase for participants results in automatic annual increases of 1% until the participant's contribution percentage equals 10% or the election is changed by the participant. Employees can opt out of the automatic enrollment or the automatic annual increase by completing the appropriate documentation.

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. The effective dates of the provisions within SECURE 2.0 vary through 2026. The Plan has implemented all of the requisite applicable changes through December 31, 2024. The Plan has until the end of the first Plan year beginning on or after January 1, 2026, to amend the Plan for the balance of the changes related to SECURE 2.0 which impact the Plan. The Plan intends to implement these provisions by January 1, 2026.

Contributions

Plan participants may elect to contribute up to 90% of annual compensation, as defined in the Plan agreement. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants eligible to make catch-up contributions may contribute up to 75% of annual compensation. Contributions are subject to certain IRS limitations. Participants may also contribute amounts representing rollovers from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. As defined by the Plan, the Employer has elected a Safe Harbor matching contribution. The Safe Harbor match is 100% of the first 3% of the eligible participant's compensation contributed to the Plan and 50% of the next 2% of the eligible participant's compensation contributed to the Plan. Participants who are covered under a collective bargaining agreement are not eligible for Safe Harbor match contributions.

Participant accounts

Each participant's account is credited with the participant's contribution, allocations of the Company's matching contributions and Plan earnings. Allocations are based on participant earnings and account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants shall at all times be one hundred percent (100%) vested in salary deferrals, rollovers, transfer contributions and matching contributions, plus actual earnings thereon.

Notes receivable from participants

A participant, who is also an employee, may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Participants may only have one loan outstanding at any time. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined quarterly by the Plan Administrator. The loan term may not exceed five years except for the purpose of purchasing a principal residence, in which case the term may not exceed fifteen years. At December 31, 2024, notes receivable from participants carry interest rates from 4.25% to 9.50% and mature at various dates through September 2039.

Payment of benefits

Upon termination of service due to death, disability, regular termination or retirement, a participant may receive a lump-sum benefit payment equal to the value of the participant's vested interest in his or her account. Participants who have attained the age of 59 ½ years may elect to withdraw all or any part of their vested account balance. Additionally, participants may elect distributions under certain circumstances of financial hardship, as defined in the Plan agreement.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect certain amounts reported in the financial statements and related notes. Actual results could differ from those estimates.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Investment valuation and income recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by investment advisers and the custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net realized and unrealized appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan agreement. Note balances are secured by participant accounts.

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan to the plan's recordkeeper, a party-in-interest, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Investment-related expenses are included in net realized and unrealized appreciation in fair value of investments.

Subsequent events

The Plan has evaluated subsequent events through August 7, 2025, the date the financial statements were available to be issued.

3. CERTIFICATION OF INVESTMENT INFORMATION

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the ERISA. Accordingly, as permitted under such election, the Plan Administrator has obtained a certification from Bank of America, N.A. (the "Trustee"), that all of the information included in the accompanying financial statements and Schedule of Assets (Held at End of Year) is complete and accurate. We have been informed by the Plan Administrator that Bank of America, N.A. holds the Plan's investment assets and executes investment transactions. Information related to the investments in the accounts of Bank of America, N.A., investment income, and all information appearing in the accompanying statements and Schedule of Assets (Held at End of Year) is presented in reliance solely upon these certifications.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability. There were no Level 2 investments for the years ended December 31, 2024 and 2023.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement. There were no Level 3 investments for the years ended December 31, 2024 and 2023.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money Market Funds – Valued at quoted market prices.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Fund – The Plan's collective trust investments are held in separate investment accounts, which are valued using the readily determinable fair value ("RDFV"). The RDFV is based on the value of the underlying assets owned by the fund, which include a mix of U.S. and international equities, fixed income investments, target date funds, and short-term investments. The collective trust investments held by the Plan publish their RDFV daily and transact at that price. There are currently no redemption restrictions or unfunded commitments on these investments.

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will remain 100% vested in their accounts.

6. INCOME TAX STATUS

The Trustee has obtained an opinion letter dated June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the prototype plan document was in compliance with applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any tax periods in progress.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
