Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Gibson Area Hospital & Health Services Employees' 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Gibson Area Hospital & Health Services Employees' 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Basis for Opinion

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE A - DESCRIPTION OF PLAN

The following description of the Gibson Area Hospital & Health Services Employees' 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General

The Plan was established March 1, 2005. The Plan is a defined contribution plan covering certain employees of Gibson Area Hospital & Health Services (the Hospital). All employees who have completed one hour of service are covered under the Plan. Employer contributions will begin when the employee attains one year of service and has reached the age of 21. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

2. Contributions

The Plan permits eligible employees through a salary reduction election to contribute a portion of their salary up to the maximum percentage allowable, not to exceed the limits prescribed by law. Employee rollover contributions are also permitted. The Hospital made 100% matching contributions of 4% of employees' compensation for the years ended December 31, 2024 and 2023. Additional amounts may be contributed at the option of the Hospital's Board of Directors. There were no additional amounts contributed by the Hospital during 2024 and 2023.

3. Participant Accounts and Forfeited Accounts

Each participant's account is credited with the participant's contribution and actual earnings, an allocation of the Hospital's contribution and Plan earnings. Allocations of Hospital contributions are based on participant contributions and compensation. Allocations of Plan earnings are based on participants' account balances. Excess employer contributions are reported as forfeitures and are used to reduce future administrative expenses and employer contributions. At December 31, 2024 and 2023, the Plan retained \$ 7,812 and \$ 8,877 in forfeitures, respectively.

4. Vesting

Participants are immediately vested in all contributions and related earnings.

NOTE A - DESCRIPTION OF PLAN - Continued

5. Investment Options

Upon enrollment in the Plan, a participant may direct contributions to selected investments as made available and determined by the Plan's Custodian. Participants may change their investment options at any time pursuant to procedures established in the Plan document.

6. Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$ 1,000 up to a maximum equal to the lesser of \$ 50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at the prevailing interest rate. Principal and interest is paid ratably through payroll deductions.

7. Payment of Benefits

A participant will be eligible to receive retirement benefits on his normal retirement date provided by the value in his/her individual account. The Plan also provides for early retirement, deferred retirement, disability retirement and death benefits.

8. Plan Termination

Although it has not expressed any intent to do so, the Hospital may terminate the Plan at any time in whole or in part subject to the provisions of ERISA. In the event of Plan termination, the value of each individual account shall be distributed by the Plan administrator under one of the settlement options available under the Plan.

NOTE B - SUMMARY OF ACCOUNTING POLICIES

1. Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

NOTE B - SUMMARY OF ACCOUNTING POLICIES - Continued

2. Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Quoted market prices are used to value investments. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year end.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

3. Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

4. Payment of Benefits

Benefits are recorded when paid.

5. Subsequent Events

The Plan assessed events that have occurred subsequent to December 31, 2024 through September 9, 2025, the date the financial statements were available to be issued, for potential recognition and disclosure in the financial statements. No events have occurred that would require adjustment to or disclosure in the financial statements.

6. Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions. Those estimates and assumptions affect the reported amount of assets and liabilities, the disclosures of contingent assets and liabilities, and the reported revenues and expenses. Actual results could vary from the estimates that were used.

NOTE C - CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank.

NOTE D - FAIR VALUES OF FINANCIAL INSTRUMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTE D - FAIR VALUES OF FINANCIAL INSTRUMENTS - Continued

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Investment Fund

The Plan invests in other collective investment funds (Funds). These Funds are managed portfolios valued at the daily closing price of the underlying investments weighted based on the target allocations. The mutual funds held in the Funds are open-end mutual funds that are registered with the SEC. These mutual funds are required to publish their daily net asset value and transact at that price. The mutual funds held by the Funds are deemed to be actively traded.

NOTE E - PARTY-IN-INTEREST AND RELATED-PARTY TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Charles Schwab Trust Bank. Charles Schwab Trust Bank is the Plan custodian. Additionally, the Hospital provides certain administrative services at no cost to the Plan. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA.

NOTE F - INCOME TAX STATUS

The Internal Revenue Service has determined and informed the Hospital, that the Plan and the related trusts are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the initial determination, the Plan's administration believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC.

The Plan follows accounting principles generally accepted in the United States of America related to the accounting for uncertainty in income taxes which sets a minimum threshold for financial statement recognition of the benefit of a tax position taken or expected to be taken in a tax return. Tax positions for the open tax years as of December 31, 2024, were reviewed, and it was determined that no provision or disclosure for uncertain tax positions is required. The Plan is subject to routine audits; however, there are currently no audits for any tax in progress.

NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment contracts. Investment contracts are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment contracts, it is at least reasonably possible that changes in the values of investment contracts will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
