1. Plan Description

General

RKS Associates 401(k) Plan (the "Plan") is administered by RKS Associates (the "Company" or "Sponsor"). The following brief description of the Plan provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

The Plan, which became effective on July 1, 1997, and was subsequently restated as of December 1, 2022, is a defined contribution plan covering eligible employees of Alpha School LLC, Gateway School LLC and Harbor School LLC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Eligibility

Employees of the Company can participate in the Plan once they are deemed eligible and have completed one year of service and attained twenty-one years of age, as defined in the plan document. Union employees, reclassified employees, leased employees, and non-resident alien employees are not eligible for plan participation. All employees, including part time and temporary, will not be eligible for employer contributions until they have completed 1,000 hours of service. Employees will be credited with a year of service at the end of the twelve-month period beginning with their date of hire if they have been credited with at least 1,000 hours of service during such period. If they have not been credited with 1,000 hours of service by the end of such period, they will have completed a year of service at the end of any following plan year during which they were credited with 1,000 hours of service.

Contributions

Each plan year, participants may elect to make voluntary contributions up to 100% of eligible compensation as defined in the plan document subject to certain IRS statutory limitations. Participants may elect to roll over contributions from another qualified plan. Participants 50 years of age or older may make an additional pre-tax catch-up contribution subject to IRS limitations. The Company makes matching contributions to the plan which equals 10% of deferrals that do not exceed 5% of pay, subject to certain IRS statutory limitations. The Company made matching contributions to the Plan totaling \$19,280 and \$16,717 for the years ended December 31, 2024 and 2023, respectively. The Company also made a discretionary profit-sharing contribution to all eligible participants totaling \$1,150,000 and \$1,300,000 for the years ended December 31, 2024 and 2023, respectively. The Plan applied \$98,106 in forfeitures to fund a portion of the 2024 profit sharing contribution.

Participant Accounts

Each participant's account is credited with the participant's contributions as well as allocations of the Company's discretionary profit-sharing contributions, matching contributions, and Plan earnings and losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan.

Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from a participant's vested account.

Vesting

A participant's vesting in the Company's discretionary profit sharing and matching contributions as well as earnings thereon is based on years of service. One year of service is equal to 1,000 hours of service. Except for those participants who automatically become fully vested due to death or disability, a participant becomes vested according to the following schedule indicating time of credited service:

Less than two years	0%
Two years but less than three	20%
Three years but less than four	40%
Four years but less than five	60%
Five years but less than six	80%
Six years	100%

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance reduced by the participant's highest outstanding loan balance during the prior twelve-month period. The maximum number of Plan loans that a participant may have outstanding at any one time is two. The loans are secured by the balance in the participant's account and bear interest at rates between 4.25% and 8.50% which are commensurate with the prevailing rates for similar loans as determined by the plan administrator.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant or his or her beneficiary may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump sum payment, installment payments, partial payments, or annuity contracts. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. An active participant may withdraw all or a portion of their vested account balance on January 1<sup>st</sup> of the calendar year in which they attain the age of 59 ½. The participant is also entitled to withdraw all or a portion of their rollover account balance, if any, at any time.

### Forfeitures

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$62,464 and \$98,106, respectively. These forfeitures are used to reduce future employer matching contributions or toward certain qualified plan expenses.

## 2. Summary of Significant Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, revenues and expenses and changes therein, and disclosure of contingent assets and contingent liabilities and accompanying notes. Actual results may differ from those estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustee determines the Plan's valuation policies utilizing information provided by investment advisors and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent Events

Plan management has reviewed subsequent events and transactions that occurred after December 31, 2024 through the date of the independent auditors' report and the date the financial statements were available to be issued, July 21, 2025. The financial statements include all events or transactions, including estimates, required to be recognized in accordance with generally accepted accounting principles.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common/Collective Trust funds:* Valued at the NAV of units of a bank or insurance company collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be profitable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

5. Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. Whole or partial termination of the Plan shall result in the full and immediate vesting of employer profit sharing contributions and earnings thereon. 6. Tax Status

The Internal Revenue Service has determined and informed the Company by letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirement of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Party in Interest Transactions

Certain Plan investments are managed by John Hancock Life Insurance Company (U.S.A.) who is the custodian for the Plan and therefore, these transactions qualify as exempt party-in-interest transactions.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities in general are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants account balances and the amounts reported in the statement of net assets available for benefits.
