### Note 1: Description of Plan

The following description of the Central Processing Corp. Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan established by Central Processing Corporation (the "Company"). An employee becomes eligible to participate in the Plan on the first day of the month following 3 months of service and attainment of age 19. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### The SECURE 2.0 Act of 2022

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

#### Contributions

Participants are allowed to contribute pretax annual compensation, as defined by the Plan, and Roth contributions up to the annual maximum allowed by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible pretax compensation and their contributions invested in a designated fund until changed by the participant.

The Company may make a discretionary matching contribution. The Company matches an amount equal to 25% of the first 5% of a participant's eligible compensation. For employees with at least four years of service, the Company match is 100% of the first 5% of a participant's eligible compensation. Rollovers are not matched. The Company made discretionary matching contributions of \$2,725,083 for the year ended December 31, 2024 (net of forfeitures used to reduce the discretionary matching contribution in the amount of \$73,341).

The Company may also make a discretionary nonelective contribution as determined by the Company's Board of Directors each year. There were no discretionary nonelective contributions made for the year ended December 31, 2024.

### **Note 1: Description of Plan** (Continued)

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution and rollover contributions, and Company discretionary matching contributions, and allocations of (a) the Company's discretionary nonelective contribution and (b) plan earnings (losses), and charged with an allocation of administrative expenses paid by the Plan. Allocations are based on the participant's eligible compensation, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are vested immediately in their voluntary contributions plus actual earnings (losses) thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings (losses) thereon is based on years of continuous service. Participants vest at a rate of 20% per year beginning with the first year of service. Participants become fully vested after five years of service.

#### **Notes Receivable From Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. The loans are secured by the balance in the participant's account and bear interest at the prime interest rate plus 1.00%. The interest rates on existing loans range from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

#### **Payment of Benefits**

Benefits may be paid to a participant or beneficiary upon death, disability, retirement, or termination of employment, as defined in the plan document. The Plan provides for normal retirement at age 65. The total vested portion of a participant's account balance may be distributed in the form of a lump-sum payment if the participant's vested balance is greater than \$7,000. If the vested balance is less than \$7,000, a mandatory automatic rollover distribution will be made. In addition, hardship distributions out of all contribution accounts are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59½.

#### **Forfeitures**

Plan forfeitures arise as a result of participants who terminate service with the Company before becoming 100% vested in the Company's contributions. These forfeitures shall be used for restoration of forfeitures to participant accounts, to pay administrative expenses of the Plan, or to reduce Company contributions. At December 31, 2024 and 2023, unused forfeitures from nonvested accounts were \$2,772 and \$1,132, respectively. During the year ended December 31, 2024, Company discretionary matching contributions were reduced by \$73,341 from forfeited nonvested accounts.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### **Use of Estimates**

The preparation of the accompanying financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are reclassified as distributions on the basis of the terms of the plan document.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of the Plan are included in administrative expenses and allocated proportionately to participants. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to plan participants based on their respective account balances and are offset against net investment income.

#### Subsequent Events

The Plan has evaluated subsequent events through September 26, 2025, which is the date the financial statements were available to be issued.

### Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would be used only if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual funds held in Pooled Separate Accounts:* Fair value of mutual funds held in pooled separate accounts is based on quoted net asset values of underlying investments held by the pooled separate accounts adjusted by an asset charge. The underlying mutual funds held in the pooled separate accounts are open-ended mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price.

*Guaranteed Interest Accounts:* Valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

### Note 4: Information Prepared and Certified by the Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments, notes receivable from participants, and non-interest-bearing cash held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by John Hancock Life Insurance Company ("John Hancock"), the Custodian of the Plan.

### Note 5: Related-Party Transactions and Party-in-Interest Transactions

Certain plan investments are managed by John Hancock, the Custodian as defined by the Plan; and therefore, these transactions qualify as party-in-interest transactions. The Custodian also provided third-party administrative services to the Plan.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

### Note 6: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate or partially terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contributions.

### Note 7: Tax Status

The Company adopted a nonstandard pre-approved document with an IRS notification letter which states the pre-approved plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
