Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Minnesota Twins Profit Sharing/401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Minnesota Twins Profit Sharing/401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). NOTE 1 DESCRIPTION OF THE PLAN

The following is not a comprehensive description of Minnesota Twins Profit Sharing/401(k) Plan (the Plan) and, therefore, does not include all situations and limitations covered by the Plan. Participants should refer to the Plan document for more complete information.

General

The Minnesota Twins (the Club) established the Plan to enable its employees to add to their retirement financial security. The Plan is a defined contribution plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Plan Operations

The Club is the Plan Sponsor. The trustee and custodian are responsible for the holding of the assets of the Plan, executing asset transactions, making disbursements to participants, and providing the Plan Sponsor with a list of the Plan's assets and changes in asset at the end of each year.

Eligibility

Substantially all employees who have attained age 21 and completed three months of service are eligible to participate in the Plan. Employees are eligible to participate in the Plan on the first day of the payroll period after meeting the requirements.

Effective January 1, 2024, the Plan excluded Union employees.

Contributions

The Plan allows eligible participants to make pretax and Roth contributions to the Plan for their own benefit. Pretax contributions are limited to 75% of the participant's compensation, as defined, up to the maximum permitted by law. The Club may make discretionary matching contributions. Discretionary matching contributions are equal to 100% of elective deferrals up to 3% of eligible compensation plus 50% of elective deferrals between 3% and 5% of eligible compensation. The Club made discretionary matching contributions of \$1,596,241 for the year ended December 31, 2024. The Club may also make discretionary profit-sharing contributions. The Club made discretionary profit-sharing contributions of \$2,231,338 for the year ended December 31, 2024.

Effective January 1, 2024, the Plan removed the deferral percentage restriction for highly compensated employees and modified the definition of eligible compensation.

Participant Accounts

Each participant's account is credited with the participant's contributions and Club discretionary matching contributions, if any, as well as allocations of the Club's discretionary profit-sharing contributions, if any, and investment results. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1 DESCRIPTION OF THE PLAN (CONTINUED)

Investment Options

Participants may allocate their contributions in a variety of investment choices, as more fully described in the Plan's literature. All choices vary in types of investments, rates of return and investment risk. Participants may elect at any time to have all, or part of their account balances transferred from one investment choice to another or in any combination.

Vesting

Participants are immediately vested in their contributions and Club discretionary matching contributions, plus actual earnings thereon. Vesting in the Club discretionary profit-sharing contributions is based on years of credited service. Participants vest gradually and are 100% vested after six years of credited service.

Effective January 1, 2024, the Plan excluded any vesting credit for the age of 18.

Forfeited Accounts

Forfeited nonvested accounts are used to reduce administrative expenses, restore participant accounts, or fund future Club contributions. The Plan utilized forfeitures of \$53,178 to pay administrative expenses for the year ended December 31, 2024. Forfeited nonvested accounts as of December 31, 2024 and 2023, totaled \$76,919 and \$134,303 respectively.

Notes Receivable from Participants

Participants may borrow from their Plan account a minimum of \$1,000 up to a maximum of 50% of their account balance, not to exceed \$50,000. A participant note repayment term cannot exceed five years, other than a home purchase note, which cannot exceed 15 years. Interest on such notes is fixed at the prime rate plus 1% at the time of note origination. At December 31, 2024, note maturities were through November 2029. Principal and interest are paid ratably through monthly payroll deductions.

Benefit Payments

Plan participants are entitled to receive distributions from their accounts if they retire at or after reaching age 59 ½. Upon termination of employment, including permanent disability or death, participants or their beneficiaries are entitled to receive their vested account balance determined at the most recent valuation date. Plan participants may also be entitled to receive the full amount of their pretax 401(k) or Roth 401(k) accounts if the participant can demonstrate hardship, as defined in the Plan.

Effective January 1, 2024, the Plan allowed disability withdrawals from pre-tax, Roth, and Employer contributions sources.

Plan Termination

Although it has not expressed any intention to do so, the Club reserves the right to amend or terminate the Plan at any time, subject to the provisions of ERISA. Termination shall become effective upon receipt by the trustee and custodian of a written instrument of termination signed by the Club or a duly authorized representative thereof. At that time, participants would become 100% vested in the Club discretionary profit-sharing contribution portion of the accounts and the assets of the Plan will be distributed in accordance with Plan provisions.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined- contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisors, trustee, and insurance company. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Benefit Payments

Benefit payments are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make note repayments and the Plan Administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded.

Notes receivable from participants have been classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental schedule, Schedule H, line 4i—schedule of assets (held at end of year).

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Club and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

Effective January 1, 2025, the Plan amended the definition of compensation for all contributions to exclude signing bonuses, pension bonuses, and post-season players share compensation.

The Plan has evaluated subsequent events through September 5, 2025, the date the financial statements were available to be issued.

NOTE 3 INFORMATION CERTIFIED

The Plan Administrator has obtained certifications from the qualified institutions that the information provided to the Plan Administrator by the qualified institutions relating to the following assets is complete and accurate.

Accordingly, as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information that appears throughout the financial statements and ERISA-required supplemental schedule relating to the following assets:

NOTE 4 FAIR VALUE MEASUREMENTS

Accounting standards established the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies

Registered investment companies are valued at the quoted market price of shares held by the Plan at year-end in the active market on which the individual securities are traded.

Collective Trust Funds

The collective trust funds are valued at the net asset value (NAV) as reported by the investment manager at year-end. The fund's underlying assets consist of investment contracts and security-backed contracts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

Pooled Separate Accounts

The pooled separate accounts are valued at the NAV of units as determined by the insurance company. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

The methods described above may produce fair values that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan has invested in a Prudential Guaranteed Investment Contract. The fund is credited with interest using a single portfolio rate approach. Withdrawals can be made at contract value at any time for the purpose of participant withdrawals or benefit payments. Prudential is contractually obligated to repay the principal and a specified interest rate that is guaranteed by the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.50%. The crediting rate is reviewed on a semiannual basis for resetting. The contract does not have a stated maturity date. The fund is included in the financial statement at contract value, as it is fully benefit-responsive, as reported to the Plan by Prudential.

Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals, and fees. The Plan held \$1,709,619 and \$2,967,044 of traditional contracts at contract value at December 31, 2024 and 2023, respectively.

NOTE 6 INCOME TAX STATUS

The Plan adopted a non-standardized pre-approved plan sponsored by Empower Retirement LLC. Empower Retirement LLC has received an opinion letter, dated November 14, 2022, from the Internal Revenue Service (IRS), as to the pre-approved plan's qualified status.

The pre-approved plan opinion letter has been relied upon by this Plan. The Plan has been amended since the date of this letter. However, the Club and Plan Administrator believes the Plan is designed and being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of registered investment companies managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC the custodian and trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included as an offset to net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Club pays directly any other fees related to the Plan's operations.
